## **DENMARK**

Comments from the Danish delegation to consolidated version 14985/21 + ADD 1 and 2 concerning the TAC-Regulation for 2022

## <u>14985/21 + add 1 and 2 - Consolidated text 20 December 2021</u>

### Add 1:

<u>Tusk in United Kingdom and Union waters of 4 (USK/04-C)</u>: Foodnote (1) shall also be attached to the Danish Quota (so that we have the same area-flexibility as other MS).

Herring 3a (HER/03A.): Footnote (3) in this version the last sentence of the footnote only refers to area 4b. Is this an error to be corrected or an adaptation due to the fact that area 4a does no longer cover Union waters? Previous version in doc 14892/21 rev 2 reads: "Special condition: up to 50% of this amount may be fished in United Kingdom waters of 4 (HER/\*04-UK), and up to the following amounts may be fished in Union waters of 4a and 4b (HER/\*4AB-EU)."

Northern prawn 3a, (PRA/03A.): Please double check that articles 3 and 4 of 847/96 is correctly stated. It currently says that "Article 3 of Regulation (EC) No 847/96 shall not apply / Article 4 of Regulation (EC) No 847/96 shall not apply". While according to the Agreed Record EU-Norway Skagerrak for 2022, paragraph 9.1, the system inter-annual quota flexibility should cover Pandalus for 2022.

Northern prawn in United Kingdom and Union waters of 4 (PRA/2AC4-C): According to Written Record between EU and UK this quota is only for bycatches in 2022.

## Mackerel North Sea (MAC/2A34):

Why is there no reference to both United Kingdom and Union waters in the headline as follows: "3a and 4; United Kingdom waters of 2a; Union waters of 3b, 3c and Subdivisions 22-32 (MAC/2A34.)"?

The following footnote should also apply to Union waters as before Brexit. Please compare with earlier Regulations, for instance with TAC-Reg 2018/120:

(1) Special condition: up to 60 % may be fished in <u>Union</u>, United Kingdom and international waters of 2a, 5b, 6, 7, 8d, 8e, 12 and 14 (MAC/\*2AX14).

<u>Sprat and associated by-catches in 3a (SPR/03A.):</u> Text and figures in table are wrong. There is already EU-legislation in place for this stock covering the period from 1 July 2021 to 30 June 2022. (Council Regulation (EU) 2021/1069 page 7). Must be replaced by this, if need to repeat.

Sprat and associated by-catches in United Kingdom and Union waters of 4; United Kingdom waters of 2a (SPR/2AC4-C): Text and figures in table are wrong. There is already EU-legislation in place for this stock covering the period from 1 July 2021 to 30 June 2022. (Council Regulation (EU) 2021/1069 page 7 and 8). Must be replaced by this, if need to repeat.

### Annex V:

Part B, p. 24, there is the following line:

Norway Herring, north of 62° 00' N To be establ. To be establ.

Since there is no Union waters north of 62° 00' N anymore, there cannot be licences to be establised. Therefore, this line should be deleted.

# FIXING FOR 2022 THE FISHING OPPORTUNITIES FOR CERTAIN FISH STOCKS AND GROUPS OF FISH STOCKS APPLICABLE IN UNION WATERS AND FOR UNION FISHING VESSELS IN CERTAIN NON-UNION WATERS (Document 14985/21)

Spain has a comment in relation with the TAC and quotas for Southern hake (HKE/83411). We have observed a different criteria applied in relation with regulation UE 2021/92, of 28 of January.

In that regulation (UE) 2021/92, the table of quotas for this stock was:

So, as an exercise of coherency to the previous year, Spain considers that Union TAC for hake (HKE/8C3411) for the year 2022 should be 7.836 tonnes according to the compromise of Presidency. And as a consequence quotas of MMSS should be amended consequently.

## <u>14985/21 – Consolidated text 20 December 2021</u>

## ADD 1:

Herring 3a (HER/03A.): Footnote (3) in this version the last sentence of the footnote only refers to area 4b. Is this an error to be corrected or an adaptation due to the fact that area 4a does no longer cover Union waters? Previous version in doc 14892/21 rev 2 reads: "Special condition: up to 50% of this amount may be fished in United Kingdom waters of 4 (HER/\*04-UK), and up to the following amounts may be fished in Union waters of 4a and 4b (HER/\*4AB-EU)."

Herring 4 (HER/4AB.): Swedish quota should be 4093 t.

Norway lobster 3a, (NEP/3A.): Table missing from 14985/21 ADD1.

Northern prawn 3a, (PRA/03A.): Please double check that articles 3 and 4 of 847/96 is correctly stated. It currently says that "Article 3 of Regulation (EC) No 847/96 shall not apply / Article 4 of Regulation (EC) No 847/96 shall not apply". While according to the Agreed Record EU-Norway Skagerrak for 2022, paragraph 9.1, the system inter-annual quota flexibility should cover Pandalus for 2022.

Plaice in the Kattegat (PLE/03AS.): Table missing from 14985/21 ADD1.
