

Context

- Increase in politically estranged situations:
 - ► Unconstitutional regimes (e.g. Afghanistan, Mali, Myanmar).
 - Transitional situations & authorities (e.g. Haiti, Sudan)
 - Contested electoral situations where donors don't recognize party claiming victory or prohibit engagement (e.g. Venezuela, Gaza)
 - States under comprehensive international sanctions with UN investigations underway (e.g. Syria, Eritrea)
- 'Standard' development approaches and instruments difficult to apply & in some cases prohibited.



- Avoid legitimizing unlawful regimes or fuelling further conflict, human rights abuses or large-scale corruption.

Build domestic support

Targeted outreach:

- Parliamentary bodies/committees expert briefings, including from UN & in-country officials
- Diaspora groups regular dialogue
- Mainstream & social media sustained coverage.

Understand & respond to key concerns:

- Scale of need, spillover risks, geopolitical competition, value for money
- Demonstrate risks of legitimizing abusive regimes & corruption can be addressed through effective aid modalities
