## THE POLITICAL AND SECURITY COMMITTEE,

Having regard to the Treaty on European Union, and in particular the third paragraph of Article 38 thereof,

Having regard to Council Decision 2010/452/CFSP of 12 August 2010 on the European Union Monitoring Mission in Georgia, EUMM Georgia<sup>1</sup>, and in particular Article 10(1) thereof,

### Whereas:

- **(1)** Pursuant to Article 10(1) of Decision 2010/452/CFSP, the Political and Security Committee (PSC) is authorised, in accordance with the third paragraph of Article 38 of the Treaty, to take relevant decisions for the purpose of exercising the political control and strategic direction of the European Union Monitoring Mission in Georgia (EUMM Georgia), including the decision to appoint a Head of Mission.
- On 11 February 2020, the PSC adopted Decision (CFSP) 2020/200<sup>1</sup> appointing (2) Mr Marek SZCZYGIEŁ as Head of Mission of EUMM Georgia from 15 March 2020 to 14 December 2020.
- On 25 November 2021, the PSC adopted Decision (CFSP) 2021/2163<sup>2</sup>, extending the (3) mandate of Mr Marek SZCZYGIEŁ as Head of Mission of EUMM Georgia from 15 December 2021 to 14 December 2022.

- (5) On 25 January 2023, the High Representative of the Union for Foreign Affairs and Security Policy proposed the appointment of Mr Dimitrios KARABALIS as Head of Mission of EUMM Georgia until 14 December 2023.
- (6) A decision on the appointment of Mr Dimitrios KARABALIS as Head of Mission of EUMM Georgia from 1 February 2023 to 14 December 2023 should therefore be taken,
