<u>The Committee</u> examined a Presidency compromise text and gave a mandate to the Presidency to explore the possibilities of a first reading agreement with the European Parliament at the next informal trialogue meeting.

- Ukraine Russia dispute over gas
  - Follow-up to the extraordinary meeting of the Council of 12 January 2009

The Chairperson debriefed <u>the Committee</u> on recent developments as well as on the summit convened in Moscow on 17 January, and recalled the line agreed at <u>the Committee</u> on 15 January. The Commission provided additional information on the summit, reconfirmed the line agreed at <u>the Committee</u> and stress the need to intensify efforts on internal aspects of the crisis; in this respect the Gas Coordination Group will meet on 19 January and Director-Generals for Energy on 21 January. A few delegations updated <u>the Committee</u> on their internal situation as well as on bilateral contacts with the Russian side.

The Chairperson concluded by stressing the need to have comprehensive exchange of information on all contacts taken at high level and noting that the impact of the dispute is no longer limited to a few "most affected" countries.
