The General Secretariat of the Council informed the SCA about the way AOB items would be reflected on Council agendas in the future.

The Presidency informed the SCA about the next SCA meeting on 9 February 2026 and the "Agriculture and Fisheries" Council meeting on 26 January 2026.

Regarding that Council meeting:

- Poland requested a public item under “any other business”, on the “Actions necessary for protection of sensitive agricultural sectors in the context of trade agreements with third countries”;
- Austria requested a public item under “any other business”, on “Arable Farmers under pressure: Urgent action to protect EU agriculture”;
- Italy requested a public item under “any other business”, on an “Extraordinary EU Plan for the Crisis in the European Dairy Sector”;
- Germany confirmed its request for a public item under “any other business”, on “Marketing Standards for poultry meat”;
- France informed the SCA that it would request, at Coreper, a public item under “any other business”, on “Origin labelling for agricultural and food products”; and
- The SCA agreed that the items requested by Poland, Austria, Italy and Germany would be taken in public session in accordance with Article 8(2) of the rules of procedure of the Council.
