#### A. INTRODUCTION AND AIM

- On 31 March 2020, the Council adopted the decision to launch EUNAVFOR MED Operation IRINI. The current mandate expires on 31 Mar 2023 (Ref. A).
- 2. Since the latest Strategic Review (Ref. B), the political and security situation in Libya has continued deteriorating. More than a year after the postponement of the presidential and parliamentary elections scheduled to take place on 24 December 2021, Libya continues to be paralysed by a deeply entrenched institutional crisis, with two competing governments. The political landscape in Libya keeps on being dominated by backchannel negotiations and attempts to carve a new political roadmap amid competing interests between the Interim Government of National Unity (IGNU) established in Tripoli and the Government of National Stability (GNS) based in Sirte. The increased political uncertainty resulting from the parallel governments has led to further instability, notably in the Tripoli area where armed

clashes between the warring factions have occurred. The overall arms embargo continues to be violated, while the potential for oil smuggling remains a profitable option. The situation for migrants and refugees departing from Libya remains a concern.

- 3. On 06 Dec 2022, the European External Action Service (EEAS) issued a Strategic Review of Operation EUNAVFOR MED IRINI (Ref. C).
- 4. On 13 Dec 2022, the Political and Security Committee (PSC) invited the EU Military Committee (EUMC) to provide its Military Advice on the Strategic Review (Ref. D).
- 5. The aim of this paper is to provide Military Advice and to submit recommendations to the PSC.

#### **B. CONSIDERATIONS**

- 6. The EUMC acknowledges the ongoing prominent role of the EU in supporting the Berlin Process and the UN-led mediation efforts and the 13 October 2022 European Parliament Foreign Affairs Committee's approval of a series of recommendations on Libya<sup>1</sup>.
- 7. The EUMC acknowledges the long-awaited appointment of a new Special Representative of the UN Secretary General, which could help the United Nations reinvigorate its central role in supporting a Libyan-led and Libyan-owned process.
