In view of the Land Transport working party on 30 January 2024 delegations will find in the annex a revised four-column document.

The  $4^{th}$  column with the draft agreement is compared to the text of the general approach.

Compared to ST 5532/24, the Presidency and the EP found an provisional agreement on lines 111a, 112, 149, 150, 205, 213o-s, 234, 238-244, 246, 247 and 255aa. These have been indicated in green.

Delegation are invited to have a closer look at the following lines.

Regarding <u>deadlines</u> the Presidency would like to finalise a compromise that you can find in lines 22, 30, 100, 122r, 132, 135-137, 146, 171, 184, 191 and 192, marked in red.

Regarding the <u>follow-up documents</u>, the Parliament agreed with the concept in the general approach, but asked for clarifications. Delegations can find the Presidency compromise in lines 2130 and 213s, marked in yellow.

Regarding the <u>debt collectors</u>, the Presidency would like to offer a compromise to the Parliament but *the final text will be issued later*. This is marked in red, because the Parliament is still considering this after what was discussed in the last technical meeting. Line 34 will need to be redrafted to align it with the final outcome on this issue.

Regarding the issues of <u>earmarking</u> (lines 42a, 255b-e) and <u>3<sup>rd</sup> countries</u> (lines 35a-c, 255f-h), the Presidency has explained the Council position to the Parliament and is waiting for the Parliament's response.

The Presidency has also proposed to include an additional Article 8c regarding <u>bilateral and multilateral agreements between Member States</u> (lines 255ag-ah).

The annex still needs more work.
