30. Fisheries Partnership Agreement between the European Community and the Islamic Republic of Mauritania

- Information from the Commission

The Commission representative informs the Committee that during the visit of the Commission services to Mauritania that same week satisfactory progress had been made on a Memorandum of Understanding on the review of the protocol to the agreement, and that, on 29 January 2008, the Mauritanian Minister responsible for fisheries will be in Brussels for a meeting with Commissioner Borg in order to discuss further the guiding principles for the envisaged review of the protocol to the fisheries agreement. The Commission representative expresses guarded optimism that the Memorandum of Understanding will be signed during that meeting.

He recalls that the principal reason for the review is the need to reduce the fishing opportunities to the levels actually utilised and that such reductions will be combined with the introduction of a flexibility clause allowing for more fishing opportunities should the need arise. The financial contribution will also be gradually, but significantly, reduced. This reduction will be offset to some extent by more support for development of the Mauritanian fisheries sector from the EDF. In order to obtain more stability, a 4 year protocol is also envisaged. The Commission wishes to complete the review process by the end of February, but underlines the complexity of this dossier. The preparations of the review will take place in the Working Party and, if necessary, the Commission will organise technical meetings. The Presidency confirms that preparations will begin shortly in the Working Party.
