Statement by Germany, Finland, Austria, Slovenia and the Netherlands

"Germany, Finland, Austria, Slovenia and the Netherlands consider the Commission's proposal amending Regulation (EU) No 260/2012 regarding the migration to Union-wide credit transfers and direct debits as unnecessary in relation to the SEPA migration process. Recent findings in 2013 and even in January 2014 have indicated that, with some efforts, these Member States would have completed SEPA migration in due time.

With a view to possible migration problems in some Member States and in order to avoid further legal uncertainty for payment service providers or payment service users, Germany, Finland, Austria, Slovenia and the Netherlands will accept the Commission's proposal without any further changes.

The Commission's proposal and the reasoning mentioned in the corresponding Commission press release only three weeks ahead of the long-standing envisaged end-date have hampered the latest migration efforts in Member States and in the EU and have led to legal confusion among payment service users and payment service providers.

However, Germany, Finland, Austria, Slovenia and the Netherlands are deeply concerned by the Commission's approach in this respect. In such an urgent matter, Member States should have been informed ahead of the proposal's publication, especially given the fact that the proposal has a significant impact on numerous payment service users and payment service providers. The proposal also interferes with the migration efforts undertaken by governments, central banks and stakeholders so far. Cooperation in the spirit of mutual trust and based on partnership is essential for the acceptance of European legislation by the general public in the EU and Member States. For possible similar cases in the future, we insist on earlier consultations and proposals, in order to ensure the real benefits of such amendments."

Statement by United Kingdom and Czech Republic

"While the UK and Czech Republic have no policy objection to the proposed Regulation, the UK and Czech Republic are concerned by the approach taken to this urgent quick fix legislative proposal. Member States should have been informed of the Commission's intention to postpone the implementation date ahead of its publication. National parliaments should be given appropriate time to scrutinize EU legislative proposals. The timetabling that has been pursued on this proposal has not allowed this and the UK and Czech Republic therefore reserve their position."

Statement by Italy

"Italy reaffirms that the end-date set for 1 February 2014 to complete the SEPA migration is fully confirmed and that all efforts have been and will be made to fulfill it according to the plans already approved. Italy takes note of the European Commission's proposal to modify EU Regulation No 260/2102 related to the Single Euro Payments Area (SEPA), introducing an additional transition period of six months for credit transfers and direct debits different from a SEPA format which could continue to be accepted until 1 August 2014."

The Presidency informed the Committee that, at an informal meeting between the negotiating teams of the three institutions the previous day, it had been decided to resume negotiations on 28 January 2014 considering the urgency to reach an agreement as soon as possible.

During the informal meeting the Commission had recalled that it could not accept the cut of some EUR 300 mio from direct management, but would be willing to accept that 2/3 of these funds be transferred to shared management. The European Parliament had indicated that it would be willing to give up around 50 mio of its requested increase for controls and data collection and would expect Council to come up with the other 50 mio. The Presidency had reserved its position on this matter.

The Presidency asked the delegations for guidance on whether or not the Council could accept to come up with the said 50 mio, and if so, how. To guide discussion the Presidency submitted a table to the Committee (doc. 5651/14). The Presidency stressed it would seek to negotiate the remaining outstanding issues as a package.

The Commission representative confirmed its offer regarding a transfer of funds from direct to shared management. It recognised the concerns regarding the possibility to absorb the large amounts of money allocated to controls and data collection and suggested that increasing the co-financing rates to 80 and 90% respectively should overcome many of these concerns.

Delegations taking the floor all accepted some budgetary flexibility and supported the "package approach" and to seek to spread out the reduction over several budget lines. Several delegations underlined the need of some flexibility to transfer funds between budget lines.

The Italian and Romanian delegations highlighted their concerns in relation to the consumption criterion in Article 17. The Latvian delegation recalled its problem in relation to the definition of SMEs. The Polish delegation underlined that it would not want to see any cut in the allocation for sustainable fisheries and aquaculture.

The Presidency thanked the Committee for its willingness to grant the Presidency a margin of flexibility on its mandate.

Presidency presented the agenda of the February General Affairs Council which will include the presentation of the Presidency programme and the Annotated draft agenda of the March European Council. The FR delegation (supported by DK, HU, BG, LU, SI and HR) asked for an additional B point on GMO maize.

The Committee discussed the preparations for the seventh summit with Brazil, on the basis of an orientation note (doc. 5041/14) and a presentation by the EEAS.

Delegations gave their support to the orientation note and offered comments on particular issues, and the Committee felt, more in general, that there was a need for more focused debates on Strategic Partners; the Committee could task other bodies to prepare these debates.

After an exchange of views, the Committee reached a unanimous agreement on the Presidency's proposals for the three legislative texts set out in 5466/14, 5467/14 and 5468/14, subject to legal-linguistic revision.

The Committee agreed to provide the European Parliament with the texts set out in 5466/14 and 5468/14, and to invite the European Parliament to take the revised texts into consideration when drawing up its opinions.

The Committee made the following statement to be included in its minutes :

"The Committee unanimously agrees that the Commission working document on the calculation of the United Kingdom correction, which is to be unanimously endorsed by the Council at the time of the formal adoption of this legislative package, needs to be reviewed when the text of the inter-governmental agreement on the single resolution mechanism is finalised to ensure that the United Kingdom is not overcompensated once it has been reimbursed in this context."

The Belgian, French, Hungarian, Italian, Luxembourg, Polish, Portuguese and Spanish delegations made the following unilateral statement to be entered into the Committee' minutes and the Council minutes when adopting the Own Resources Decision:

"The Member States, underwriters of this statement, underline that the preamble of the Decision on the system of own resources of the European Union does not entirely reflect the conclusions of the European Council of 7 and 8 February 2013.

These Member States consider that these conclusions are an important move forward in the negotiations of the own resources legislative package. According to these conclusions, which reflect the common general position of the Member States, no reference to the conclusions of the European Council in Fontainebleau of 1984 was to be made, nor any assessment on the appropriateness of corrections benefitting specific Member States.

Therefore, taking into account the profound change of the EU and its budget since 1984, the text of recital 3 of the Decision, which was introduced in the current own resources decision on the basis of the December 2005 European Council conclusions, does not prejudice the forthcoming discussions about the review of the own resources system."

The Swedish and United Kingdom delegations made the following unilateral statement:

"In lifting their reservation on the Own Resources legislative package, which was connected to the possible budgetary implications of the Single Resolution Mechanism for non-participating Member States, Sweden and the United Kingdom underline the importance of the commitment set out in paragraph 21 of the Terms of Reference concerning the intergovernmental agreement on the Single Resolution Fund adopted at the ECOFIN Council on 18 December 2013 and endorsed by the European Council.

Sweden and the United Kingdom wish to emphasize the importance of agreeing an effective and efficient reimbursement mechanism that fully implements the commitment to protect non-participating Member States from the possible effects on the EU budget of non-contractual liabilities and costs related thereto in connection to the SRM, including clarification of the Commission's coordinating role and ensuring effective implementation of the principles and commitments in the on-going negotiations of the Inter-Governmental Agreement in line with the Terms of Reference."

58. High Level Group on Own Resources (restricted session)

The Committee met in a restricted session to discuss the state of play and next steps in the process of setting up the High-level Group on Own Resources.
