Subject:	Proposal for a Regulation of the European Parliament and of the Council on the protection of individuals with regard to the processing of personal data and on the free movement of such data (General Data Protection Regulation)
	- The one-stop-shop mechanism

Background

1. Following the discussions at DAPIX on 26-27 January 2014 on the one-stop-shop mechanism, the Presidency has revised the text of Chapters VI and VII. To that end it has based itself on the text of the Regulation as it stood at the end of the Italian Presidency. It has inserted therein the text proposals made by Germany and France, to the extent that they were supported by a majority of Member States at the previous DAPIX meetings. The Presidency has also made additional changes in order to account of the remarks and suggestions made by other delegations and with a view to further streamlining the text of these two Chapters.

2. The latest changes introduced in the previous and current Presidency that have not yet been discussed in the Working Party are marked in **bold underlining**.

3. The text of Article 76b is part and parcel of the discussions on the one-stop-shop mechanism, but the Presidency does not intend to discuss this at the next DAPIX meeting, at which the Presidency would in particular like to discuss the following issues:

Inclusion of processors in the one-stop shop mechanism

4. The Commission proposal provided that this mechanism would cover both controllers and processors. The German-French note proposes to limit the mechanism to controllers. Some delegations have opposed this, referring to the considerable power of some processors, in particular in the so-called cloud environment. Processors have some 'autonomous' obligations under Article 26 and regarding security measures, the non-respect of which may give rise to sanctions against processors. Others have pointed out that the data subject can exercise his rights under Chapter III only against controllers.

5. Therefore the Presidency invites delegations to indicate which alternative they prefer:a) Full exclusion of processors from the one-stop shop mechanism;

- b) Exclusion of processors from the one-stop shop mechanism, combined with a possibility to extend the mechanism to them in some cases: (procedurally, by allowing the controller to invoke the fault of the processor or, materially, by considering a processor which has acted in violation of the controller's instructions as controllers); or
- c) Full inclusion of processors into the one-stop shop mechanism

Definition of concerned supervisory authorities

6. So far these authorities have been defined in a very broad manner as covering all Member States on whose territory the controller is established or whose data subjects are substantially affected or likely to be so. This definition allows for maximum proximity, especially regarding any kind of processing related to the offering of goods and services over the internet where there may potentially be affected data subjects in all Member States. Some delegations have, however, pointed to the heavy burdens this imposes on the lead authority. With a view to making the co-operation mechanism lighter and reducing the number of possible cases going into the consistency mechanism (and possible actions before the ECJ), the Presidency has suggested to narrow somewhat the definition of concerned authorities in Article 4(19a).

7. Delegations are invited to indicate whether they can support such narrower definition of concerned supervisory authorities.

Need for a separate category of 'grey zone' cases between local and transnational cases

8. Both the text of the Regulation as it stood at the end of the Italian Presidency and the German-French note provide for a category of "grey zone" cases, which, notwithstanding the fact that they have some transnational element to them, can be dealt with locally by the territorially competent supervisory authority. Many delegations have pleaded in favour of simplifying the procedure in this regard and the Presidency has accordingly deleted Article 54b. It has moved this category of cases from Article 5 (2a) to Article 5 (1a). The question is whether a right for the concerned supervisory authority to object to the lead supervisory authority dealing with such a case should be maintained. One may wonder whether there is a need for such separate right to object and whether such objections could not be subsumed under the general right of concerned supervisory authorities to have the EDBB rule on which authority is competed (Article 57 (2a)(c). A lead supervisory authority which is of the opinion that it should deal with a case may always investigate this in accordance with the procedure set out in Article 54a (paras. 2 and 2b). 9. Delegations are invited to indicate whether they can see a need for maintaining a separate right to object against a lead supervisory authority which is supposedly acting in a case that should be dealt by the local supervisory authority or whether this can be dealt with under the general right of local supervisory authorities to object against a draft decision of the lead supervisory authority.

Definition of serious and reasoned objection and quantitative threshold

10. Further to suggestions made, the Presidency has inserted a definition of a 'serious and reasoned objection' in Article 4(19b) which restricts the subject-matter of the objection. The Presidency also suggests inserting a low quantitative threshold of 1/3 of the concerned supervisory authorities, as soon as there is more than one concerned supervisory authority other than the lead authority. The fact that, in a situation where there are several concerned authorities and the supervisory authority that has expressed an objection does not manage to convince another concerned supervisory authority, may be an indication of the low weight that its arguments carry. (In cases where there would only be one concerned supervisory authority, a single objection should be sufficient).

11. Delegations are invited to indicate whether they can support this definition and the proposal for a quantitative threshold.

Scope of EDPB revision

12. Regarding the scope of the revision by the EDPB, the Presidency suggests that the Board should be entitled to verify whether an infringement of the Regulation took place and to verify whether the corrective measure the lead supervisory authority intends to impose is in conformity with the Regulation. This excludes that the supervisory authority substitutes itself for the lead supervisory authority in determining the corrective measure, but it does empower the Board to take decisions in this regard when the proposed measure is in violation of the Regulation, including the proportionality requirement for fines (Article 79(2)).

- Delegations are also invited to express themselves whether they see a need for having legally binding EDPB decisions in the cases referred to in points d) and e) of Article 57(2a).

- Functioning of EDPB

14. The latest draft of Chapter VII provides that the EDPB should adopt its legally binding decisions by a 2/3 majority, whereas other decisions and opinions are adopted by a simple majority. The German-French note has maintained this approach. The concern to have the EDPB overrule the lead supervisory authority only in cases when a robust majority of members of the Board agree that there are grounds to do so, is understandable; however this proposed majority requirement risks to slow down and even block the functioning of the Board. In order to avoid stalemate situations, at least a fall-back position will have to be provided, for example by indicating that after one month the required majority will be simple (with a possibility to have a split vote decided by the vote of the EDPB Chair). Should delegations agree to introduce such fall-back simple majority, the question arises whether there is a need for a specific procedure/majority for decisions on the nature of the objection.

Delegations are invited to express themselves regarding the majority requirements for the EDPB.

- 92) The establishment of supervisory authorities in Member States, empowered to perform their <u>tasks</u> and exercise their functions with complete independence, is an essential component of the protection of individuals with regard to the processing of their personal data. Member States may establish more than one supervisory authority, to reflect their constitutional, organisational and administrative structure.
- 92a) The independence of supervisory authorities should not mean that the supervisory authorities cannot be subjected to control or monitoring mechanism regarding their financial expenditure¹. Neither does it imply that supervisory authorities cannot be subjected to judicial review.
- 93) Where a Member State establishes several supervisory authorities, it should establish by law mechanisms for ensuring the effective participation of those supervisory authorities in the consistency mechanism. That Member State should in particular designate the supervisory authority which functions as a single contact point for the effective participation of those authorities in the mechanism, to ensure swift and smooth co-operation with other supervisory authorities, the European Data Protection Board and the Commission.
- 94) Each supervisory authority should be provided with the (...) financial and human resources, premises and infrastructure, which <u>are</u> necessary for the effective performance of their tasks, including for the tasks related to mutual assistance and co-operation with other supervisory authorities throughout the Union. <u>Each supervisory authority should have a separate annual budget</u>, which may be part of the overall state or national budget.

- 95) The general conditions for the <u>member or</u> members of the supervisory authority should be laid down by law in each Member State and should in particular provide that those members should be either appointed by the parliament <u>and/or</u> the government <u>or the head of State</u> of the Member State <u>or by an independent body entrusted by Member State law with the appointment by means of a transparent procedure. In order to ensure the independence of the supervisory authority, the member or members should refrain from any action incompatible with their duties and should not, during their term of office, engage in any incompatible <u>occupation</u>, whether gainful or not. They should behave, after their term of office, with integrity and discretion as regards the acceptance of appointments and benefits.</u>
- 95a) Each supervisory authority should be competent on the territory of its own Member State to exercise the powers and to perform the tasks conferred on it in accordance with this Regulation. This should cover in particular the processing in the context of the activities of an establishment of the controller or processor on the territory of its own Member State, the processing of personal data, carried out by public authorities or private bodies acting in the public interest² processing affecting data subjects on its territory or processing carried out by a controller not established in the European Union when targeting data subjects residing in its territory. This should include dealing with complaints lodged by a data subject, conducting investigations on the application of the Regulation, promoting public awareness of the risks, rules, safeguards and rights in relation to the processing of personal data.
- 96) The supervisory authorities should monitor the application of the provisions pursuant to this Regulation and contribute to its consistent application throughout the Union, in order to protect natural persons in relation to the processing of their personal data and to facilitate the free flow of personal data within the internal market. For that purpose, <u>this Regulation should oblige and empower</u> the supervisory authorities to co-operate with each other and the Commission, <u>without the need for any agreement between Member States on the provision of mutual assistance or on such cooperation</u>.

96a) Where the processing of personal data *takes place* in the context of the activities of an establishment of a controller or processor in the Union <u>and the controller (...) is established</u> in more than one Member State, or where processing taking place in the context of the activities of a single establishment of a controller (...) in the Union substantially affects or is likely to substantially affect data subjects in more than one Member State, the supervisory authority for the main establishment of the controller or processor or for the single establishment of the controller or processor should act as lead authority. Within its tasks to issue guidelines on any question covering the application of this Regulation, the European Data Protection Board may issue guidelines in particular on the criteria to be taken into account in order to ascertain whether the processing in question substantially affects data subjects in more than one Member State.

(...)

- 96b) The lead authority should be competent to adopt binding decisions regarding measures

 applying the powers conferred on it in accordance with the provisions of this Regulation. In
 its capacity as lead authority, the supervisory authority should closely involve and coordinate
 the *concerned* supervisory authorities in the decision-making process. In cases where the
 decisions is to reject the complaint by the data subject in whole or in part that decision
 should be adopted by the up supervisory authority at which the complaint has been
 lodged.
- 96c) The decision (...) should be agreed jointly by the lead supervisory authority and (...) the (...) concerned supervisory authorities and should be directed towards the main or single establishment of the controller or processor and be binding on the controller and processor. The controller or processor should take the necessary measures to ensure the compliance with this Regulation and the implementation of the decision notified by the lead supervisory authority to the main establishment of the controller or processor as regards the processing activities (...) in the Union.

- 97) <u>A supervisory authority should not act as lead supervisory authority in local cases where the</u> controller (...) is established in more than one Member State, but the subject matter of the specific processing concerns only processing carried out in a single Member State and involving only data subjects in that single Member State, for example, where the subject matter concerns the processing of employees data in the specific employment context of a Member State. The rules on the lead supervisory authority and the one-stop-shop mechanism should not apply where the processing is carried out by public authorities or private bodies of acting in the public interest. In such cases the only supervisory authority competent to exercise the powers conferred to it in accordance with this Regulation should be the supervisory authority of the Member State where the public authority or body is established.
- 98) (...)
- 99) In order to ensure consistent monitoring and enforcement of this Regulation throughout the Union, the supervisory authorities should have in each Member State the same tasks and effective powers, including powers of investigation, corrective powers and sanctions, and authorisation and advisory powers, particularly in cases of complaints from individuals, and to bring infringements of this Regulation to the attention of the judicial authorities and/or engage in legal proceedings. Member States may specify other tasks related to the protection of personal data under this Regulation. The powers of supervisory authorities (...) should be exercised in conformity with appropriate procedural safeguards set out in Union law and national law, impartially, fairly and within a reasonable time. In particular each measure should be appropriate, necessary and proportionate in view of ensuring compliance with this Regulation, taking into account the circumstances of each individual case, respect the right of every person to be heard before any individual measure which would affect him or her adversely is taken and avoid superfluous costs and excessive inconveniences for the persons concerned. Investigatory powers as regards access to premises should be exercised in accordance with specific requirements in national procedural law, such as the requirement to obtain a prior judicial authorisation.

Each legally binding measure of the supervisory authority should be in writing, be clear and unambiguous, indicate the supervisory authority which has issued the measure, the date of issue of the measure, bear the signature of the head or a member of the supervisory authority of a person authorised by him or her, give the reasons for the measure, and refer to the right of an effective remedy. This should not preclude additional requirements pursuant to national procedural law. The adoption of such legally binding decision implies that it may give rise to judicial review in the Member State of the supervisory authority that adopted the decision³.

101) Where the supervisory authority to which the complaint has been lodged is not the lead supervisory authority, the lead supervisory authority should closely co-operate with the supervisory authority to which the complaint has been lodged according to the provisions on co-operation and consistency laid down in this Regulation. In such cases, the lead supervisory authority should, when taking measures intended to produce legal effects, including the imposition of administrative fines, take utmost account of the view of the supervisory authority to which the complaint has been lodged and which should remain competent to carry out any investigation on the territory of its own Member State in liaison with the competent supervisory authority.

- 101a) The supervisory authority receiving a complaint or detecting or being informed otherwise of situations that entail possible infringements of the Regulation should seek an amicable settlement and, if this proves unsuccessful, exercise its full range of powers in cases where another supervisory authority should act as a lead supervisory authority for the processing activities of the controller (...) but the concrete subject matter of a complaint or the possible infringement concerns only processing activities (...) of the controller (...) in the one single Member State where the complaint has been lodged or the possible infringement detected and the matter does not substantially affect (...) or is not likely to substantially affect data subjects in other Member State of the supervisory authority or with regard to data subjects on the territory of that Member State; or to processing that is carried out in the context of an offer of goods or services specifically aimed at data subjects in the territory of the supervisory authority; or that has to be assessed taking into account relevant legal obligations under national law.
- 102) Awareness raising activities by supervisory authorities addressed to the public should include specific measures directed at controllers and processors, including micro, small and mediumsized enterprises, as well as (...) <u>individuals in particular in the educational context</u>.
- 103) The supervisory authorities should assist each other in performing their <u>tasks</u> and provide mutual assistance, so as to ensure the consistent application and enforcement of this Regulation in the internal market. Where a supervisory authority requesting mutual assistance, in the case of no response of the requested supervisory authority within one month of receiving the request, adopts a provisional measure, such provisional measure should be duly justified and only of a temporary nature.
- 104) Each supervisory authority should have the right to participate in joint operations between supervisory authorities. The requested supervisory authority should be obliged to respond to the request in a defined time period.

- 105) In order to ensure the consistent application of this Regulation throughout the Union, a consistency mechanism for co-operation between the supervisory authorities themselves and the Commission should be established. This mechanism should in particular apply where a supervisory authority intends to <u>adopt a measure intended to produce legal effects</u> as regards processing operations which substantially affect a significant number of data subjects in several Member States (...). It should also apply where any *concerned_supervisory* authority or the Commission requests that such matter should be dealt with in the consistency mechanism. This mechanism should be without prejudice to any measures that the Commission may take in the exercise of its powers under the Treaties.
- 106) In application of the consistency mechanism, the European Data Protection Board should, within a determined period of time, issue an opinion, if a (...) majority of its members so decides or if so requested by any *concerned*_supervisory authority_or the Commission. The European Data Protection Board should also be empowered to adopt legally binding decisions in case of disputes between supervisory authorities. For that purposes it should issue, with a two-third majority of its members, legally binding decisions in clearly defined cases where there are conflicting views among supervisory authorities in particular in the cooperation mechanism between the lead supervisory authority and *concerned* supervisory authorities on the merits of the case, notably whether there is an infringement of this Regulation or not (...).

107) (...)

108) There may be an urgent need to act in order to protect the <u>rights and freedoms</u> of data subjects, in particular when the danger exists that the enforcement of a right of a data subject could be considerably impeded. Therefore, a supervisory authority should be able to adopt provisional measures with a specified period of validity when applying the consistency mechanism.

- 109) The application of this mechanism should be a condition for the (...) <u>lawfulness</u> of <u>a</u> (...) <u>measure intended to produce legal effects</u> by a supervisory authority in those cases where its application is mandatory. In other cases of cross-border relevance, <u>the **cooperation**</u> <u>mechanism between the lead supervisory authority and *concerned* supervisory authorities <u>should be applied and</u> mutual assistance and joint operations might be carried out between the *concerned* supervisory authorities on a bilateral or multilateral basis without triggering the consistency mechanism.</u>
- 110) In order to promote the consistent application of this Regulation, the European Data Protection Board should be set up as an independent body of the Union. To fulfil its objectives, the European Data Protection Board should have legal personality. The European Data Protection Board should be represented by its Chairperson. It should replace the Working Party on the Protection of Individuals with Regard to the Processing of Personal Data established by Directive 95/46/EC. It should consist of a head of a supervisory authority of each Member State or his or her representative and of the European Data Protection Supervisor. The Commission should participate in its activities without voting rights. The European Data Protection Board should contribute to the consistent application of this Regulation throughout the Union, including by advising the Commission, in particular on the level of protection in third countries or international organisations, and promoting cooperation of the supervisory authorities throughout the Union. The European Data Protection Board should act independently when exercising its tasks

- 111) Every data subject should have the right to lodge a complaint with a supervisory authority, in particular in the Member State of his or her habitual residence, and have the right to an effective judicial remedy in accordance with Article 47 of the Charter of Fundamental Rights if the data subject considers that his or her rights under this Regulation are infringed or where the supervisory authority does not act on a complaint, partially or wholly rejects or dismisses a complaint or does not act where such action is necessary to protect the rights of the data subject. The investigation following a complaint should be carried out, subject to judicial review, to the extent that is appropriate in the specific case. The supervisory authority should inform the data subject of the progress and the outcome of the complaint within a reasonable period. If the case requires further investigation or coordination with another supervisory authority, intermediate information should be given to the data subject. In order to facilitate the submission of complaints, each supervisory authority should take measures such as providing a complaint submission form which can be completed also electronically, without excluding other means of communication.
- 112) Where a data subject considers that his or her rights under this Regulation are infringed, he or she should have the right to mandate a body, organisation or association which aims to protect the rights and interests of data subjects in relation to the protection of their data and is constituted according to the law of a Member State, to lodge a complaint on his or her behalf with a supervisory authority or exercise the right to a judicial remedy on behalf of data subjects. Such a body, organisation or association should have the right to lodge, independently of a data subject's complaint, a complaint where it has reasons to consider that a personal data breach referred to in Article 32(1) has occurred and Article 32(3) does not apply.

113) Without prejudice to the right of natural or legal person to bring an action for annulment of decisions of the European Data Protection Board which have been notified to him or her before the Court of Justice of the European Union, each natural or legal person should have the right to an effective judicial remedy against a decision of a supervisory authority which produces legal effects concerning this person. Such decisions concern in particular the exercise of investigative, corrective and authorisation powers by the supervisory authority or the dismissal or rejection of complaints. However, this right does not encompass other measures of supervisory authorities which are not legally binding, such as opinions issued by or advice provided by the supervisory authority. The fact that a natural or legal person has not brought an action for the annulment of the European Data Protection Board's decisions before the Court of Justice of the European Union within the mandatory time-limit, does not bar that person from calling in question the lawfulness of that decision before the national courts at a later stage in particular in the context of judicial review of a supervisory authority's decision applying the European Data Protection Board's decision. In that context, where a national court considers that the European Data Protection Board's decision may be unlawful, it shall request the Court of Justice of the European Union a preliminary ruling concerning the validity of that European Data Protection Board's decision, in accordance with Article 267 TFEU as interpreted by the Court of Justice in the Foto-frost case⁶. Proceedings against a supervisory authority should be brought before the courts of the Member State where the supervisory authority is established and shall be conducted in accordance with the national procedural law of that Member State. Those courts should exercise full jurisdiction which should include jurisdiction to examine all questions of fact and law relevant to the dispute before it. Where a complaint has been rejected or dismissed by a supervisory authority, the complainant may bring proceedings to the courts in the same Member State. In the context of judicial remedies relating to the application of this Regulation, national courts whose decisions may be subject to appeal under national law should endeavour to request a preliminary ruling concerning the interpretation of Union law including this Regulation, in particular where the case involves a data subject who has lodged a complaint with a supervisory authority located in a Member State other than the one where the controller or processor has its establishment.

Definitions

- (13) 'main establishment' means⁷
 - as regards a controller with establishments in more than one Member State, the place of its central administration in the Union, unless the decisions on the purposes (...) and means of the processing of personal data are taken in another establishment of the controller in the Union <u>and the latter establishment has the power to have</u> <u>such decisions implemented</u>, in this case the establishment having taken such decisions shall be considered as the main establishment⁸.

- (19a) 'concerned supervisory authority ' means
 - a supervisory authority which is concerned by the processing, because the controller
 (...) is established on the territory of the Member State of that supervisory authority;
 or the underlying complaint has been lodged to that supervisory authority¹⁰; or
 because the *processing* [is likely to present a high degree of specific risk for the
 rights and freedoms of¹¹] data subjects residing in this Member State which are or
 likely to be substantially affected by the processing.

(19b) "transnational processing of personal data" means either:

(a) processing which takes place in the context of the activities of an establishment of a controller in the Union and the controller is established in more than one Member State; or

(b) <u>processing which takes place in the context of the activities of a single</u> <u>establishment of a controller in the Union but which substantially affects or is</u> <u>likely to substantially affect¹² data subjects in more than one Member State</u>.

(19c) "serious and reasoned objection" means :

an objection on grounds relating to whether there is an infringement of this Regulation or not, or, as the case may be, whether the envisaged action in relation to the controller is in conformity with the Regulation. The objection shall be accompanied by an analysis of the significance of the risks posed by the draft decision as regards the fundamental rights and freedoms of data subjects and where applicable, the free flow of personal data.

CHAPTER VI INDEPENDENT SUPERVISORY AUTHORITIES

SECTION 1 INDEPENDENT STATUS

Article 46 Supervisory authority¹³

- 1. Each Member State shall provide that one or more independent public authorities are responsible for monitoring the application of this Regulation.
- 1a. Each supervisory authority shall contribute to the consistent application of this Regulation throughout the Union $(...)^{14}$. For this purpose, the supervisory authorities shall co-operate with each other and the Commission in accordance with Chapter VII¹⁵.
- 2. Where in a Member State more than one supervisory authority are established, that Member State shall designate the supervisory authority which <u>shall represent</u> those authorities in the European Data Protection Board and shall set out the mechanism to ensure compliance by the other authorities with the rules relating to the consistency mechanism referred to in Article 57.
- [3. Each Member State shall notify to the Commission those provisions of its law which it adopts pursuant to this Chapter, by the date specified in Article 91(2) at the latest and, without delay, any subsequent amendment affecting them¹⁶].

Article 47 ¹⁷

- 1. Each supervisory authority shall act with complete¹⁸ independence in <u>performing</u> the <u>duties</u>¹⁹ and *exercising* the powers entrusted to it <u>in accordance with this Regulation</u>.

- 6. Each Member State shall ensure that <u>each</u> supervisory authority has its own staff which shall (...) be subject to the direction of the <u>member or members</u>²⁶ of the supervisory authority.

- Where any of the <u>concerned</u> supervisory authorities within a period of four⁷⁸ weeks after having been consulted <u>in accordance with</u> paragraph 2 to the draft decision, <u>expresses a</u> <u>serious and</u> reasoned objection, the lead supervisory authority <u>shall</u>, <u>if it does not follow</u> the objection, submit the matter to the consistency mechanism referred to in Article 57.
 (...)
- 3a.In case there is more than one concerned supervisory authority, the lead supervisory
authority shall only submit the matter to the consistency mechanism referred to in
Article 57, if at least one third of the concerned supervisory authorities has expressed
a serious and reasoned objection to the draft decision.
- 3.b. Where the lead supervisory authority intends to follow the objection made, it shall submit to the concerned supervisory authorities a revised draft decision for their opinion. This revised draft decision shall be subject to the procedure referred to in paragraph 3 within a period of two weeks.
- 3c.In case of disagreement between supervisory authorities on whether an objection is
reasoned and serious, the lead authority shall submit the matter to the consistency
mechanism in accordance with paragraph 3.
- 4. Where no supervisory authority concerned has objected to the draft decision submitted by the lead supervisory authority within the period referred to in paragraphs 3 and 3b, the lead supervisory authority and the supervisory authorities concerned shall be deemed to be in agreement with this draft decision.

- <u>4a.</u> The lead supervisory authority shall adopt and notify the decision to the main establishment or single establishment of the controller (...)⁷⁹, and inform the concerned supervisory authorities and the European Data Protection Board of the decision in question including a summary of the relevant facts and grounds. The supervisory authority to which a complaint has been lodged shall inform the complainant on the decision.
- 4b. By derogation from paragraph 4a, where (...) the complaint is dismissed or rejected
 (...), the supervisory authority to which the complain was lodged shall adopt the
 ⁸⁰decision and notify it to the complainant. (...) and shall inform the controller thereof.
- 4bb.Where the lead supervisory authority and the concerned supervisory authorities are
in agreement to dismiss or reject parts of a complaint and to act on other parts of the
complaint, a separate decision shall be adopted for each of those parts of the
matter.The lead supervisory authority shall adopt the decision for the part
concerning actions in relation to the controller and notify it to the main establishment
or single establishment of the controller or processor on the territory of its Member
State, while the supervisory authority of the complainant shall adopt the decision for
the part concerning dismissal or rejection of the complaint and notify it on the
complainant⁸¹.
- 4c. After being notified of the decision of the lead supervisory authority pursuant to paragraph 4a and 4bb, the controller (...) shall take the necessary measures to ensure compliance with the decision as regards the processing activities in the context of all its establishments in the Union. The controller (...) shall notify the measures taken for complying with the decision to the lead supervisory authority, which shall inform the *concerned* supervisory authorities. The *concerned* supervisory authorities shall be bound by the single decision (...)

- 4d.Where, in exceptional circumstances, a *concerned* supervisory authority has reasons to
consider that there is an urgent need to act in order to protect the interests of data subjects,
the urgency procedure referred to in Article 61 shall apply.
- 5. The <u>lead</u> supervisory authority and the *concerned* supervisory authorities shall supply the information required under this Article (...) to each other by electronic means, using a standardised format.

Article **54b**

Cooperation between the lead supervisory authority and the other supervisory authorities concerned in individual cases of possible non-compliance with the Regulation

(...)

Article 55 Mutual assistance⁸²

1. Supervisory authorities shall provide each other <u>with</u> relevant information and mutual assistance in order to implement and apply this Regulation in a consistent manner, and shall put in place measures for effective co-operation with one another. Mutual assistance shall cover, in particular, information requests and supervisory measures, such as requests to carry out prior authorisations and consultations, inspections and <u>investigations</u>. (...)

- 2. Each supervisory authority shall take all appropriate measures required to reply to the request of another supervisory authority without undue delay and no later than <u>one month</u>⁸³ after having received the request. Such measures may include, in particular, the transmission of relevant information on the <u>conduct</u> of an investigation (...).
- The request for assistance shall contain all the necessary information⁸⁴, including the purpose of the request and reasons for the request. Information exchanged shall be used only <u>for the purpose</u> for which it was requested.
- 4. ⁸⁵A supervisory authority to which a request for assistance is addressed may not refuse to comply with it unless:

(a) it is not competent for the subject-matter of the request or for the measures it is requested to execute⁸⁶; or

(b) compliance with the request would be incompatible with the provisions of this Regulation or with Union or Member State law to which the supervisory authority receiving the request is subject.

5. The requested supervisory authority shall inform the requesting supervisory authority of the results or, as the case may be, of the progress or the measures taken in order to <u>respond</u> to the request. <u>In cases of a refusal under paragraph 4, it shall explain its reasons for refusing the request</u>⁸⁷.

- 6. Supervisory authorities shall, <u>as a rule</u>, supply the information requested by other supervisory authorities by electronic means⁸⁸, using a standardised format.
- No fee shall be charged for any action taken following a request for mutual assistance. Supervisory authorities may agree with other supervisory authorities rules for indemnification by other supervisory authorities for specific expenditure arising from the provision of mutual assistance in exceptional circumstances⁸⁹.
- 8. Where a supervisory authority does not provide the information referred to in paragraph 5 within <u>one month of receiving the request</u> of another supervisory authority, the requesting supervisory authority <u>may adopt</u> a provisional measure⁹⁰ on the territory of its Member State in accordance with Article 51(1) and shall submit the matter to the European Data Protection Board (...) in accordance with the <u>consistency mechanism</u> referred to in Article 57⁹¹.
- 9. The supervisory authority shall specify the period of validity of such a provisional measure which shall not exceed three months⁹². The supervisory authority shall, without delay, communicate <u>such a</u> measure, <u>together with its</u> reasons <u>for adopting it</u>, to the European Data Protection Board (...) <u>in accordance with the consistency mechanism referred to in Article 57</u>.

The Commission may specify the format and procedures for mutual assistance referred to in this article and the arrangements for the exchange of information by electronic means between supervisory authorities, and between supervisory authorities and the European Data Protection Board, in particular the standardised format referred to in paragraph 6. Those implementing acts shall be adopted in accordance with the examination procedure referred to in Article $87(2)^{93}$.

Article 56 Joint operations of supervisory authorities⁹⁴

- The supervisory authorities <u>may</u>, where appropriate, conduct joint operations, <u>including</u> joint <u>investigations and</u> joint enforcement measures in which members or staff from other Member States' supervisory authorities are involved.
- 2. In cases where the controller or processor has establishments in several Member States or where [a significant number of⁹⁵] data subjects in more than one Member State are likely to be substantially affected by processing operations, a supervisory authority of each of those Member States shall have the right to participate in the joint operations, as appropriate. The competent supervisory⁹⁶ authority shall invite the supervisory authority of each of those Member States to take part in the joint operations concerned and respond without delay to the request of a supervisory authority to participate⁹⁷.

- 3. <u>A</u> supervisory authority may, in compliance with its own <u>Member State</u> law, and with the seconding supervisory authority's authorisation, confer <u>powers</u>, including investigative powers on the seconding supervisory authority's members or staff involved in joint operations or, in so far as the <u>law of the Member State of the</u> host supervisory authority permits, allow the seconding supervisory authority's members or staff to exercise their <u>investigative</u> powers in accordance with the <u>law of the Member State of the</u> seconding supervisory authority. Such <u>investigative</u> powers may be exercised only under the guidance and in the presence of members or staff <u>of</u> the host supervisory authority. The seconding supervisory authority's members or staff shall be subject to the host supervisory authority's national law. (...)⁹⁸
- 3a. Where, in accordance with paragraph 1, staff of a seconding supervisory authority are operating in another Member State, the Member State of the host supervisory authority shall be liable for any damage caused by them during their operations, in accordance with the law of the Member State in whose territory they are operating.
- 3b. The Member State in whose territory the damage was caused shall make good such damage under the conditions applicable to damage caused by its own staff. The Member State of the seconding supervisory authority whose staff has caused damage to any person in the territory of another Member State shall reimburse the latter in full any sums it has paid to the (...) persons entitled on their behalf.
- 3c. Without prejudice to the exercise of its rights vis-à-vis third parties and with the exception of paragraph 3b, each Member State shall refrain, in the case provided for in paragraph 1, from requesting reimbursement of damages [it has sustained] from another Member State⁹⁹.

- 6. The supervisory authority shall specify the period of validity of a provisional measure referred to in paragraph 5, <u>which</u> shall not exceed three months. The supervisory authority shall, without delay, communicate <u>such a</u> measure, <u>together with its</u> reasons <u>for adopting it</u>, to the European Data Protection Board and to the Commission in <u>accordance with</u> the <u>consistency</u> mechanism referred to in Article 57.

CONSISTENCY¹⁰¹

Article 57

Consistency mechanism¹⁰²

- 1. For the purpose set out in Article 46(1a), the supervisory authorities shall co-operate with each other through the consistency mechanism as set out in this section¹⁰³.
- 2. The European Data Protection Board shall (...) issue an opinion whenever a competent supervisory authority intends to adopt any of the measures below (...). To that end, the competent supervisory authority shall communicate the draft decision to the European Data Protection Board, when the it:
 - (a) (...);
 - (b) (...);
 - (c) aims at adopting a list of the processing operations subject to <u>the requirement for a</u> <u>data protection impact assessment</u> pursuant to Article <u>33(2b)</u>; or
 - (ca) concerns a matter pursuant to Article 38(2b) whether a draft code of conduct or an amendment or extension to a code of conduct is in compliance with this Regulation; <u>or</u>
 - (cb) <u>aims at approving the criteria for accreditation of a body pursuant to paragraph 3 of</u> <u>Article 38a or a certification body pursuant to paragraph 2a of Article 39 or</u> <u>paragraph 3 of Article 39a;</u>

- <u>2a.</u> The European Data Protection Board shall <u>adopt a binding decision</u> in the following cases:
 - a) Where, in a case referred to in paragraph 3 of Article 54a(...), a concerned supervisory authority (...) has expressed a serious and reasoned objection to a draft decision of the lead authority (...); The binding decision shall concern all the matters which are the subject of the serious and reasoned objection.
 - b) Where, in a case referred to in paragraph 3c of Article 54a, there is a disagreement between supervisory authorities on whether an objection is reasoned and serious. In this case the European Data Protection Board may decide by simple majority that the objection is not serious and reasoned. [In such a case the European Data Protection Board shall send the request back to the lead supervisory authority in order to decide upon in accordance with the procedure provided in Article 54a];
 - <u>c)</u> [Where (...), there are conflicting views on which of the *concerned* supervisory authorities is competent for the main establishment. (...);
 - <u>d)</u> Where a competent supervisory authority does not comply with the obligations for mutual assistance in accordance with Article 55 or for joint operations in accordance with Article 56. In that case, any *concerned* supervisory authority ¹⁰⁴ (...) or the Commission may communicate such matter to the European Data Protection Board¹⁰⁵;

Supervisory authorities and the Commission shall electronically communicate to the <u>European Data Protection Board, using a standardised format</u> any relevant information, including as the case may be a summary of the facts, the draft <u>decision</u>, the grounds which make the enactment of such measure necessary, and the views of other *concerned* supervisory <u>authorities</u>.
- 6. The chair of the European Data Protection Board shall <u>without undue delay</u> electronically inform the members of the European Data Protection Board and the Commission of any relevant information which has been communicated to it using a standardised format. The <u>secretariat</u> of the European Data Protection Board shall, where necessary, provide translations of relevant information.

<u>Article 58a</u> <u>Decisions by the European Data Protection Board</u>¹¹⁰

- In the cases referred to in paragraph 2a of Article 57, the European Data Protection Board shall adopt a decision on the subject-matter submitted to it in order to ensure the correct and consistent application of this Regulation in individual cases. *The decision shall be reasoned* and addressed to *the lead supervisory authority and all the concerned supervisory authorities and binding on them.*
- 2. <u>The decision referred to in paragraph 1 shall be adopted within one month from the referral of the subject-matter by a two-third¹¹¹ majority of the members of the Board. (...). <u>This period may be extended by a further month on account of the complexity of the subject-matter.</u></u>

In exceptional circumstances, where <u>a</u> supervisory authority considers that there is an urgent need to act in order to protect <u>rights and freedoms</u> of data subjects, it may, by way of derogation from the <u>consistency mechanism</u> referred to in Article <u>57</u> or the procedure referred to in Article <u>54a</u>, immediately adopt provisional measures <u>intended to produce legal effects</u> (...) <u>within the territory of its own Member State</u>¹¹⁸, with a specified period of validity. The supervisory authority shall, without delay, communicate those measures <u>and the</u> reasons <u>for adopting them</u>, to the European Data Protection Board and to the Commission¹¹⁹.

SECTION 3

EUROPEAN DATA PROTECTION BOARD¹²²

Article 64

European Data Protection Board

- 1a.The European Data Protection Board is hereby established as body of the Union and shall
have legal personality.
- 1b. The European Data Protection Board shall be represented by its Chair.
- 2. The European Data Protection Board shall be composed of the head¹²³ of one supervisory authority of each Member State <u>or his/her representative</u> and of the European Data Protection Supervisor¹²⁴.

- 3. Where in a Member State more than one supervisory authority is responsible for monitoring the application of the provisions pursuant to this Regulation, they shall nominate the head of one of those supervisory authorities as joint representative.
- 4. The Commission¹²⁵ shall have the right to participate in the activities and meetings of the European Data Protection Board and shall designate a representative <u>without voting rights</u>. The chair of the European Data Protection Board shall, <u>communicate</u> the Commission <u>the</u> activities of the European Data Protection Board.

Independence

- 1. The European Data Protection Board shall act independently when <u>performing</u> its tasks or exercising its powers pursuant to Articles 66 (...) and 67.¹²⁶
- 2. Without prejudice to requests by the Commission referred to in point (b) of paragraph 1 and in paragraph 2 of Article 66, the European Data Protection Board shall, in the <u>performance of its tasks or the exercise of its powers</u>, neither seek nor take instructions from anybody¹²⁷.

Article 66

Tasks of the European Data Protection Board

- The European Data Protection Board shall <u>promote</u> the consistent application of this Regulation. To this effect, the European Data Protection Board shall, on its own initiative or at the request of the Commission, in particular:
 - (aa) monitor and ensure the correct application of this Regulation in the cases provided for in Article 57(2a) without prejudice to the tasks of national supervisory authorities;

- (a) advise the Commission on any issue related to the protection of personal data in the Union, including on any proposed amendment of this Regulation;
- (b) examine, on its own initiative or on request of one of its members or on request of the Commission, any question covering the application of this Regulation and issue guidelines, recommendations and best practices in order to encourage consistent application of this Regulation;
- (ba) draw up guidelines for supervisory authorities concerning the application of measures referred to in paragraph 1, 1b and 1c of Article 53 and the fixing of administrative fines pursuant to Articles 79 and 79a¹²⁸;
 - (c) review the practical application of the guidelines, recommendations and best practices referred to in points (b) <u>and (ba);</u>
 - (ca) encourage the drawing-up of codes of conduct and the establishment of data protection certification mechanisms and data protection seals and marks pursuant to Articles 38 and 39;
 - (cb) <u>carry out the accreditation of certification bodies and its periodic review pursuant to</u> <u>Article 39a and maintain a public register of accredited bodies pursuant to paragraph 6</u> <u>of Article 39a and of the accredited controllers or processors established in third</u> <u>countries pursuant to paragraph 4 of Article 39</u>¹²⁹;
 - (cd) specify the requirements mentioned in paragraph 3 of Article 39a with a view to the accreditation of certification bodies under Article 39;
 - (ce) give the Commission an opinion on the level of protection in third countries or international organisations, in particular in the cases referred to in Article 41;
 - (d) issue opinions on draft decisions of supervisory <u>authorities</u> pursuant to the consistency mechanism referred to in <u>paragraph 2 and on matters submitted pursuant to</u> <u>paragraph 2c of</u> Article 57;

- (e) promote the co-operation and the effective bilateral and multilateral exchange of information and practices between the supervisory authorities;
- (f) promote common training programmes and facilitate personnel exchanges between the supervisory authorities, as well as, where appropriate, with the supervisory authorities of third countries or of international organisations;
- (g) promote the exchange of knowledge and documentation on data protection legislation and practice with data protection supervisory authorities worldwide;
- [(h) maintain a publicly accessible electronic register for consultation on confirmed main establishments referred to in Article 51c;]
- (i) <u>maintain a publicly accessible electronic register of decisions taken by supervisory</u> <u>authorities and courts on issues dealt with in the consistency mechanism</u>.
- 2. Where the Commission requests advice from the European Data Protection Board, it may <u>indicate</u> a time limit, taking into account the urgency of the matter.
- 3. The European Data Protection Board shall forward its opinions, guidelines, recommendations, and best practices to the Commission and to the committee referred to in Article 87 and make them public.

Article 67 **Reports**

- 1. (...)
- 2. <u>The European Data Protection Board</u> *shall draw up an annual report regarding the protection of natural persons with regard to the processing of personal data in the Union and*, where <u>relevant</u>, *in third countries* <u>and international organisations</u>. The report shall be made public and <u>be</u> transmitted to the European Parliament, the Council and the Commission.

 The <u>annual</u> report shall include <u>a</u> review of the practical application of the guidelines, recommendations and best practices referred to in point (c) of Article 66(1) <u>as well as of the</u> <u>binding decisions</u> referred to in paragraph 2a of Article 57.

Article 68

Procedure

- The European Data Protection Board shall <u>adopt binding decisions referred to in paragraph</u>
 <u>2a of Article 57 by a two-third majority of its members. As regards decisions related to the</u>
 <u>tasks listed in Article 66 hereof, they shall be taken by a simple majority of its members (...).</u>
- The European Data Protection Board shall adopt its own rules of procedure <u>by a two-third</u> <u>majority of its members</u> and organise its own operational arrangements.

Article 69

Chair

- 1. The European Data Protection Board shall elect a chair and two deputy chairpersons from amongst its members (...).¹³⁰
- 2. The term of office of the chair and of the deputy chairpersons shall be five years and be renewable <u>once¹³¹</u>.

Tasks of the chair

- 1. The chair shall have the following tasks 132 :
 - (a) to convene the meetings of the European Data Protection Board and prepare its agenda;
 - (aa) to notify decisions adopted by the European Data Protection Board pursuant to
 Article 58a to the lead supervisory authority and the *concerned* supervisory
 authorities (...);
 - (b) to ensure the timely <u>performance</u> of the tasks of the European Data Protection Board, in particular in relation to the consistency mechanism referred to in Article 57.
- 2. The European Data Protection Board shall lay down the attribution of tasks between the chair and the deputy chairpersons in its rules of procedure.

Article 71

Secretariat

- The European Data Protection Board shall have a secretariat. The European Data Protection Supervisor shall provide that secretariat¹³³.
- 2. The secretariat shall provide analytical, administrative and logistical support to the European Data Protection Board.
- 3. The secretariat shall be responsible in particular for:
 - (a) the day-to-day business of the European Data Protection Board;

(b) the communication between the members of the European Data Protection Board, its chair, and the Commission and for communication with other institutions and the public;

- (c) the use of electronic means for the internal and external communication;
- (d) the translation of relevant information;
- (e) the preparation and follow-up of the meetings of the European Data Protection Board;
- (f) the preparation, drafting and publication of opinions, <u>positions on the settlement of</u> <u>disputes between supervisory authorities</u> and other texts adopted by the European Data Protection Board.

Article 72 Confidentiality¹³⁴

- 1. The discussions¹³⁵ of the European Data Protection Board shall be confidential.
- 2. <u>Access to documents</u> submitted to members of the European Data Protection Board, experts and representatives of third parties shall be <u>governed by</u> Regulation (EC) No 1049/2001.

CHAPTER VIII

REMEDIES, LIABILITY AND SANCTIONS¹³⁶

Article 76b

Actions before the Court of Justice of the European Union against decisions by the European Data Protection Board¹³⁷

- Actions may be brought before the Court of Justice of the European Union in accordance with Article 263 TFEU, in order for it to review the legality of decisions taken by the European Data Protection Board pursuant to Article 58a. Such actions may be brought before the Court of Justice of the European Union by supervisory authorities, Member States and the Union institutions as well as by natural or legal persons to whom decisions taken by the European Data Protection Board have been notified or to whom such decisions are of direct and individual concern, including data subjects who have lodged a complaint in accordance with Article 73.
- 2. The expiration of the time-period provided for in the sixth subparagraph of Article 263 TFEU and the Rules of Procedure of the General Court shall not bar the persons referred to in paragraph 1 from calling in question the lawfulness of any decision taken by the European Data Protection Board before the national courts in accordance with Article 74 or 75 and those national courts from requesting the Court of Justice of the European Union a preliminary ruling concerning the validity of any decision taken by the European Data Protection Board in accordance with Article 267 TFEU.

- 3. Where the European Data Protection Board notifies its decision in accordance with Article 58a(6), such a notification shall state the possibility for the persons referred to in paragraph 1 to bring an action for annulment before the General Court of the European Union in accordance with Article 263 TFEU as well as the time-period for such an action in accordance with the sixth subparagraph of Article 263 TFEU and the Rules of Procedure of the General Court. It shall also refer to the additional right conferred on that person pursuant to paragraph 2.
- 4. In the event that the European Data Protection Board has an obligation to act and fails to take a decision, proceedings for failure to act may be brought before the Court of Justice of the European Union in accordance with Article 265 TFEU.
- 5. <u>The European Data Protection Board shall be required to take the necessary measures to</u> <u>comply with the judgment of the Court of Justice of the European Union.</u>
