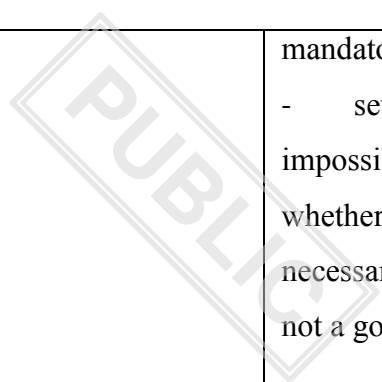

Subject:	Proposal for a REGULATION ON THE EUROPEAN PARLIAMENT AND OF THE COUNCIL on the sustainable use of plant protection products and amending Regulation (EU) 2021/2115 - Follow up to the Working Party on Plants and Plant Health Questions (Pesticides/Plant Protection Products) on 27 January 2023 – comments from Luxembourg on IPM

<i>Chapter IV</i>		<ul style="list-style-type: none"><li>- Several of the proposed provisions would lead to unacceptable administrative burden for both PPP users (e.g. recording all aspects of IPM measures taken or not taken and reasons thereof) and authorities (e.g. procedure for establishing and annually reviewing crop specific guidelines);</li><li>- In practice it will be impossible to provide each PPP user with access to an advisor. Some PPP users have the same or better knowledge regarding their crops as an advisor. Some crops or PPP uses might be very rare and specific advice is not available. Imposing an advisor in these cases does not make sense and in general</li></ul>

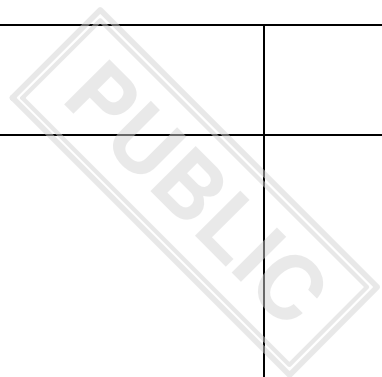

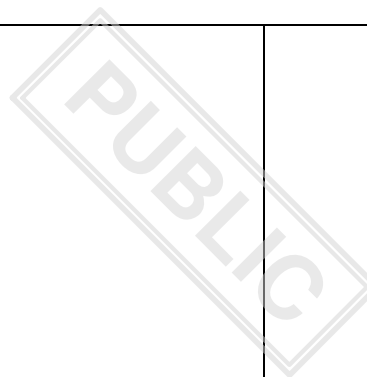

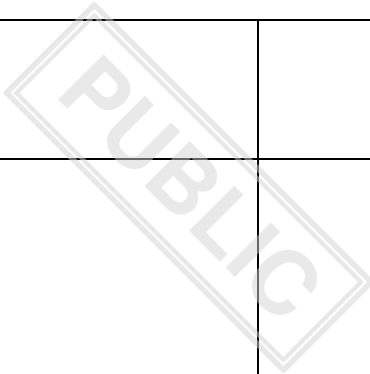

<b>CHAPTER V</b> <b>USE, STORAGE AND DISPOSAL OF PLANT PROTECTION PRODUCTS</b>		
<i>Article 17</i> <b>General requirements for the use of plant protection products for professional use and of application equipment in professional use</b>		
1. A plant protection product authorised for professional use may only be used by a professional user who:  (a) has been issued with a training certificate for following courses for professional users in accordance with Article 25, or has a proof of entry in a central electronic register for following such courses in accordance with Article 25(5), and  (b) uses the services of an independent advisor in accordance with Article 26(3).	1. A plant protection product authorised for professional use may only be used by a professional user who:  (a) has been issued with a training certificate for following courses for professional users in accordance with Article 25, or has a proof of entry in a central electronic register for following such courses in accordance with Article 25(5), and

Application equipment in professional use may only be used by professional users that hold a training certificate issued to them for following courses for professional users in accordance with Article 25 or have a proof of entry in a central electronic register for following such courses in accordance with Article 25(5).

Within 3 years starting from date of first purchase, and every 3 years thereafter, a professional user shall submit his or her application equipment in professional use for inspection pursuant to Article 31. Where 3 years have passed from the date of first purchase of application equipment in professional use, a professional user may only use it for the application of plant protection products, if that
