"While the European Union has decided to develop its policies for education and training on the basis of data developed by various European and international institutions including the OECD and while, within the framework of evidence-based education and training policies, the European Commission is enhancing its cooperation and exchanges with the OECD and is encouraging the Member States to cooperate and participate in various OECD surveys and activities, Cyprus continues to be excluded from all such surveys and activities, because of Turkey's continued objections.

The problem has been repeatedly raised by Cyprus at different levels, both within the Council and the Commission.

Cyprus continues to contribute financially to these EU-funded activities of the OECD. Nevertheless, various research programmes and survey activities are planned to be carried out within the framework of the EU-OECD co-operation, from which Cyprus will continue to be excluded.

Cyprus fully supports and endorses the continuation and strengthening of EU-OECD cooperation. It hopes and expects that this cooperation will be developed and promoted on the basis of the equal treatment and non-exclusion of any Member State."
