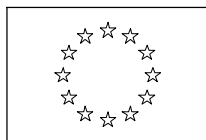

## PARTI A: DAHLA

Dan ir-rapport jifforma parti mill-“pakkett ta’ implimentazzjoni” tal-politika ekonomika u ta’ l-impjiegi, flimkien mar-rapporti ta’ implimentazzjoni dwar il-Linji Gwida Ġenerali tal-Politika Ekonomika (LGĠPE) u l-Linji Gwida ta’ l-Impjiegi (LGI). Dawn it-tliet rapporti se jiġu pprezentati biex isostnu r-Rapport tal-Kummissjoni (ir-Revizjoni Intermedja ta’ Lisbona) għall-Kunsill Ewropew tar-Rebbiegħa ta’ l-2005.

Ir-rapport reċenti ta’ Kok<sup>1</sup> ifakkarna fl-importanza tas-Suq Intern biex dan isaħħaħ il-kompetittività waqt li johloq il-ġid meħtieġ biex jgħolli l-livelli ta’ l-għajxien u jzomm il-mudell soċjali Ewropew. Dan jerga’ jtenni l-messaġġ ewlieni ta’ l-Istrateġija tas-Suq Intern 2003-2006.<sup>2</sup>

Waqt li kull Stat Membru għandu r-responsabbiltà ewlenija li jiżgura li l-politika ekonomika tiegħu tkun tiffavorixxi t-tkabbir ekonomiku u l-ġid, is-Suq Intern huwa proġett komuni li għalih għandhom jikkontribwixxu l-Istati Membri kollha u li minnu kulhadd jista’ igawdi. Fl-UE-25, din hija sfida akbar minn qabel, iżda l-gwadanji possibbli huma wkoll akbar. Dan kien it-tieni messaġġ ewlieni ta’ l-Istrateġija tas-Suq Intern.

Is-suċċess ekonomiku għall-Unjoni Ewropea għalhekk jistrieħ fuq ir-responsabbiltà kollettiva; taħlita ta’ inizjattivi mill-Istati Membri u azzjoni Ewropea mfassla biex tintegra s-swieq nazzjonali f’Suq Intern kbir wiehed. Din l-azzjoni teħtieġ li tindirizza kemm il-provvista kif ukoll id-domanda; dan billi jitqiesu l-interessi tan-negozji u l-konsumaturi. Dan ir-rapport fuq l-implimentazzjoni ta’ l-Istrateġija tas-Suq Intern 2003-2006 jikkonferma l-htieġa tagħna li naġixxu flimkien. L-analiżi tiegħu dwar il-progress li sar u d-dewmien li kien hemm s’issa, turi li għad fadal ħafna xi jsir biex jintlaħaq qbil fuq il-proposti ewlenin u biex is-Suq Intern ikun jista’ jaħdem aħjar fil-prattika, waqt li l-integrazzjoni tas-suq baqgħet xi ffit jew wisq statika.

Fil-bidu tal-mandat tagħha u hekk kif miexja b’ritmu tajjeb ir-revizjoni intermedja ta’ l-Istrateġija ta’ Lisbona, il-Kummissjoni tilqa’ l-opportunità li tgħolli l-profil tas-Suq Intern u li tibni appoġġ aktar b’saħħtu biex dan jitlesta u jaħdem b’mod effettiv fil-prattika.

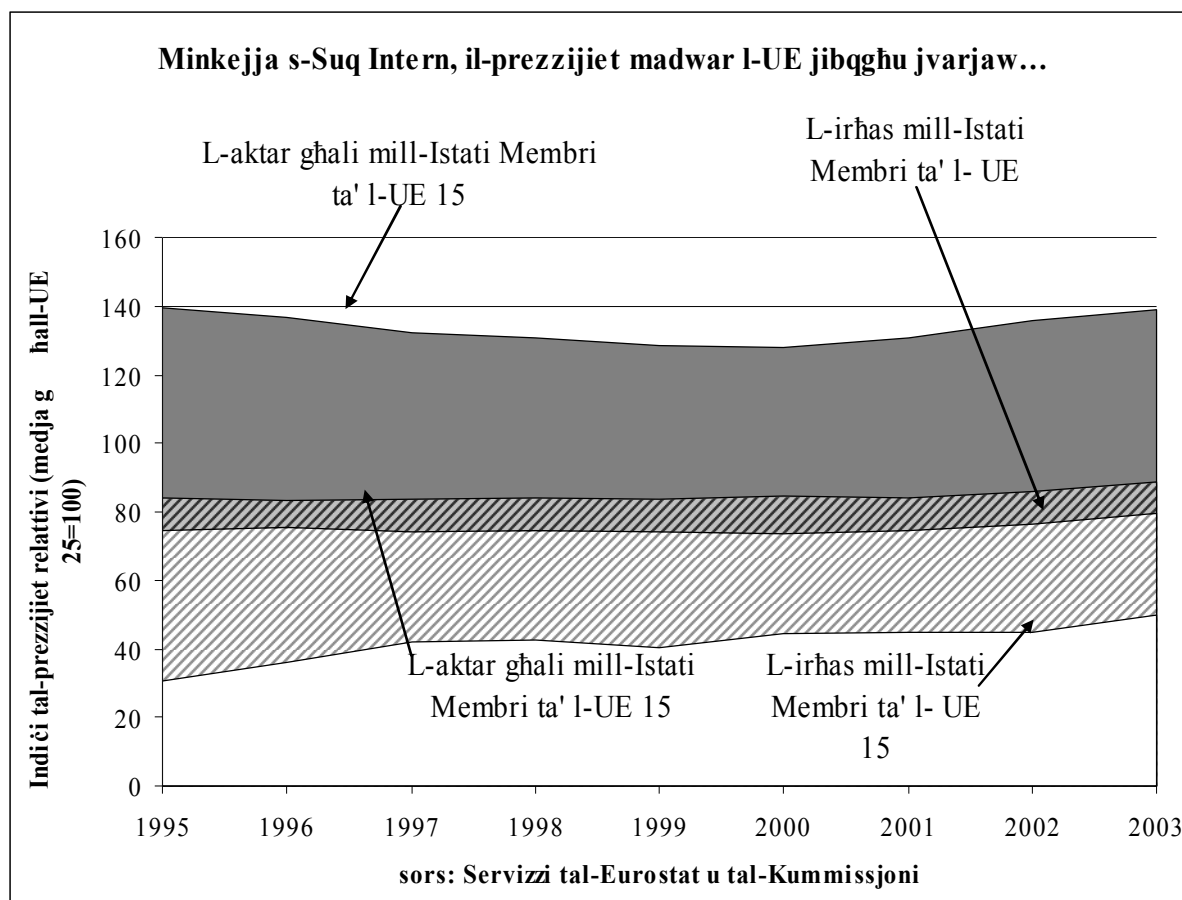
## PARTI B: IS-SITWAZZJONI PREŻENTI TAS-SUQ INTERN

Barra mit-tkabbir ekonomiku kajman, hemm indikaturi ewlenin oħra li jkomplu juru li l-integrazzjoni tas-Suq Intern qed tistaġna.

### *Il-prezzijiet fl-UE mhux qegħdin jikkonverġu ...*

Meta l-kummerċ ikun faċli, il-kompetizzjoni li titnissel iżzomm il-prezzijiet ta' l-istess oġġetti qrib xulxin fl-UE kollha. Kien fl-oqsma ta' l-oġġetti fejn is-Suq Intern għamel il-kummerċ ferm aktar faċli – eż., hwejjeġ, żraben u alkohol – li l-prezzijiet qorbu l-aktar lejn xulxin<sup>3</sup>. B'mod ġenerali, inkluż fiż-żona ta' l-Euro, il-kontinwazzjoni ta' l-eżistenza ta' ostakli tfisser li l-prezzijiet ta' oġġetti simili għal xulxin fl-Istati Membri baqgħu persistentement differenti (ara l-graff 1).

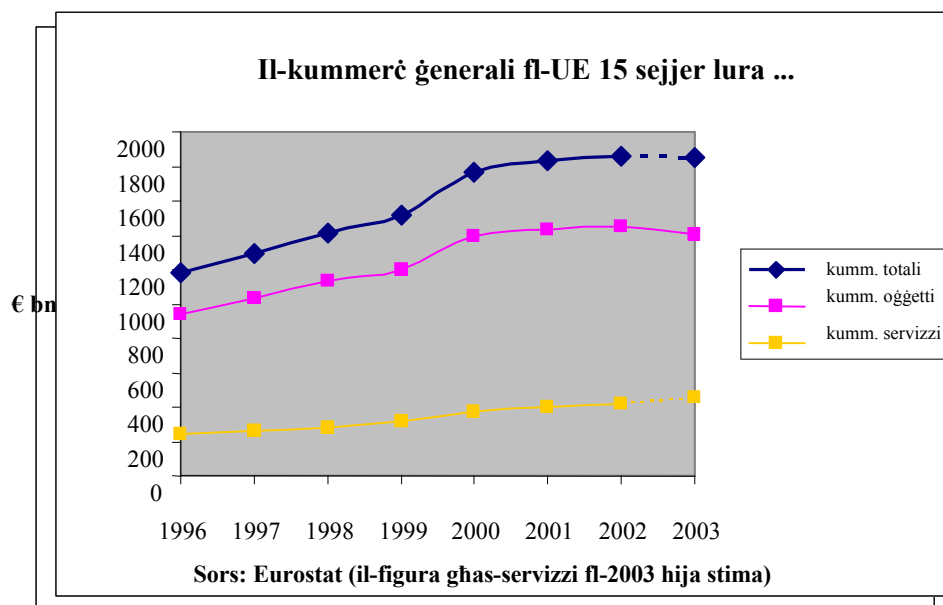

### *Il-kummerċ qed inaqqas ir-ritmu...*

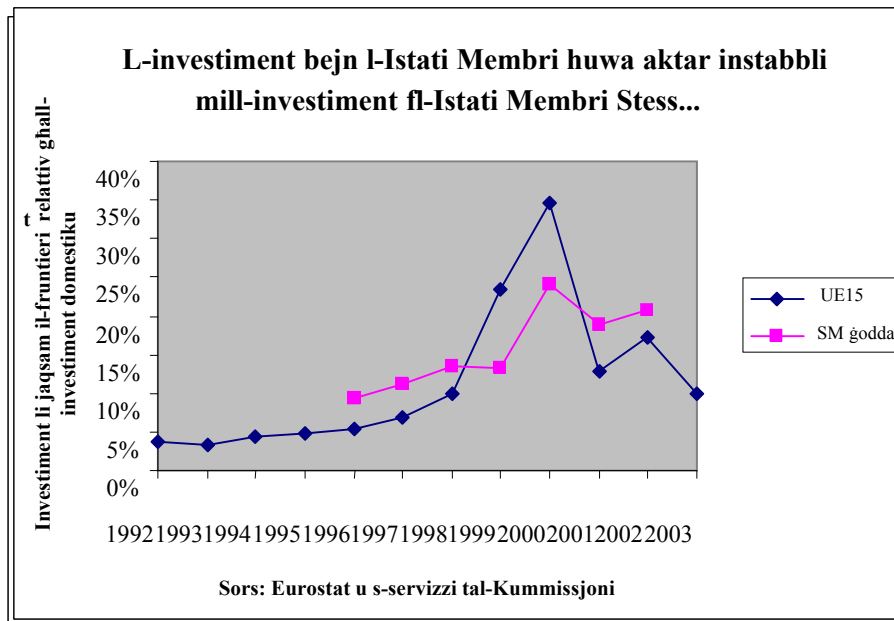
Il-kummerċ bejn l-Istati Membri f'oġġetti manifatturati baqa' staġnat mill-2000 'il hawn, u saħansitra waqa' fl-2003. Il-kummerċ fis-servizzi jidher li huwa aktar b'saħħtu (għalkemm it-tagħrif huwa disponibbli biss sa l-2002), iżda l-andament batut tal-kummerċ fl-oġġetti jiddomina l-figuri ġenerali tal-kummerċ – minħabba li l-kummerċ fis-servizzi jgħodd biss madwar 20% tal-valur tal-kummerċ ta' l-oġġetti. Ritmu mnaqqas ta' kummerċ ifisser inqas pressjoni kompetittiva fuq il-prezzijiet.

## U l-flussi ta' l-investment barrani huwa pjuttost instabbli...

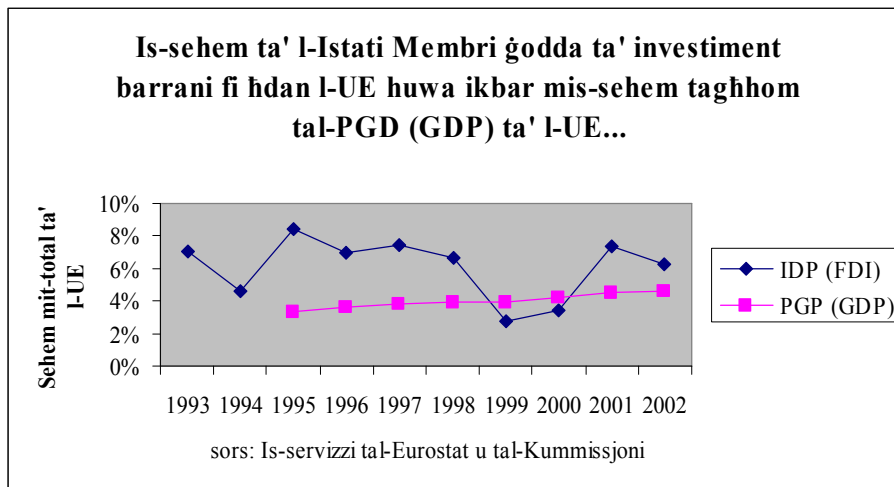
L-istudji jissuġġerixxu li l-investment barrani oġġla jwassal għal tkabbir oġġla fil-produttività f'dawk l-ekonomiji li jirċievu dan l-investment<sup>4</sup>. Iż-żieda fl-investment li jaqşam il-fruntieri ta' l-Istati Membri fl-UE kien mutur importanti għall-integrazzjoni tas-Suq Intern u matul dawn l-aħħar għaxar snin kiber b'rata sostanzjalment aktar mgħaġġla mill-investment domestiku. Fl-UE 15 il-valur totali tal-flussi ta' l-Investment Dirett Barrani (IDB) fis-sena 2000 kien tnax-il darba aktar minn dak ta' l-1992, iżda sa l-2003 dan waqa' għal 4 darbiet aktar mil-livell ta' l-1992 (li xorta hi figura rispettabbli).

Jista' jkun hemm diversi raġunijiet għall-instabbiltà fl-IDB f'dawn l-aħħar snin, inkluż it-tmiem tal-*boom* tal-kumpaniji "dot com" u t-traġedja tal-*ħdax* ta' Settembru. Minkejja dan, l-instabbiltà tal-flussi ta' l-IDB meta mqabbla ma' l-investment domestiku (ara l-graff 3) turi li l-integrazzjoni għad fadlilha mhux ħazin biex tintlaħaq u li l-investituri m'humiex qed iħarsu lejn l-investment fis-Suq Intern bl-istess mod kif iħarsu lejn l-investment fis-swieq domestiċi tagħhom.

Il-graff turi wkoll li l-influssi ta' l-investment barrani meta mqabbla ma' l-investment totali huma oġġla fl-Istati Membri l-ġodda milli kienu fl-EU 15 (barra mis-snin eċċezzjonali 1999 u 2000). L-Istati Membri l-ġodda rċevew ukoll sehem sporporzjonatament għoli mill-influssi ta' l-IDB minn parti għal oħra ta' l-UE (intra-UE) meta dawn jitqabblu mad-daqs ekonomiku tagħhom (ara l-graff hawn taht), għalkemm dawn bdew minn livell bazi ta' investment ferm aktar baxx. Dan jidher li jagħtina x'nifhmu li l-integrazzjoni tas-Suq Intern hija fattur importanti fl-iżvilupp ta' l-ekonomija tal-provvista fl-Istati Membri l-ġodda u l-aċċess minn dawn għas-Suq Intern ta' l-UE jista' jkun kalamita importanti għall-investment barrani.

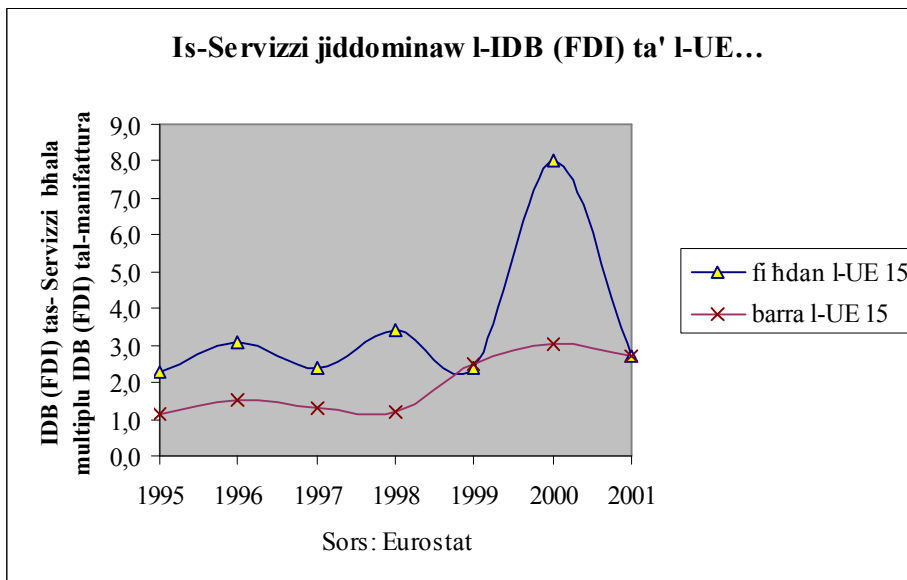

L-investiment barrani bejn l-Istati Membri ta' l-UE 15 huwa kkoncentrat fuq l-oqsma tas-servizzi. B'mod ġenerali, is-servizzi jirċievu tliet darbiet aktar investiment barrani milli tirċievi l-manifattura; fis-sena 2000, is-servizzi rċewew tmien darbiet aktar. L-intrapriżi ta' l-UE wkoll jippreferu s-servizzi milli l-manifattura fil-bqija tad-dinja, iżda inqas sew milli fl-UE (ara l-grafl 5).

## ***Din hija r-raġuni għaliex l-integrazzjoni tas-swieq tas-servizzi ta' l-UE hija daqstant importanti...***

L-investiment dirett barrani intra-UE huwa ddominat l-aktar mis-servizzi. Minhabba li s-servizzi jiddominaw ukoll l-ekonomija ta' l-UE, il-ġid li jista' johroġ mit-twahhid tas-swieq tas-servizzi ta' l-UE huwa tassew kbir. Dan jispjega għaliex Direttiva tas-Servizzi, li tista tillibera l-potenzjal sħiħ tas-settur tas-servizzi, inkluż billi tiffaċilita l-libertà ta' l-istabbiliment, hija daqstant importanti.<sup>5</sup>

Stharriġ reċenti<sup>6</sup> juri kemm jistgħu ikunu frammentati s-swieq tas-servizzi<sup>7</sup>: fil-kontabilità, per eżempju, ir-regolamenti nazzjonali jwasslu biex ditta ta' Stat Membru, li tkun qed tfittex li tagħmel negozju fi Stat Membru ieħor, tiffaċċja, bħala medja, spejjeż tan-negozju li jkunu 23% oġhla minn dawk ta' kompetitur lokali. It-tnehhija ta' dawn l-ostakli jista' jwassal biex titkattar l-produttività, u b'hekk jiżdiedu l-pagi fl-ekonomija ta' l-UE kollha b' medja ta' 0.4% u l-impjeggi b'0.3%<sup>8</sup>. Stharriġ ieħor<sup>9</sup> juri li l-kummerċ ta' l-UE jista' jiżdied bejn 15 u 30% kieku s-swieq tas-servizzi kellhom ikunu integrati, waqt li l-volum ta' l-investiment barrani fis-servizzi jista' jiżdied bejn 20 u 35%. In-nuqqas ta' kompetizzjoni fis-settur tas-servizzi finanzjarji jwassal biex ibatu l-konsumaturi permezz ta' prezzijiet oġhla, u inqas aċċess għall-kreditu. Huwa stmat li qabel is-sena 2000 l-ostakli għad-ditti barranin fis-settur bankarju għollew il-prezzijiet b'madwar 5.3%. L-integrazzjoni tas-servizzi finanzjarji jista' jwassal biex il-PGD ta' l-UE jiżdied b'madwar 130 biljun Euro (fl-2002) waqt li l-investiment kummerċjali jiżdied b'6.0%.

### ***Kif hi wkoll li tingheleb l-inċertezza legali ...***

Fl-oqsma fejn m'hemmx leġislazzjoni speċifika ta' l-UE, u fejn għalhekk jista' japplika l-prinċipju ta' l-għarfien reċiproku<sup>10</sup>, la l-produtturi u lanqas l-awtoritajiet tas-sorveljanza tas-suq m'huma ċerti sa fejn prodotti minn Stat Membru wieħed jistgħu jidhlu fis-suq ta' Stat Membru ieħor mingħajr ma ssir l-ebda modifika fuqhom; skond il-Grupp ta' Konsultazzjoni tan-Negozju Ewropew, 53% tan-negozji lanqas biss huma familjari mal-prinċipju. Fi stharriġ reċenti, madwar 80% ta' dawk li wieġbu<sup>11</sup> kienu jaħsbu li d-diffikultajiet regolatorji huma l-problema ewlenija biex isir in-negozju fis-Suq Intern.

L-impatt ta' din l-inċertezza fuq l-ekonomija huwa wieħed apprezzabbi: huwa stmat li fis-sena 2000 in-nuqqas ta' applikazzjoni tal-prinċipju ta' l-għarfien reċiproku naqqas il-kummerċ ta' l-oġġetti fis-Suq Intern b'sa 10% jew b'madwar 150 biljun Euro<sup>12</sup>. Għalhekk, l-għazla tal-

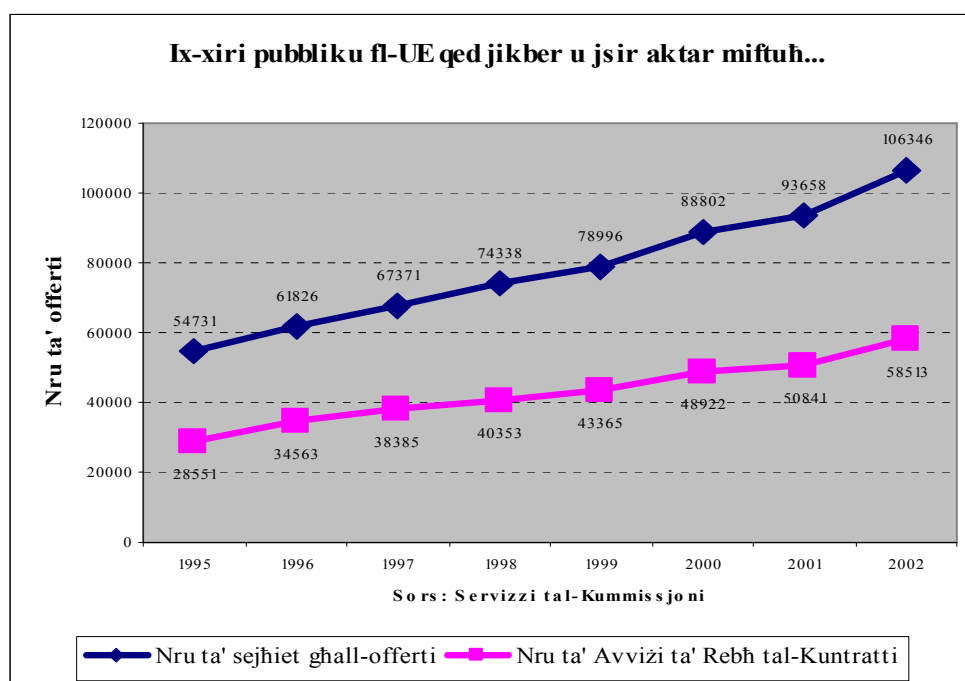

konsumatur tiġi limitata u huma jiġu obbligati jhallsu aktar għaliex m'hux qed tiġi sfruttata s-sahha shiha tal-kompetizzjoni.

### *U li tinghata attenzjoni għas-swieq Ewropej tax-xiri pubbliku...*

Fl-2002 is-suq kollu tax-xiri pubbliku ta' l-UE kien jiswa 1.5 triljun Euro jew ftit aktar minn 16% tal-GDP. Tradizzjonalment, l-Istati Membri taw vantaġġ lill-kumpaniji lokali, iżda dan is-suq vast qed jinfetah: in-numru ta' sejhiet pubbliċi għall-offerti li ġew ippubblikati fil-Ġurnal Uffiċjali, bħala proporzjon tal-valur totali tax-xiri pubbliku, kiber sew iżda għadu jlahhaq biss għal madwar 16% tal-valur totali tax-xiri pubbliku.

Huwa essenzjali għall-ekonomija li jitwessgħu ir-regoli tax-xiri pubbliku tas-Suq Intern. L-awtoritajiet pubbliċi li għamlu xiri permezz tar-regoli tax-xiri pubbliku hallsu prezzijiet ta' madwar 34% inqas minn dawk l-awtoritajiet li ma użawx dawn ir-regoli<sup>13</sup>. L-Italja tistma li fl-2003 diġà ffrankat €3.7 biljun minn total ta' €23 biljun f'xiri. L-Irlanda tistma li tista' tiffranka madwar biljun Euro matul il-5 snin li ġejjin mix-xiri b'mezzi elettronici biss.

Sistema ta' xiri pubbliku aktar miftuħa tista' żżid il-kummerċ, il-produttività u t-tkabbir ekonomiku. Hi tgħin ukoll biex jissahħu l-finanzi makroekonomici; li jkun iffrankat 10% biss tan-nefqa kurrenti għax-xiri pubbliku jista' jwassel biex il-15-il Stat Membru ta' l-UE ta' qabel Mejju 2004 jingiebu taht il-limitu ta' l-izbilanċ fiskali stabbilit mill-Patt ta' l-Istabbiltà u t-Tkabbir Ekonomiku.

## PARTI C: L-ISTAT TA' L-IMPLIMENTAZZJONI TA' L-ISTRATEĠIJA

L-integrazzjoni tas-suq intern setgħet waqfet temporanjament, iżda l-espansjoni tas-suq intern għall-għaxar Stati Membri l-godda minn Mejju 'l hawn kienet relattivament bla problemi. L-integrazzjoni tas-suq fl-UE 25 se toffri opportunitajiet biex ikun hemm stimolu ekonomiku gdid. Kif indika r-Rapport ta' Implimentazzjoni tas-sena l-oħra<sup>14</sup>, għad hemm spazju biex fil-futur qrib sa dak fuq tul medju ikun hemm zieda sostanzjali kemm fil-kummerç kif ukoll fl-investment bejn l-UE15 u l-UE10. Għalhekk, hemm raġuni għaliex wieħed għandu jkun ottimist dwar il-kontribuzzjoni li s-Suq Intern se jkompli jagħti għall-kompetittività ta' l-Ewropa.

Barra mill-effetti pożittivi ta' suq intern akbar, matul dawn l-aħħar snin ġew adottati diversi miżuri f'oqsma bħalma huma s-servizzi finanzjarji, l-industriji tan-network jew il-liġi tal-kumpaniji, li huma mistennija jibdeu jagħtu riżultati pożittivi fil-prattika.

Huwa fatt inkuragganti li żewġ terzi tal-miżuri previsiti sehhew digà sa tmiem l-2004 (ara l-eżempji fit-tabella 1), għalkemm hafna minn dawn huma proposti tal-Kummissjoni, li biex jgħinu fit-tkabbir u l-kompetittività xorta għad trid tittiehed deċizzjoni dwarhom fil-Kunsill u l-Parlament u għad iridu jiġu implimentati b'mod effettiv mill-Istati Membri. ## **PARTI D: KONKLUŻJONI – IN-NUQQASIJET LI JIBQA' F'OQSMA TA' PRIJORITÀ EWLENJA**

Meta ssir analiżi tas-sitwazzjoni preżenti ta' l-implimentazzjoni din tindika il-htieġa li jkun hemm attenzjoni akbar fuq numru ta' temi ewlenin fil-perijodu li għad fadal mill-Istrateġija tas-Suq Intern:

### **1. Li nlestu l-qafas legali**

Waqt li l-biċċa l-kbira tal-qafas legali tas-Suq Intern diġà jinsab f'postu, għad hemm vojt kbir f'ċerti oqsma ekonomiċi ewlenin. Fil-qasam ta' l-oġġetti, jispikkaw ir-reviżjoni tas-Sistema l-Ġdida kif ukoll il-possibbiltà li jkun hemm regolament dwar l-applikazzjoni tal-prinċipju ta' l-għarfien reċiproku. Proposti importanti għall-azzjoni, bħalma hija d-Direttiva tas-Servizzi, diġà qed ikunu diskussi fil-Kunsill u l-Parlament u jridu jiġu adottati u implimentati mill-aktar fis. L-istess jgħodd għall-Privattiva tal-Komunità u l-invenzjonijiet implimentati bil-kompjuter kif ukoll għall-miżuri li baqa' tal-FSAP.

### **2. Li niehdu hsieb aktar tal-qafas eżistenti**

Li jkun hemm qbil dwar regoli fuq livell Ewropew huwa biss il-bidu. Biex ikun hemm tassew l-effetti mixtieqa, dawn iridu jkunu implimentati fil-hin u jkunu infurzati b'mod effettiv f'kull wieħed mill-ħamsa u għoxrin Stat Membru. Huma l-Istati Membri stess li għandhom rwol kruċjali għat-tħaddim ta' kuljum tas-Suq Intern. B'mod speċjali, dan jinvolvi li jkun hemm aktar kooperazzjoni bejniethom u mal-Kummissjoni, u li jkun hemm skambju ta' informazzjoni, għajjnuna reċiproka u soluzzjoni ta' problemi. Dawn l-iskambji jeħtieġu li jkunu ffacilitati b'sistemi moderni ta' informazzjoni, bħalma huma dawk li fuqhom hi mibnija n-network SOLVIT. Minbarra dan, l-aħjar użu jrid isir min-networks ta' l-intrapriżi, inklużi dawk għall-intrapriżi ta' daqs żgħir jew medju, bħan-network taċ-Ċentri Ewropej għall-Infurmazzjoni (CEI).

### **3. Li niżguraw koerenza u sinerġija akbar ma' strateġiji ohra tal-Komunità**

L-istrateġiji tas-Suq Intern ma joperawx barra mill-kuntest tagħhom. Huma jeħtieġu li jkunu marbuta ma' għanijiet strateġiċi importanti ohra, kull fejn ikun possibbli, biex b'hekk jinstabu sinerġiji. Il-prijoritajiet immedjati huma r-rabtiet mal-politika dwar il-konsumatur, dwar il-kompetizzjoni u dwar l-ambjent. Sinerġiji ma' oqsma ohrajn, bħall-politika reġjonali u agrikola, huma wkoll importanti. Mill-effetti tal-kompetizzjoni ta' Suq Intern li jaħdem b'mod effiċjenti jgawdu l-konsumaturi fl-għamla ta' għażla aktar wiesgħa u prezzijiet aktar kompetittivi. Min-naħa tagħha, l-importanza ta' dimensjoni b'saħħitha tal-konsumatur f'Suq Intern li jiffunzjona tajjeb giet rikonoxxuta mill-Kunsill Ewropew<sup>23</sup> u hija ta' prijorità għall-istituzzjonijiet kollha tal-Komunità. Il-konsumaturi jridu jkunu kunfidenti wkoll li l-prodotti jkunu tajbin u li d-drittijiet tagħhom ikunu mħarsa sew. Għalhekk, għandhom jitfasslu miżuri b'tali mod li jkunu ppreżervati l-effetti ta' stimolu għall-kompetizzjoni li jgħib il-moviment hieles li fuqu jiddependu l-benefiċċji ekonomiċi għall-konsumaturi,

waqt li jharsu lil dawn ta' l-ahħar minn riskji għas-saħħa u s-sigurtà u kif ukoll minn riskji oħra. Barra minn hekk, il-politika ambjentali, flimkien mal-moviment ħieles, tista' tipprowdi opportunitajiet għall-innovazzjoni u għal kompetittività akbar billi jkun hemm effiċjenza aħjar fl-użu tar-rizorsi u opportunitajiet godda ta' investment.

#### **4. Li niżguraw li l-qafas legali tas-Suq Intern ikun aktar konformi mal-qafas ekonomiku globali**

Fl-ekonomija ferm globalizzata ta' llum, l-impatt ta' leġislazzjoni adottata eluf ta' mili 'l bogħod qed jinħass dejjem aktar fl-UE u viċeversa. Fejn il-kumpaniji joperaw iżjed globalment, per eżempju fil-qasam tal-finanzi, ir-regolazzjoni ma jistax tibqa' lura. Għalhekk, l-istrategija ssejjah għal tishih tad-djalogu ma' l-imsieħba kummerċjali l-kbar. L-għan tad-djalogu huwa li naslu għal leġislazzjoni effettiva li ssaħħaħ il-ftuħ tas-suq u li tnaqqas il-piż regolatorju għan-negozji li jieħdu sehem fis-swieq tad-dinja. Għalhekk, dan id-djalogu għandu jiffavorixxi l-konverġenza regolatorja u jnaqqas id-diverġenza jew il-kunflitt regolatorju. Il-ġid li wieħed jistenna minn kooperazzjoni effettiva jista' jkun kbir kemm f'termini ta' impjegi kif ukoll f'termini ta' tkabbir ekonomiku.

## ANNEX 1: IMPLEMENTATION REPORT SCOREBOARD

### 1. Transposition by Member States of Internal Market rules into national law

Member States persistently fail to transpose Internal Market rules correctly and on time. The transposition deficit<sup>24</sup> for the EU has got significantly worse and now stands at 3.6%. This is a long way from the 1.5% interim target set by successive European Councils. And the real target is, of course, 0% because timely and correct transposition is a legal obligation.

The deficit for the EU 15 Member States<sup>25</sup> is 2.9%, which represents a very significant step backwards after their progress in reducing the deficit since the Lisbon summit in 2000. When all 25 Member States are included in the calculation, the deficit rises to 3.6% - too high, but still considerably better than the 7.1% deficit at enlargement thanks to the sustained notification efforts of the new Member States. Concretely, this means that the Commission is still awaiting 1428 notifications of national implementing measures.

Of all Internal Market directives, over a quarter (27% or 427 directives) have not been fully transposed in at least one Member State<sup>26</sup>. This figure is much higher than before – and its rise is in large part due to enlargement, as many of the directives still to be transposed by each of the EU 10 Member States<sup>27</sup> are not the same.

Member States' failure is not only a breach of their legal obligations - it also deprives businesses and citizens in practice of their rights and undermines the day-to-day working of the Internal Market.

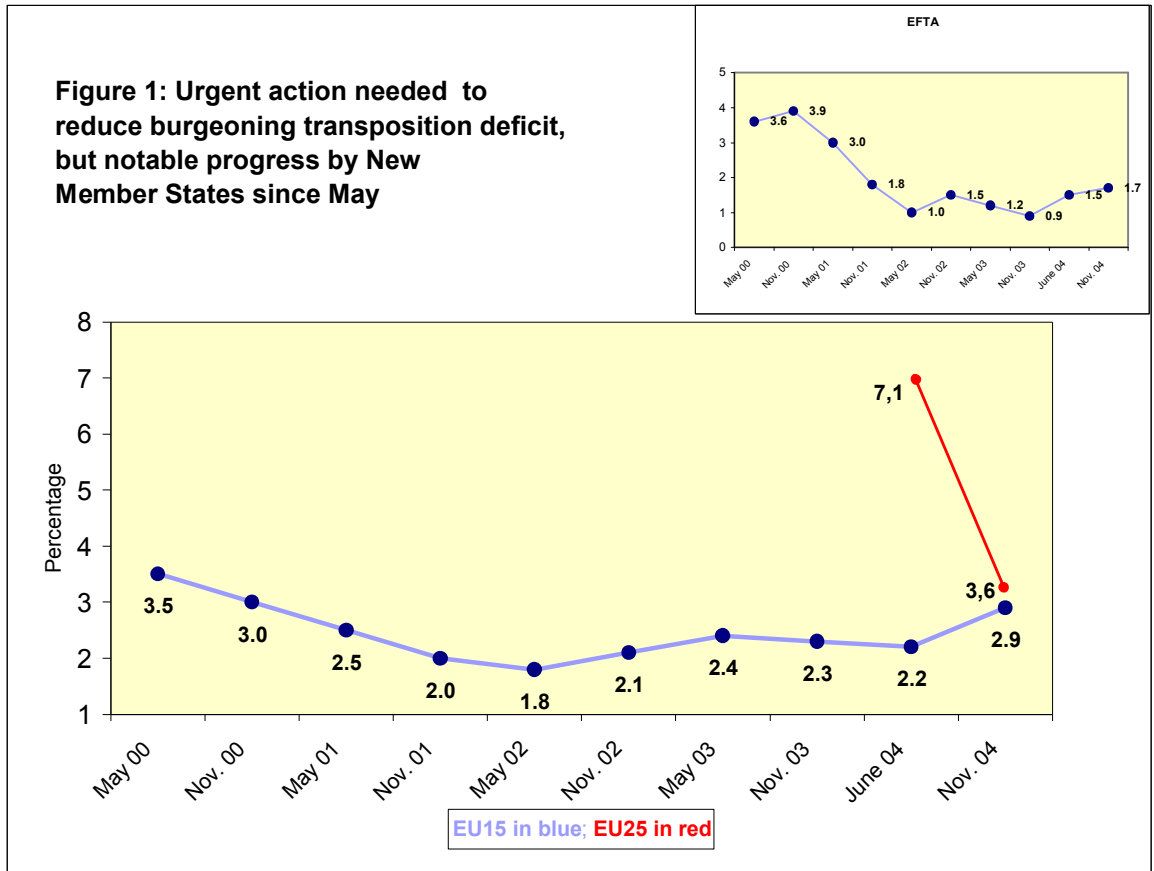

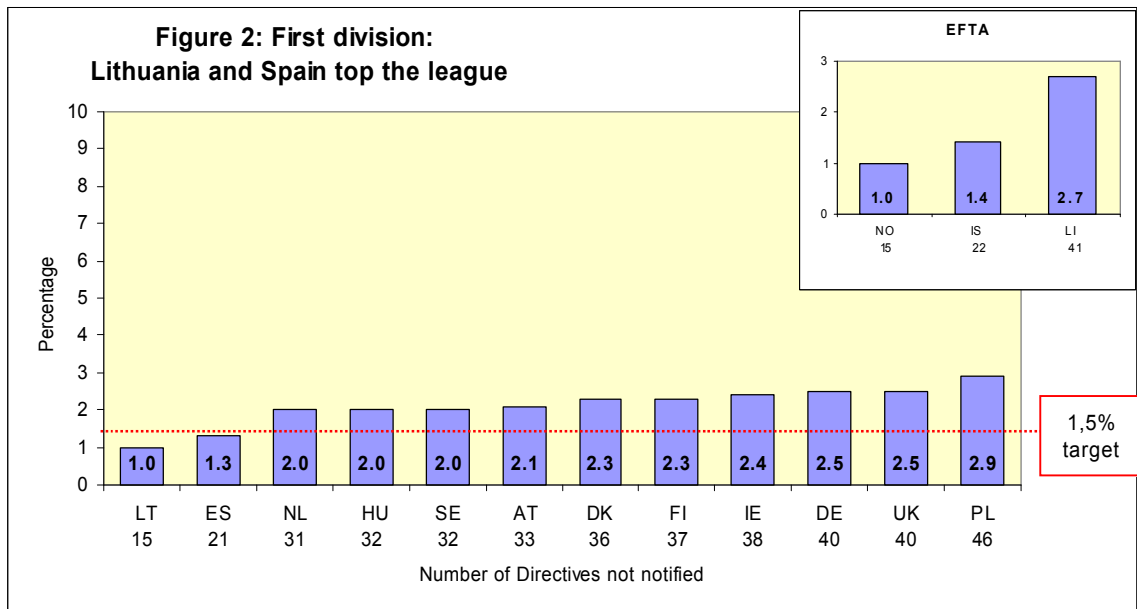

The transposition deficits for the EU 10 Member States are still to a certain extent provisional, as part of the national implementing measures are still under verification by the Commission. Wherever there has been a notification, the Commission deems this to reflect a full transposition unless it establishes after analysis that this is not the case. This means that the transposition deficits in reality could be higher.

Of those countries in the First Division:

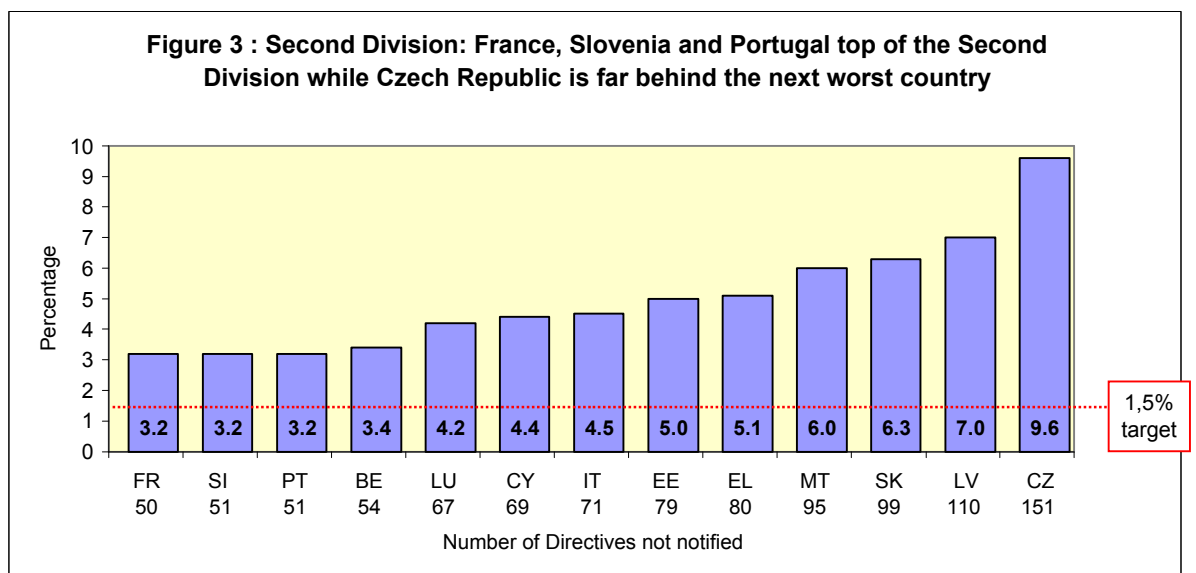
- Lithuania and Spain are to be commended for being the only Member States to have met the 1.5% interim target set by the European Council.
- The Netherlands has improved on its recent disappointing record.
- Hungary has made impressive progress in reducing its transposition deficit and is now in fourth place.
- Germany has made major strides in reducing its transposition deficit, but there is further to go.
- Despite being in the First Division, the transposition deficits of the other Member States have got worse. The performances of Denmark, Finland, the UK and Ireland are particularly disappointing, as they have all regularly met the 1.5% interim target in the past.



*Transposition deficit, by Member State, as at 30 November 2004*

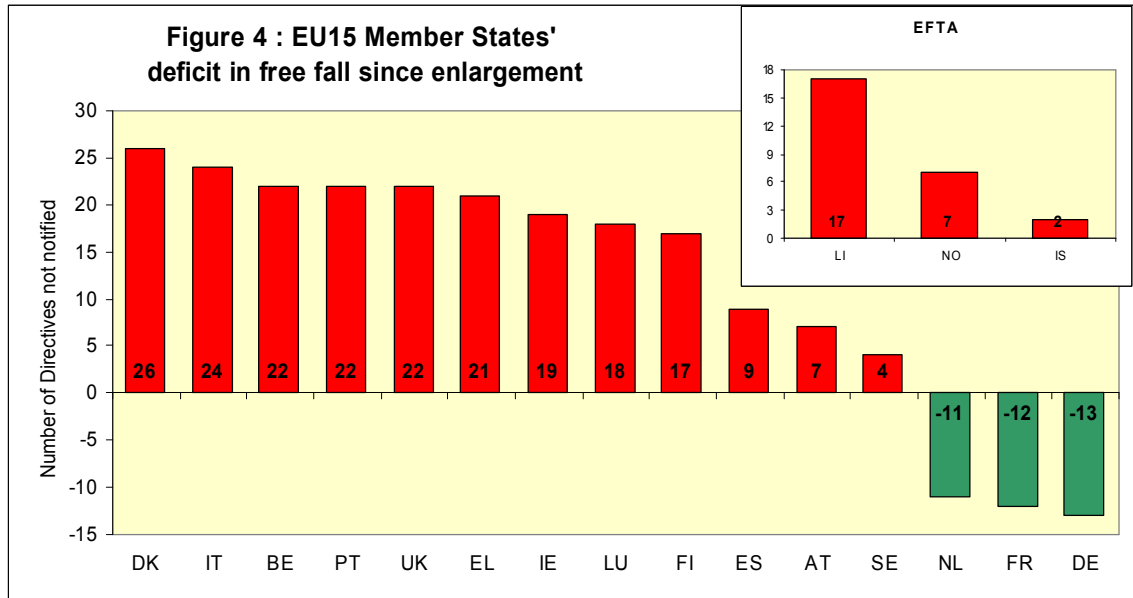
The transposition deficit of countries in the Second Division is more than double the 1.5% European Council target. Of these countries:

- All EU 10 Member States in the Second Division have reduced their deficit since EU accession.
- The Czech Republic is bottom of the league, and still has to transpose over 150 directives. However it can be expected that its performance will improve soon. The efforts of France to reduce its deficit are beginning to bear fruit.
- Belgium, Luxembourg, Italy and Greece have all gone into reverse gear, recording their worst transposition deficits for many years.



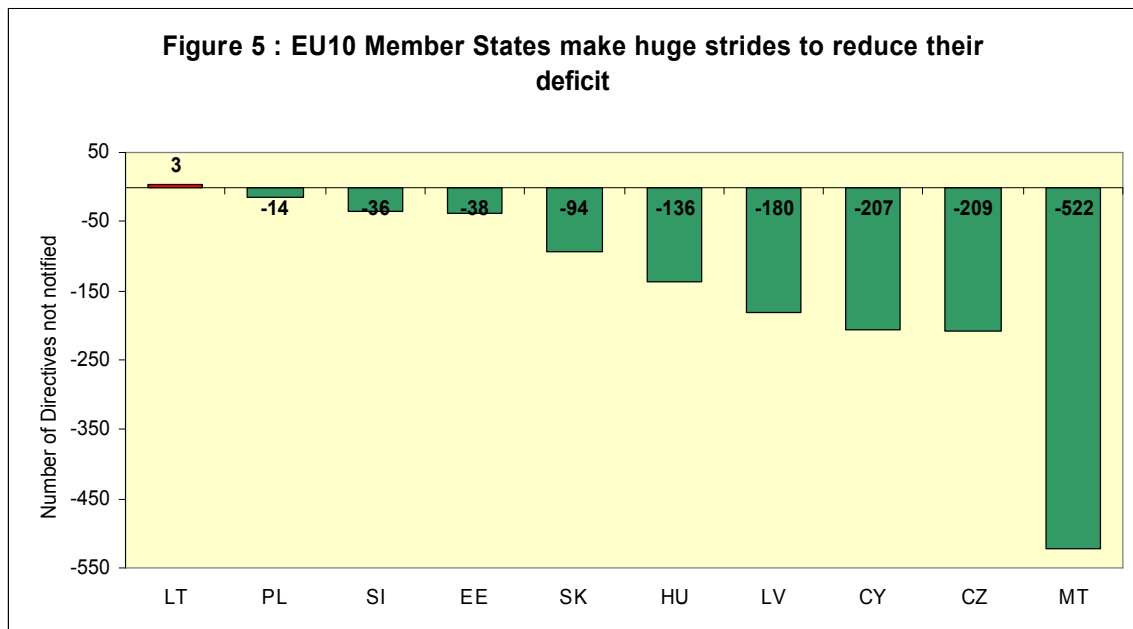
*Transposition deficit, by Member State, as at 30 November 2004*

What is striking is that the performance of almost all EU 15 Member States has deteriorated significantly since enlargement. Only Germany, France and the Netherlands have reduced their deficits since then.



Change in the number of outstanding directives, by Member State, since May 2004. For example, Denmark's backlog has increased by 26 directives, while Germany has reduced its backlog by 13 directives.

What is equally striking is that the EU 10 Member States have significantly reduced their deficits since their EU accession. Many now have better records than EU-15 Member States.

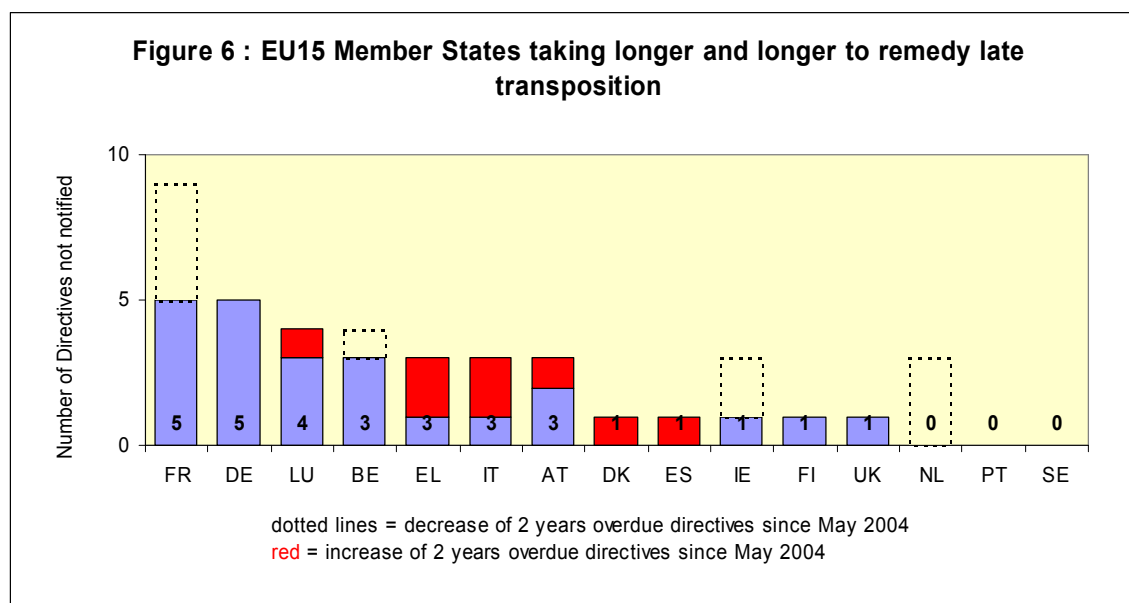


Change in the number of outstanding directives, by Member State, since May 2004. For example, Malta has reduced its huge backlog by 522 directives.

Ensuring that delays in transposing Internal Market directives do not go on indefinitely is also important. This is why the European Council set a 'zero

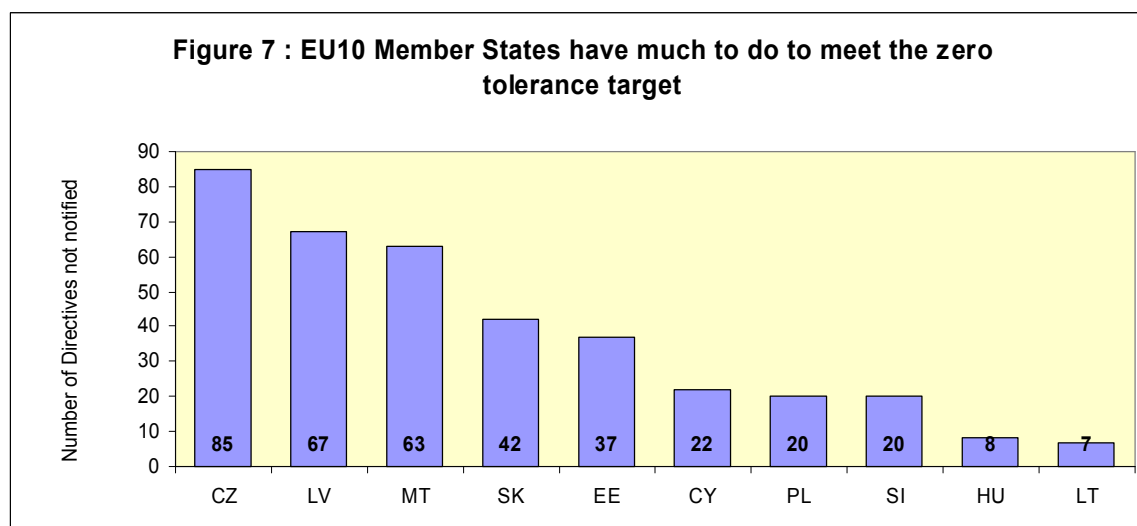
tolerance' target for directives whose implementation is over two years late. Of the EU 15 Member States:

- Only Sweden, Portugal and the Netherlands met this target and they deserve credit for doing so.
- France almost halved the number of directives whose transposition is over 2 years late, but is still in last place (with Germany).
- The records of Luxembourg, Greece, Italy, Austria, Denmark and Spain all deteriorated.

The fact that EU 10 Member States only joined the EU in May 2004 should not preclude the application of this 'zero tolerance' target to them. The number of directives that they need to transpose to meet this target is set out below.



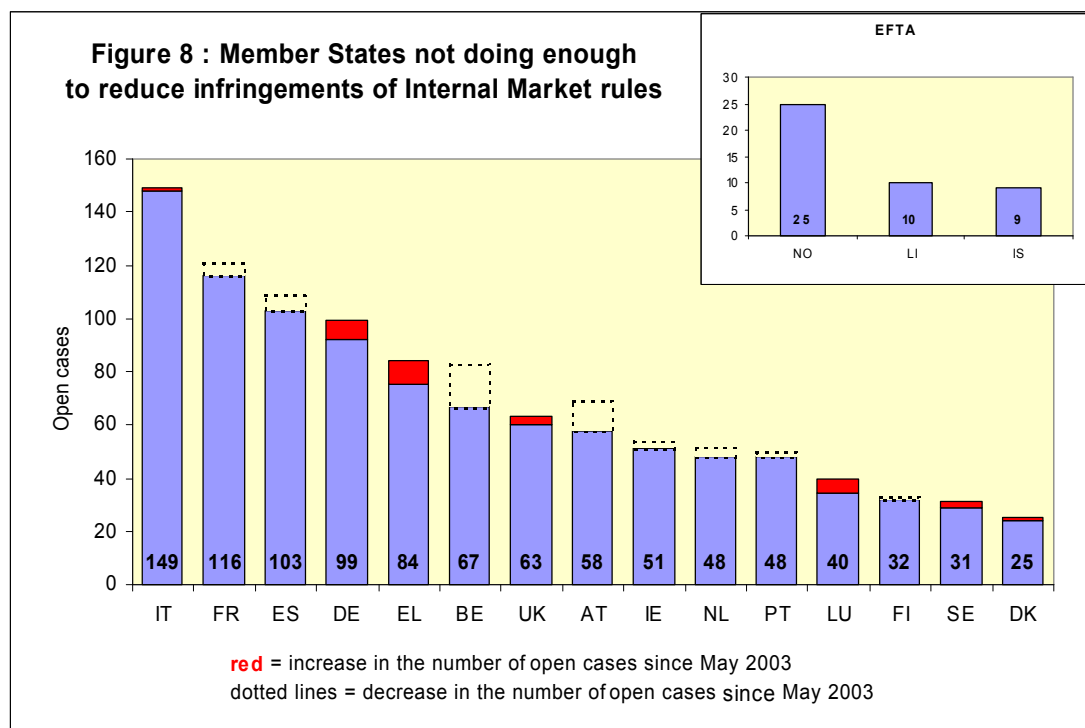
*Number of directives to be transposed to meet the 'zero tolerance' target.*

## 2. Application by Member States of Internal Market rules: infringements<sup>28</sup>

For the Internal Market to work, Member States must apply the rules correctly. Where they do not do so, they deprive businesses and citizens of their rights and undermine confidence in the Internal Market. This is why the Internal Market Strategy 2003-2006 called for a 50% reduction in infringements by 2006 through a combination of better compliance, prevention and use of alternative methods of problem-resolution (such as SOLVIT).

France, Spain, Belgium, Austria, Ireland, the Netherlands, Portugal and Finland have all made progress towards meeting this goal, but much more needs to be done.

Regrettably, other Member States have not followed their good example. The position of Italy, already the country with the most infringement procedures against it, has got worse since the objective of a 50% reduction was set. Greece, the UK, Luxembourg, Sweden and Denmark have also all seen the number of infringements against them increase.
