Dear Secretary General,

The Swedish government decided on 12 November 2015 to temporarily reintroduce border control at the Swedish internal borders between 12 November and 21 November. Other measures had, after detailed consideration, been deemed insufficient. The Swedish government decided on 19 November to prolong the border control at the internal borders for the period to 11 December. On 10 December, the border control was prolonged until 20 December and on 18 December the Swedish government decided to prolong the reintroduced border control until 9 January 2016. On 7 January 2016 the Swedish government decided to prolong the border control at the internal borders until 8 February 2016. Today, the Swedish government has decided to prolong the border control until 9 March 2016.

The decision to prolong the border control was made due to the remaining serious threat to public policy and internal security posed by the consequences of the unprecedented migratory pressure and the ensuing significant challenges to the functioning of the Swedish society.

In its most recent situational pictures, the Swedish Civil Contingencies Agency states that there are challenges for a range of important services in Swedish society and that the strained situation is likely to remain so for some time. The influx of asylum applicants in Sweden has decreased, but still remains high, especially for this time of the year. During the period from 27 January 2016 to 2 February 2016, the Swedish Migration Agency registered almost 700 asylum applications. Although the number of new asylum seekers has decreased, the effects from the unprecedented migratory pressure in the latter part of 2015 combined with the current influx, still makes the situation very challenging for many of the important services in Sweden.



The border control may extend to all internal borders, including land, sea and air borders, whereby the specific border sections and border crossing points are determined by the Swedish Police Authority. For now, the controls will remain focused on the regions mentioned in my letter to You of 12 November 2015. The scope of the control will remain limited to what is strictly necessary to respond to the threat to public policy and internal security and constantly adapted to the relevant circumstances.

Today's decision to prolong the border control was made in accordance with articles 23 and 24 of the Regulation (EC) no 562/2006 of the European Parliament and of the Council establishing a Community Code on the rules governing the movement of persons across borders (Schengen Borders Code).

I would be grateful for Your support for this necessary measure.
