## Mandate

## Action 11.11 Trafficking of cocaine in maritime consignments

Reference:	11.11
Objective:	Improvement of customs capacities to prevent illicit trafficking of cocaine in maritime consignments. Due to the high impact on maritime containers, this action will focus on them.
Rationale:	Cocaine trafficking has been identified in the EU SOCTA 2021 and the LEWP-C Situational Awareness Paper (10363/1/21 ENFOCUSTOM 105 REV 1) as one of the main threats to the EU.  This action is in line with the EU Drugs Strategy 2021-2025, which was adopted by the Council in December 2020 <sup>1</sup> .
	Action 11.11 on cocaine trafficking is directly linked to:  - public health concerns  - security issues  - the structuring of criminal organisations and their financial gains from trafficking.
Focus:	<ul> <li>This action will be carried out by experts' meetings in which:</li> <li>the situation will be reviewed, in order to identify the main threats, trends, modi operandi and best practices;</li> <li>experts will share the tools which Member States have at their disposal to tackle cocaine maritime consignments;</li> <li>an exchange of current control practices and difficulties encountered will take place;</li> <li>the activities will be finalised with a joint operation in coordination with EMPACT OAP Cocaine, Cannabis, Heroin (CCH).</li> </ul>
