**COMMENT ACCOMPANYING  
THE COUNCIL RECOMMENDATION ON THE DISCHARGE TO BE GIVEN TO THE

The Council welcomes the Court's opinion that, in all material respects, the Agency's annual accounts present fairly its financial position as at 31 December 2020 and the results of its operations, its cash flows, and the changes in net assets for the year then ended, in accordance with the provisions of the Agency's Financial Regulation, and that the underlying transactions for 2020 are legal and regular in all material respects. Nevertheless, one observation needs to be made.

The Council takes note with concern of the Court's finding related to the slow selection process for management posts in the Authority, which resulted in some positions being filled by acting managers for more than one year, up to nine years in one case. While taking into account the impact of the COVID-19 pandemic on the Authority's Strategy Design and Organisational Design Project deliverables, as noted by the Court, the Council encourages it to speed-up the roll-out of its project of organisational design in order to end this situation of precarity at management level in the shortest time possible.

The Council welcomes the Court's opinion that, in all material respects, the Centre's annual accounts present fairly its financial position as at 31 December 2020 and the results of its operations, its cash flows, and the changes in net assets for the year then ended, in accordance with the provisions of the Centre's Financial Regulation, and that the underlying transactions for 2020 are legal and regular in all material respects. Nevertheless, some observations need to be made.

The Council takes note of the Court's observations on the Centre's legality and regularity of transactions regarding a procurement procedure for the provision of web services and welcomes the fact that the Centre cancelled the contract following those observations.

The Council regrets the issues identified by the Court concerning the Centre's budgetary management, whereby the calculation of European Free Trade Association (EFTA) contributions was not applied correctly in three different aspects, leading to an underpayment of EUR 20 272 from the Union budget. While acknowledging the Centre's action, the Council calls on the Centre to ensure that the calculation of EFTA contributions is correct in all circumstances.

The Council welcomes the Court's opinion that, in all material respects, the Agency's annual accounts present fairly its financial position as at 31 December 2020 and the results of its operations, its cash flows, and the changes in net assets for the year then ended, in accordance with the provisions of the Agency's Financial Regulation, and that the underlying transactions for 2020 are legal and regular in all material respects. Nevertheless, some observations need to be made.

The Council regrets the issues identified as "an emphasis of matter" in the Court's report with regard to the Agency's liabilities related to its former offices in London, while acknowledging the Agency's agreement with the landlord of those premises, as well as the efforts made by the Agency and its Management Board to address the need to solve the issue at political level.

The Council invites the Agency to promptly remedy the weakness found by the Court in the process for appointing selection panels, in order to avoid it as a current practice which may lead to legal and reputational risks for the Agency.

In relation to a revision of some prices related to a catering and restaurants services framework contract, the Council regrets that the Agency contravened to provisions of framework contract and of the Financial Regulation, and it urges the Agency to fully respect those provisions in the future.

The Council welcomes the Court's opinion that, in all material respects, the Agency's annual accounts present fairly its financial position as at 31 December 2020 and the results of its operations, its cash flows, and the changes in net assets for the year then ended, in accordance with the provisions of the Agency's Financial Regulation, and that the underlying transactions for 2020 are legal and regular in all material respects. Nevertheless, some observations need to be made.

While acknowledging the Agency's efforts to continue improving the monitoring of return operations/activities, the Council regrets the Court's observation that in one case the Agency made an *ex-post* budgetary commitment, which contravened the principle of annuality, and calls on the Agency to comply rigorously with budgetary rules.

The Council is very concerned about the reported cases of alleged fundamental rights violations and therefore welcomes the commitment of the Agency to cooperate closely with the European Parliament, the European Ombudsman and the European Anti-Fraud Office on fundamental rights matters. Furthermore, while taking into account the impact of the COVID-19 pandemic, as noted by the Court, the Council shares the Court's view that the delayed recruitment of 40 fundamental rights monitors poses a serious risk to the operations and reputation of the Agency, and urges the Agency to complete the recruitment procedures in the shortest possible time.

The Council regrets that the Agency was exposed to a risk of reputational damage, related to weaknesses in the management of grades of new staff members, and encourages the Agency to comply with the establishment plan following the adoption of the Agency's new Regulation<sup>1</sup>, as well as to increase the transparency and effectiveness of the internal control system.

**AGENCY FOR THE COOPERATION OF ENERGY REGULATORS**

The Council welcomes the Court's opinion that, in all material respects, the Agency's annual accounts present fairly its financial position as at 31 December 2020 and the results of its operations, its cash flows, and the changes in net assets for the year then ended, in accordance with the provisions of the Agency's Financial Regulation, and that the underlying transactions for 2020 are legal and regular in all material respects. Nevertheless, some observations need to be made.

While acknowledging that payments underlying the accounts for the year ended on 31 December 2020 are legal and regular in all material respects, the Council regrets that there were sufficient grounds for the Court to issue a qualified opinion on the legality and regularity of the payments, due to irregularities related to a framework contract for IT services, because of the absence of competitive procurement procedure to make a substantial amount of payments in 2020.

The Council regrets the internal control weaknesses, due to the lack of internal rules to address the continuity of delegations of authorising powers, identified by the Court. It invites the Agency to foster improving internal decisions and mitigating measures, already introduced, to avoid similar risks in the future.

While acknowledging the Agency's reply that a shortfall in budget resources was only covered through an amending budget in December and that a high level of carry-overs was required to cover open obligations identified at the end of the year, particularly legal and translation fees, the Council encourages the Agency to continue improving its budget planning and monitoring its budget implementation in order to reduce the level of commitments carried over to the strict minimum, in line with the budgetary principle of annuality.

The Council acknowledges the Agency's reply to the Court's observations about some weaknesses identified in the Agency's recruitment procedures. The Council notes with satisfaction the measures already taken by the Agency to remedy the errors notably by introducing preliminary eligibility checks, evaluation by a selection committee, double checks by the Human Resource, and transparency of the scoring methodology. It encourages the Agency to guarantee proper implementation of those measure with the aim to ensure a fair and transparent recruitment process.

The Council welcomes the Court's opinion that, in all material respects, the Authority's annual accounts present fairly its financial position as at 31 December 2020 and the results of its operations, its cash flows, and the changes in net assets for the year then ended, in accordance with the provisions of the Authority's Financial Regulation, and that the underlying transactions for 2020 are legal and regular in all material respects. Nevertheless, some observations need to be made.

The Council regrets the deficiencies identified by the Court in the Authority's public procurement procedures. First, the Authority concluded a short-term banking agreement with a bank but it underestimated the contract's value because the Authority launched a negotiated procedure without prior publication with only one potential contractor. For the same case, the Authority did not set out criteria for selecting the best offer nor carry out proper evaluation of other offers when it was needed to search other contractors. Secondly, the Authority launched a procurement procedure for legal services by using a negotiated procedure without prior publication of a contract notice and missing an adequate audit trail. A third procurement procedure was also deemed irregular because confidentiality and declaration of absence of conflict of interest were applied only at a latest stage. While taking into account the impact of the COVID-19 pandemic, as noted by the Authority, and the measures already taken, the Council calls on the Authority to ensure that its procurement procedures, especially the application of the negotiated procedure, are always fully in line with the Financial Regulation.

The Council supports the Court's findings on the need for the Authority to update its business continuity plan and urges the Authority to address this weakness in its internal control procedures.

The Council welcomes the Court's opinion that, in all material respects, the Authority's annual accounts present fairly its financial position as at 31 December 2020 and the results of its operations, its cash flows, and the changes in net assets for the year then ended, in accordance with the provisions of the Authority's Financial Regulation, and that the underlying transactions for 2020 are legal and regular in all material respects. Nevertheless, some observations need to be made.

The Council takes note of the Court's finding about the risk of circumvention of the credit rating agencies (CRA) regulation by the CRA, which can use the opportunity to reduce or avoid fees by transferring their revenues under EU jurisdiction to their related entities outside the EU. It welcomes the Authority's efforts to assess and monitor this issue, as well as the submission to the Commission of its technical advice on the revision of the Regulation with regard to the fees charged by the Authority to CRA.

The Council supports the Authority's efforts already made in the past to provide the maximum assurance possible within the current regulatory framework on fees to trade repositories. The Council welcomes the submission by the Authority to the Commission of its technical advice on the amendment of Trade Repositories' fee management legislation in the second half of 2021 and it invites the Commission to work on the revision of the legislative framework.

While acknowledging the Authority's replies, the Council regrets the internal control weaknesses identified by the Court. First, the Authority concluded a framework contract by using the contractor's Framework Contract template instead of the Authority's usual template, and this reduced the transparency of the agreement. Secondly, the Authority did not correctly apply the interest rate on the late payments made by a number of CRA and trade repositories in connection with their 2020 contributions and did not fully respect the provisions of the Financial Regulation. Thirdly, the Authority was not able to confirm the payments made to a contractor under a framework contract for IT consultancy services as it did not properly monitor the charged time.

The Council takes note of the Court's opinion on "other matter" whereby ongoing judicial proceedings against the Agency have a bearing on aspects of the Court's opinion.

The Council, while taking note of the ongoing and implemented corrective actions, notes the Court's observations on the legality and regularity of transactions, in particular on payments made in connection with procurement procedures declared irregular by the Court in previous years (i.e. procurement for rented premises, for interim workers in Italy and for external experts).

The Council, while taking note of the development of a comprehensive recruitment plan and the impact of the COVID-19 pandemic, regrets the issues identified by the Court concerning the Agency's staff policy, in particular the high number of vacant management posts and the length of temporary management appointments, which have an impact on the Agency's ability to deliver on its objectives.

Concerning budgetary management, while noting the impact of the COVID-19 pandemic, as noted by the Agency, the Council also expresses its concern that budget implementation was lower than planned, and calls on the Agency to continue improving its financial programming and monitoring of budget implementation, in order to ensure full compliance with the principle of sound financial management and annuality.

Finally, the Council welcomes the significant efforts made by the Agency since 2018 to improve its internal control systems and governance processes, and to implement corrective actions to respond to the Court's observations.

Having examined the revenue and expenditure accounts for the financial year 2020 and the balance sheet as at 31 December 2020 of the European Institute of Innovation and Technology, hereinafter referred to as the "Institute", as well as the Court of Auditors' report on the annual accounts of the Institute for the financial year 2020, accompanied by the Institute's replies to the Court's observations<sup>1</sup>,

Whereas the Council welcomes the fact that the observations in the Court of Auditors' report in relation to the financial year 2020 do not call for any comments,

Whereas, following the above examination, the implementation of the budget of the Institute is such as to allow a discharge to be given in respect of that implementation,

HEREBY RECOMMENDS to the European Parliament to give a discharge to the Director of the Institute in respect of the implementation of the budget for the financial year 2020.
