a) Methodology for the handling of ECA Special reports at the SCA

- Information from the Presidency

The SCA took note of the proposed methodology of the Presidency with regard to the possible examination by the SCA of certain aspects in ECA special reports and of the comments made by a number of delegations. Council conclusions will continue to be drafted and approved in accordance with the procedure set out in doc. 7515/00 + COR 1. SCA delegations will be informed about the publication of ECA special reports and in case delegations identify certain aspects in special reports, which go beyond the remit of AGRIFIN, e.g. as regards possible longer-term policy or CAP legislative implications, they should inform the Presidency accordingly. The Presidency will then assess whether or not the SCA should examine the identified aspects in these special reports. The views of the SCA on the special reports examined shall be reflected in the minutes of the SCA meeting.

b) Simplification of Marketing Standards

The SCA took note of the information from the CZ delegation who was supported by several delegations. In addition, the SCA took note of the explanations given by the Commission and comments provided by the delegations.

Proposal for a Council Regulation amending Regulation (EU) No 1370/2013 determining measures on fixing certain aids and refunds related to the common organisation of the markets in agricultural products
– Requested by the Cyprus delegation

The SCA took note of the request of the Cyprus delegation regarding the scope of the limitation of aid to the milk component, stating that there is no provision on maximum aid per portion for fresh milk and cheese and asking for clarification from the Commission in this respect, and of the clarification by the Commission representative agreeing with this delegation's statement and confirming that this limitation only applies to Annex V products.

The Presidency informed the SCA on the upcoming Council "Agriculture and Fisheries" meeting on 15 February 2016 as well as on the next SCA meeting on 7 March 2016.
