#### **OUTCOME OF PROCEEDINGS**

	- Election of the Chair

- In the meeting of the <u>Code of Conduct Group (business taxation) of</u>
   <u>1 February 2023</u>, the High-Level Representatives of the Member States
   proceeded to the selection of the new Chair of the Code of Conduct Group.
- 2. It is recalled that the two-year period for which Ms Lyudmila Petkova was appointed as Chair of the Code of Conduct Group expires on 4 February 2023. It was therefore necessary to appoint the Chair of the Code of Conduct Group for a two-year period starting on 5 February 2023.
- 3. At the meeting of the Code of Conduct Group of 1 February 2023, the General Secretariat of the Council informed the representatives of the Member States that two nominations for the Chair of the Code of Conduct Group were received:
  - Ms. María José Garde Garde, Spain; and
  - Ms. Lyudmila Petkova, Bulgaria.

- 4. The General Secretariat of the Council recalled that, in accordance with paragraph 5 of the Council conclusions of 9 March 1998 concerning the establishment of the Code of Conduct Group (business taxation) (OJ C 99, 1 April 1998, p. 1): "[...]the chairman will be appointed by common accord, but [...], if necessary, the chairman shall be elected by a majority of the high-level representatives of the Group".
  - The General Secretariat of the Council also recalled the procedural modalities set out in document WK 700/2023 and obtained confirmation that Member States raised no objection in relation to the selection process.
- 5. On the basis of this procedure, Ms M. J. Garde Garde was elected by a majority of the High-Level Representatives as Chair of the Code of Conduct Group for a period of two years starting on 5 February 2023.
