STATEMENT 1/01

"Member States undertake - as far as can be foreseen today - that from 1 January 2001 to 31 December 2005 they will make every effort to avoid widening the current span of 10 percentage points above the current lowest standard rate applied by Member States."

EXPLANATION OF THE FRENCH DELEGATION'S VOTE

"France cannot subscribe to the authorisation of butane, propane and iso-butane as propellant gases for vegetable oils put up in aerosol containers, because of the risk of fire involved in the intended use of that type of aerosol near sources of heat. Accordingly, France abstained when the common position was adopted."

STATEMENT 2/01

STATEMENT BY THE COMMISSION

Advances

"The Commission undertakes to examine the rules currently in force concerning the payment of the compensatory aid in order to improve the cash flow of Community producers, notably by modifying the system of advances set out in articles 4 to 7 of Commission Regulation (EEC) 1858/93 and by the systematic use of the bimestrial communication of data concerning the marketing of bananas."

STATEMENT 3/01

STATEMENT BY THE COMMISSION

Natural disasters

"The Commission will reflect on means to aid banana producers to overcome situations brought about through natural disasters in the context of the appropriate support measures."

STATEMENT 4/01

STATEMENT BY THE COMMISSION

Assessment of the situation

"In the light of the undertakings to which it subscribed at the June 1998 Council, the Commission undertakes to examine the economic development of the banana sector, including producers' income, taking account, in particular, of the impact of the changes to the arrangements, applied since 1 January 1999, on the marketing of Community bananas."

STATEMENT 5/01

STATEMENT BY THE UNITED KINGDOM DELEGATION

"The United Kingdom has consistently worked for swift agreement to a revised EU banana regime which will not be challenged in the World Trade Organisation and which reflects the EU's commitments to the ACP, in particular the Caribbean.

The latest proposal to amend Council Regulation 404/93 will not end the trade dispute; nor is it evident that the measures to be introduced under it in the Management Committee will ensure the continued viability of the Caribbean banana export industries. For these reasons, the United Kingdom opposes the proposal".

STATEMENT 6/01

Statement of the Council and of the Commission on control and enforcement in regional fisheries organisations

<u>"The Council and the Commission</u> note that three proposals on financing control arrangements in the Community, on financing ICCAT control measures in the Gulf of Guinea and on NEAFC control measures are currently under examination in the Council with a view inter alia to ensuring that the Community fulfils its international obligations. However, decisions on these proposals are without prejudice to future decisions on arrangements for control and enforcement in Regional Fisheries Organisations.

<u>The Council and Commission</u> note that divergences still exist as to the responsibility for the implementation of control and enforcement tasks under RFOs.

<u>The Council</u> welcomes the Commission's intention to table a Communication on a range of control issues, including enforcement in RFOs. The Council looks forward to discussion of this communication during the Swedish Presidency. The Council will consider the issue of control and enforcement in RFOs with a view to reaching conclusions by June 2001 in order to ensure effective and efficient control and enforcement in RFOs.

The Commission will come forward with any appropriate proposals as soon as possible."
