"This package of directives revises and updates the entire legal framework in respect of public procurement. Given the central role played by public procurement in the European Union's overall economic performance, the legal and linguistic quality and comprehensibility of the new legal framework is of great importance.

However, Austria would point out that the deadlines for producing the different language versions of the three procurement directives were so tight that it was impossible to ensure a thoroughly accurate and high-quality translation, at least where the German-language version was concerned. Austria regrets the fact that there was such unreasonable time pressure, particularly since no compelling reasons for such great urgency were apparent, and since the ambiguities which thus arose when producing the different language versions could jeopardise the objective of simplifying the legal framework for contractors and economic operators."

Statement by the Commission on Article 18(2) of the Directive on public procurement, on Article 36(2) of the Directive on procurement by entities operating in the water, energy, transport and postal services sectors and on Article 30(3) of the Directive on the award of concession contracts

"Article 18(2) of the Directive on public procurement, Article 36(2) of the Directive on procurement by entities operating in the water, energy, transport and postal services sectors and Article 30(3) of the Directive on the award of concession contracts are enshrined in the existing applicable Union legislation. They have to be applied in compliance with Union law and in the light of its basic principles, notably, the principles of equal treatment and non-discrimination of economic operators, including economic operators from other Member States.

The Commission will closely monitor the application of these provisions by Member States and contracting authorities/entities."

Statement by the Commission on Article 18 of the Concessions Directive

"1. Pursuant to Article 18 and recital 52 of this Directive, for concessions lasting more than 5 years, the maximum duration of the concession shall not exceed the time that a concessionaire could reasonably be expected to take to recoup the investments made for operating the works or services together with a return on invested capital taking into account the investments required to achieve the specific contractual objectives.

2. To ensure the uniform enforcement of this Directive, the Commission considers that national execution measures of Article 18, as interpreted by Recital 52, shall provide that the duration of the concession shall be estimated including initial and further investments deemed necessary for the operating of the concession, in particular expenditure on infrastructure, copyrights, patents, equipment, logistics, hiring, training of personnel and initial expenses."

"The United Kingdom supports the Council Decisions authorising the signing and conclusion, on behalf of the Union, of the arrangements with the Republic of Iceland, the Principality of Liechtenstein, the Kingdom of Norway and the Swiss Confederation, respectively, on the modalities of their participation in the European Asylum Support Office.

However, the United Kingdom wishes to draw attention to the fact that the Council Decisions are concerned with the participation of those States in an Office created by Regulation (EU) No 439/2010 of the European Parliament and of the Council of 19 May 2010 establishing a European Asylum Support Office. The legal bases cited for both that Regulation and the proposed Council Decisions to be adopted are pursuant to Title V Part III of the Treaty on the Functioning of the European Union. Consequently, these Council Decisions will only bind the United Kingdom if it opts in to the Decisions in accordance with Protocol 21 to the Treaties.

Accordingly, the United Kingdom has notified the President of the Council that it wishes to take part in the adoption and application of these Decisions, in accordance with Article 3 of Protocol No 21 on the position of the United Kingdom and Ireland in respect of the area of Freedom, Security and Justice annexed to the Treaty on European Union and to the Treaty on the functioning of the European Union."

In view of the statement to the minutes entered today by the UK, the Legal Service recalls its statement to the Minutes of the 2392th meeting of the Committee of 19 January 2012 (doc. 5521/12 ADD 1), concerning the adoption of the decision to authorise the negotiations of the above arrangements (item 18 on the agenda of the 2392th meeting), according to which:

"The Council Legal Service has taken note of the statement made by the delegation of the United Kingdom.

Article 49(1) of Regulation (EU) N° 439/2010 of the European Parliament and of the Council establishing a European Asylum Support Office (EASO Regulation), by which the United Kingdom is bound, stipulates that the Support Office shall be open to the participation of Iceland, Liechtenstein, Norway and Switzerland as observers and that arrangements shall be made, specifying in particular the nature, extent and manner in which those countries are to participate in the Support Office's work.

Having become bound by this provision, as a result of its notification of 18 May 2009 under Article 3 of the Protocol on the position of the United Kingdom and Ireland in respect of the area of freedom, security and justice, the United Kingdom has become committed to giving effect to Article 49(1) of the EASO Regulation.

This commitment cannot, according to the Council Legal Service, be made dependent on a discretion of the United Kingdom to declare whether or not it wishes to take part in decisions of the Council pertaining to the signature and conclusion of the arrangements with the countries concerned.

The Council is therefore not obliged to respect a three months time period in order to allow the United Kingdom to make such declarations."

This statement is still valid, *mutatis mutandis*, as concerns the decisions on signing the said arrangements, with the consequence that as the United Kingdom is already bound by Regulation (EU) N° 439/2010, and in particular Article 49(1) thereof, the participation of the United Kingdom to these decisions is not dependent on it having notified its wish to take part in them. The notifications made by the United Kingdom on 3 February 2014 are therefore irrelevant.

The Committee took note of the information by the Commission presenting its Communication "For a European Industrial Renaissance".

- **External Representation/ITLOS**

The Committee took note of the French delegation's information about the Commission's reticence in the Fisheries Working Party to share a possible draft submission to the International Tribunal for the Law of the Sea (ITLOS), concerning reactions to third party observations in the procedure concerning an advisory opinion in case 21. The French delegation considered that the Commission's attitude had shown a lack of loyal cooperation and did not correlate with the Commission's promise to avoid *faits accomplis*. The United Kingdom, Netherlands, Spanish, Swedish, Italian and Maltese delegations supported this view. The Italian, Belgian and Irish delegations underlined the need to have a horizontal and balanced approach towards "external representation", and showed openness to a constructive discussion.

The Commission representative rejected the views that there was a lack of loyal cooperation, and held the view that the affair was limited to a dispute over the competence for representation of the Union. The Council Legal Service referred to the views previously expressed. He emphasized that the concept of the representation of the Union before an international tribunal does not encompass the power to decide whether a submission would be made and, if so, what the content of such submission would be. The Council Legal Service informed delegations that the action for annulment of the Commission's decision of 29 November 2013 would be lodged by 10 February 2014.
