The Presidency submitted a revised compromise text in relation to articles 1 to 19 of the Commission's proposal on organic farming. Delegations were invited to give political guidance on several pending issues. The SCA took note of the positions expressed by delegations and the Commission and will take them into consideration when drafting the forthcoming Presidency compromise text (on arts. 1 to 19) which will be examined at the Working Party on 25 February.
