- General early warning

The letter in the Annex has been transmitted by the Commission in follow-up to the election recess agreement between the European Parliament, the Commission and the Council of October 2023¹.

This agreement provides:

- **under point III**, that the Commission send to the European Parliament and to the Council a list of the delegated acts that it plans to adopt between 18 February and 23 August 2024. The same applies to the final draft RPS measures intended to be submitted to the committee vote during that period. The list of such planned acts is annexed to the letter. Annex I covers planned delegated acts and Annex II covers planned RPS measures.
- **under point II**, a limited number of so-called special cases, in which the recess agreement does not apply. The list of such planned acts is included at the end of Annexes I and II. Should additional cases arise, the Commission is to immediately inform the European Parliament and the Council.

As pointed out by the Commission, the list is of a purely indicative nature and is drawn up by the Commission for planning purposes. The Commission may therefore not pursue acts included in the list or it may adopt acts later than 23 August 2024.

The Commission may also need to adopt additional acts than those included in the list.

Dear Ms Marotta,

I am writing to you in follow-up to the election recess agreement, on which our respective institutions agreed last October 2023.

The election recess agreement foresees under Point III (General Early Warning) that the Commission sends, by the end of January 2024, a list of the delegated acts, which are planned to be adopted between 18 February and 23 August 2024 to the European Parliament and the Council. The same applies to final draft Regulatory Procedure with Scrutiny (RPS) measures, which are intended to be submitted to the committee vote during that period.

Attached to this letter you will find two documents with lists of such planned acts. One list covers planned delegated acts. The second list covers planned RPS measures. Both are listed by the responsible Commission services.

The election recess agreement also provides under Point II for a limited number of so-called special cases in which the recess agreement does not apply. In the attached documents, such special cases are listed separately. In line with the election recess agreement, we will inform you immediately should additional special cases arise.

Please note that this is a purely indicative list, drawn up for planning purposes only and which in no way commits the Commission. The Commission might therefore not pursue acts included in this list or acts might be adopted later than 23 August 2024.

Please also note that the Commission may need to adopt additional acts than those included in this list.
