STATEMENT 1/02

Statement by the European Parliament, the Council and the Commission

"The European Parliament, the Council and the Commission consider that, irrespective of the Community's enlargement, a Management Board composed of 14 members plus a representative of the Commission would provide the Authority with the best possible balance between the necessary efficiency of the Board and the need for a broad range of relevant expertise. Consequently, they consider that the number should in no circumstances be increased."

STATEMENT 2/02

Statement by the Commission

"By 1 August 2003 at the latest, <u>the Commission</u> will submit a report to the European Parliament and to the Council, possibly accompanied by proposals, on the functioning of the CMO in seeds, and in particular on the stabiliser mechanism."

STATEMENT 3/02

Statement by the Commission

"<u>The Commission</u> intends to insert a provision in the implementing rules, permitting Member States which so wish to define a production profile at national level for the various seed varieties so as to allow for a modulated reduction in the amounts of aid where appropriate."

STATEMENT 4/02

Statement by the Commission

"The Commission does not consider legitimate that a Member State uses the Council procedure provided by Article 88 (2) of the Treaty to counter the economic effects of a Commission final negative decision. The Commission is strongly opposed to this Portuguese request, in view of the fact that the Council is in fact acting as an appeal instance to a Commission decision. This raises a question of general principle which will need to be considered by the Commission and that may lead to institute Court proceedings for the annulment of the decision taken by the Council in this respect."

STATEMENT 5/02

Joint statement by the Council and the Commission

"The Council and the Commission agree that in the framework of the reform of the Common Fisheries Policy, they will aim at an active fleet policy in order to achieve a better balance between fishing effort and fisheries resources".
