**COMMENTS ACCOMPANYING

The Council welcomes the Court's opinion that, in all material respects, the Agency's annual accounts present fairly its financial position as at 31 December 2022 and the results of its operations, its cash flows, and the changes in net assets for the year then ended, in accordance with the provisions of the Agency's Financial Regulation, and that the underlying transactions for 2022 are legal and regular in all material respects. Nevertheless, some observations need to be made.

The Council takes note of the Court's observations on the Agency's internal controls and delegation of powers to authorising officers for payment execution. The Council acknowledges the Agency's reply to the Court's observations and welcomes its commitment to take steps to ensure sound internal controls, notably set threshold amounts for payment authorisation per payment order.

The Council also takes note of the carry-over of 29.4 % of operational commitment appropriations to 2023, and acknowledges the Agency's reply, justifying the occurrence by unpredictable Court cases expenditure. However, the Council recalls the importance of compliance with the principle of annuity, and invites the Agency to take remedial action by better planning, in order to prevent further occurrence of such cases, and therefore guarantee sound implementation of its budget in the future.

The Council welcomes the Court's opinion that the Institute's annual accounts present fairly, in all material respects, its financial position as at 31 December 2022 and the results of its operations, its cash flows, and the changes in net assets for the year then ended, in accordance with the provisions of the Institute's Financial Regulation, and that the underlying transactions for 2022 are legal and regular in all material respects. Nevertheless, some observations need to be made.

The Council notes the Institute's lack of disclosure in its annual activity report of the error rate resulting from the *ex-post* audit for the year 2021 and invites the Institute to remedy this.

The Council regrets the lack of required *ex-ante* controls by the Institute which contradicts its Financial Regulation, the Institute running the risk in this case to pay incorrect amounts to the contractors. The Council welcomes the Institute's initiative to improve its control systems in order to prevent further risks.

The Council takes note of the Court's observations on the weaknesses in the Institute's budgetary management, in particular late payment execution and non-compliance with the Financial Regulation whereas authorisation of appropriations before entering into legal commitments is concerned. The Council welcomes the Institute's commitment to review its grant management processes, and urges the Institute to prevent the occurrence of similar errors in the future.

The Council welcomes the Court's opinion that, in all material respects, the Agency's annual accounts present fairly its financial position as at 31 December 2022 and the results of its operations, its cash flows, and the changes in net assets for the year then ended, in accordance with the provisions of the Agency's Financial Regulation, and that the underlying transactions for 2022 are legal and regular in all material respects. Nevertheless, some observations need to be made.

The Council takes note of the Court's observation about the Agency not complying with the provisions of the Financial Regulation with regard to the duration of framework contracts. The Council acknowledges the Agency's reply to the Court's observation and invites the Agency to take remedial actions in order to prevent such occurrences.

The Council also acknowledges the Agency's reply to the Court's observation addressing some weaknesses in the Agency's planning and management system, related to the launch of a negotiated procedure without prior publication of a contract notice. The Council invites the Agency to take supplementary measures to ensure full compliance with procurement rules.

While taking note of the weaknesses identified in the Agency's recruitment processes, in particular the lack of audit trail, the Council welcomes the corrective action put in place by the Agency.

Nevertheless, some observations need to be made.

The Council regrets the Court's recurrent observation, already made in 2017 and 2020, on the legality and regularity of transactions concerning compliance with procurement procedures, as well as the resulting payments executed in 2022, assessed as irregular. The Council also notes other procurement flaws, where the Agency does not show compliance with the Financial Regulation or "best value for money" in its purchases, and invites the Agency to take remedial actions in order to prevent such further occurrences.

The Council welcomes the Court's opinion that, in all material respects, the Agency's annual accounts present fairly its financial position as at 31 December 2022 and the results of its operations, its cash flows, and the changes in net assets for the year then ended, in accordance with the provisions of the Agency's Financial Regulation, and that the revenue underlying the accounts for 2022 is legal and regular in all material respects.

However, the Council regrets the Court's qualified opinion on the legality and regularity of payments underlying the accounts, in particular as regards payments under specific contracts significantly deviating from the underlying framework contract as well as recurrent payments under contracts found irregular in the previous year. The Council also regrets the Court's other observations on the non-compliance and materiality.

The Council takes note of the Court's observation concerning delays in the implementation of the Entry/Exit System and their impact on the Agency's operations.

Concerning the Agency's management and control systems, the Council regrets the lack of compliance with financial rules, in particular concerning payment execution non-compliant with specific contracts provisions, as well as procurement and management of framework contracts.

With regard to budgetary management, the Council regrets the recurrent high rates of carry-overs, which contradict the budgetary principle of annuality and are indicative of structural issues in the budget process and implementation cycle.

Considering that non-compliance and deficiencies in the Agency's internal control systems related to procurement, contract and budgetary management are recurrent, the Council urges the Agency to address the Court's observations, particularly on the legality and regularity of the payments underlying the accounts, by implementing remedial measures.

Nevertheless, some observations need to be made.

The Council regrets the Court's observation concerning the certification of the Agency's accounts and the validation of its accounting system, as well as the contributions from non-EU Schengen area countries not being correctly calculated. The latter is also correlated with another observation made by the Court on budgetary management. While acknowledging the efforts already made by the Agency, the Council calls on the Agency to take any appropriate measures to improve its budgetary management. In this regard, the Council calls on the Agency to liaise with the Commission, responsible for providing further horizontal guidance to EU bodies on how to calculate contributions from non-EU countries consistently.

The Council takes note of the Court's observation related to the statement of assurance of the Agency's current Executive Director.

The Council regrets the Agency's overestimation of accrued charges for its mission costs, as well as the lack of formalised guidance or procedures to ensure consistent calculation of accrued charges, and therefore invites the Agency to take remedial measures.

Concerning the Court's observations on the legality and regularity of transactions as regards a particular service contract, the Council takes note of the Agency's acknowledgment of the irregularity and invites it to take appropriate measures to avoid similar cases in the future.

The Council also regrets the deficiencies in the Agency's management and control system, in particular concerning internal controls for framework contracts with not enough evidence of or inaccuracies in the costs incurred (e.g. travel services), and the significant weaknesses in the Agency's recruitment procedures. These may expose the Agency to reputational and legal risks. Therefore, the Council urges the Agency to address the Court's observations on its management and control system, in particular by implementing remedial measures in upcoming public procurement procedures, as well as future recruitment processes.

The Council welcomes the Court's opinion that, in all material respects, the Agency's annual accounts present fairly its financial position as at 31 December 2022 and the results of its operations, its cash flows, and the changes in net assets for the year then ended, in accordance with the provisions of the Agency's Financial Regulation, and that the underlying transactions for 2022 are legal and regular in all material respects. Nevertheless, one observation needs to be made.

The Council regrets the Court's recurrent observation regarding procurement procedures, in particular the awarding of low-value contracts by the Agency without corresponding evaluation reports and award decisions, and therefore invites the Agency to take remedial actions in full compliance with the Financial Regulation. The Council welcomes the Agency's actions to ensure the documentation and approval of the procurement procedures.
