1. Il 26 gennaio 2010 l'alto rappresentante ha proposto di prorogare fino al 31 agosto 2010 il mandato del rappresentante speciale dell'Unione europea per la regione dei Grandi Laghi in Africa in attesa di ulteriori sviluppi relativi all'istituzione del Servizio europeo per l'azione esterna. Il 29 gennaio il comitato politico e di sicurezza ha accolto tale proposta.
2. Il 12 febbraio 2010 il gruppo dei Consiglieri per le relazioni esterne ha approvato il testo del progetto di decisione del Consiglio che proroga il mandato e la scheda finanziaria ad esso relativa.
3. Nel corso del dibattito sulle schede finanziarie, il gruppo ha sottolineato che gli RSUE dovrebbero avvalersi, ove opportuno, dei contratti quadro negoziati dalla Commissione per l'approvvigionamento di servizi e di materiale.

4. Quanto ai pagamenti per trattamenti di fine rapporto spettanti al termine del contratto di lavoro al personale locale o a quello assunto dall'RSUE con contratti internazionali, per il gruppo resta inteso che si procederà a tali pagamenti solo ove obblighi giuridici lo rendano necessario.
  5. Il gruppo ha sottolineato che sono state inserite adeguate disposizioni per far sì che gli RSUE possano rispettare l'obbligo di chiusura tempestiva dei conti.
  6. Si invita pertanto il COPERER a:
    - confermare l'accordo sul progetto di decisione del Consiglio e sulla relativa scheda finanziaria che figura nell'allegato;
    - raccomandare al Consiglio di adottare la decisione che proroga il mandato del rappresentante speciale dell'Unione europea per la regione dei Grandi Laghi in Africa il cui testo, messo a punto dai giuristi-linguisti, figura nel documento 6189/10 PESC 160 COAFR 43 COSDP 105.

## 5. DESCRIPTION AND GROUNDS

### 5.1. Need for Community intervention

#### 5.1.1. Objectives pursued

In accordance with Article 2 of **Council Decision 2010/.../CFSP of .../02/2010**, the mandate of the EUSR shall be based on the policy objectives of the European Union regarding the further stabilisation and consolidation of the post conflict situation in the African Great Lakes Region paying particular attention to the regional dimension of the developments in the countries concerned. Promoting in particular the compliance with the basic norms of democracy and good governance, including respect for human rights and the rule of law, these objectives include:

- (a) contributing actively and effectively to a consistent, sustainable and responsible policy of the EU in the African Great Lakes Region, and promoting a coherent overall EU approach in the region. The EUSR shall support the work of the HR in the region;
- (b) ensuring the continued commitment of the EU to the stabilisation and reconstruction processes in the region, through an active presence on the ground and in relevant international fora, staying in touch with key players and contributing to crisis management;
- (c) contributing to the post-transition phase in the Democratic Republic of the Congo (DRC), in particular as regards the political process of consolidating the new institutions and defining a broader international framework for political consultation and coordination with the new government;
- (d) contributing, in close cooperation with the United Nations/MONUC, to the international support efforts to pursue a comprehensive Security Sector Reform in the DRC, in particular in view of the coordinating role the EU is ready to assume in this context;
- (e) contributing to appropriate follow-up measures to the International Conference of the Great Lakes Region, in particular by establishing close contacts with the Great Lakes Secretariat and its Executive Secretary as well as with the Troika of the follow-up mechanism and by promoting good neighbourly relations in the region;

- (f) addressing the still considerable problem of armed groups operating across the borders, which risks destabilising the countries in the region and aggravating their internal problems;
- (g) contributing to the post-conflict stabilisation in Burundi, Rwanda and Uganda, in particular through accompanying peace negotiations with armed groups such as the FNL and LRA.

#### **5.1.2. Measures taken in connection with ex ante evaluation**

The first mandate of the EUSR was adopted in 1996 and has been renewed 18 times. Each renewal is preceded by a political assessment by the Council.

#### **5.1.3. Measures taken following ex post evaluation**

The Council undertakes reviews at the end of each EUSR mandate on the basis of document Review of Mandates of EUSRs (doc. 6436/03 of 14 February 2003). The most recent review was conducted by the Africa Working Group on 25 November 2009 (COREU CFSP/SEC 2331/09 of 20/11/2009). The review recommended the continuation of the mandate.

### **5.2. Actions envisaged and arrangements for budget intervention**

The mandate of the EUSR, as specified in Article 3 of **Council Decision 2010/.../CFSP of .../02/2010**, will be to:

- (a) establish and maintain close contact with the countries of the Great Lakes Region, the United Nations, the African Union, key African countries and main partners of the DRC and the EU, as well as regional and sub-regional African organisations, other relevant third countries and other key regional leaders;
- (b) advise and report on the possibilities for the EU to support the stabilisation and consolidation process and on how best to pursue EU initiatives;
- (c) provide advice and assistance for security sector reform (SSR) in the DRC;
- (d) contribute to the follow-up to the International Conference of the Great Lakes Region, in particular by supporting policies, defined in the region, which pursue the objectives of non-violence and mutual defence in the resolution of conflicts as well as, regarding regional cooperation, by promoting human rights and democratisation, good governance, judicial cooperation, and the fight against impunity and the illegal exploitation of natural resources;

- (e) contribute to a better understanding of the role of the EU among opinion leaders in the region;
- (f) contribute, where requested, to the negotiation and implementation of peace and cease-fire agreements between the parties and engage with them diplomatically in the event of non-compliance with the terms of these agreements; in the context of the ongoing LRA negotiations, such activities should be pursued in close coordination with the EUSR for Sudan;
- (g) contribute to the implementation of the EU human rights policy and EU Guidelines on human rights, in particular the EU Guidelines on Children and Armed Conflict, and the EU policy regarding UN Security Council Resolution 1325(2000) on Women, Peace and Security, including by monitoring and reporting on developments in this regard.

The main beneficiaries are the countries and people of the African Great Lakes Region, in particular the Democratic Republic of Congo, Rwanda and Burundi.

### **5.3. Methods of implementation**

The EU Special Representative will sign a Special Adviser contract with the Commission. He will be accountable to the Commission for the management of expenditure relating to the mandate.

The EUSR will sign employment contracts with his staff on his own behalf. The terms of reference of any new employment contracts will be submitted to the Commission for prior approval in ways to be specified in the contract.

### Salaries

The salaries of all non-seconded staff are covered by the budget of the mandate. Salaries, daily allowances and travel allowances for international (contracted) staff are based on Commission Communication on Specific Rules for Special Advisers of the Commission entrusted with the Implementation of Operational CFSP Actions (C(2009)9502 of 30 November 2009).

The salaries of the seconded staff are covered by the seconding state and institution, respectively. Daily allowances for seconded personnel are based on Commission Communication C(2009)9502 of 30 November 2009 referring to Council Guidelines 7291/09 of 10 March 2009.

- EU Special Representative  $6 \text{ months} * 21,200 \text{ €/month} = \mathbf{127,200 \text{ €}}$

The remuneration of the EUSR corresponds to the basic salary of the grade AD 16, 1<sup>st</sup> level, as fixed at Article 66 of the EC Staff Regulations. This salary is determined on the basis of document “EU Special Representatives: Guidelines on appointment, mandate and financing” (doc. 13833/03 of 28 October 2003). The remuneration includes expatriation allowance of 16 % and other applicable allowances as per the EC Staff Regulations.

- Seconded staff in Brussels receive an allowance of 122,97 €, corresponding to the allowance for Seconded National Experts to EU Institutions, except if the secondment is from Belgium or a Brussels based EU Institution. Out of 5 seconded staff (3 Political advisers, 1 SSR expert and 1 secretary), 2 Political Advisers and 1 SSR expert fulfil this condition.

In reality, there are 2 half time posts. The provision for the Political Advisor includes gross salary and all social security contributions of the employer under the Belgian law.

## Insurances

The budget covers a high-risk insurance for the EUSR and his team members, whether they are paid from the budget or seconded by Member States.

In addition, an amount has been foreseen to cover severance payments for local Staff (**192,960 €**), as well as the costs for outplacement for 2 staff (**6,600 €**), in accordance with Belgian law.

## 6.2.2. Missions

All mission expenditure directly related to the implementation of the mandate is covered by the budget of the mandate. The mission expenditure includes transportation, per diems and accommodation. The rates are based on the Guide to Missions for Officials and Other servants of the European Commission (Article 71 of the Staff Regulations and Articles 11 to 13 of Annex VII to the Staff Regulations). Depending on the type of mission the EUSR travels with one or two advisers.

**Missions to Great Lakes Region:** the EUSR travels to the region at least once a month, sometimes twice. He generally visits 2-4 countries during each mission. In addition, a permanent presence in East RDC is ensured by 2 Political Advisors, on a rotation basis.

However, so far the EUSR was mostly able to fly with MONUC or ECHO-Flight for free. Hence no amount is foreseen.

**Missions inside Europe:** the EUSR travels to the capital of each Presidency at least once. He also visits other European capitals for consultations with the Ministers of Foreign Affairs and the Africa directors. Occasionally donor meetings on Burundi are also held in European Capitals.

EUSR + Advisers: 6 flights \* 850 €/flight = **5,100 €**

**Missions to the United States of America:** The Special Representative goes to New York 3 times a year to attend meetings in the framework of the United Nations. During some of these visits he also travels to Washington for consultations with the US State Department.

### **6.2.5. Representation**

### **6.2.6. Closure costs**

Due to the expected integration of EUSRs *or their tasks* to the European External Action Service, closure costs have been included in the budget as the contracts will have to be closed and equipment disposed of after the end of this mandate.

These closure costs have been budgeted with a view to sufficient staff availability in order to ensure a proper and speedy closure of Special Adviser contracts between the Commission and the EUSR.

In terms of staffing needed for closure, the salary is foreseen for one accountant during 6 months (57,600 €) and for one administrative assistant during 3 months (24,000 €). The amounts for severance payments for these two staff have been foreseen under the heading 6.2.1 Personnel.

## **8. FOLLOW-UP AND EVALUATION**

### **8.1 Follow-up arrangements**

According to Article 4 of **Council Decision 2010/.../CFSP of .../02/2010**, the EUSR shall be responsible for implementing the mandate acting under the authority of the High Representative of the Union for Foreign Affairs and Security Policy (HR). The EUSR shall be accountable to the Commission for all expenditure.

Under Article 11 of the said Council Decision, the EUSR will regularly provide the SG/HR and the PSC with oral and written reports. The EUSR will also report as necessary to Council working parties. Regular written reports will be circulated through the COREU network. Upon recommendation of the HR or the PSC, the EUSR may provide the Foreign Affairs Council with reports.

Under Article 12 of the said Council Decision, the EUSR will promote overall EU political coordination. He will help to ensure that all EU instruments in the field are engaged coherently to attain the EU's policy objectives. The activities of the EUSR will be coordinated with those of the Commission, as well as those of other EUSRs active in the region as appropriate. The EUSR will provide Member States' missions and the Union's delegations with regular briefings. In the field, close liaison will be maintained with the Head of the Union delegation and Member States' Heads of Mission. They will make best efforts to assist the EUSR in the implementation of the mandate. The EUSR will also liaise with other international and regional actors in the field.

The implementation of this Decision and its consistency with other contributions from the European Union to the region shall be kept under regular review. The EUSR shall present the HR, the Council and the Commission with a mandate implementation report at the end of the mandate.

### **8.2 Arrangements and schedule for the planned evaluation**

The Commission may conduct an evaluation of this action within the framework of its budget implementing powers.

The Council will conduct a review at the end of the mandate, on the basis of the Council Guidelines on appointment, mandate and financing of EU Special Representatives (doc. 11328/1/07. REV 1 of 24 July 2007).

## **9. ANTI-FRAUD MEASURES**

Controls may be undertaken by the Commission, including OLAF, as well as by the European Court of Auditors.
