Subject:	Transfer of appropriations No DEC 04/2022 within Section III - Commission - of the general budget for 2022

1. On 7 February 2022, the Commission submitted to the Council proposal for transfer of appropriations No DEC 04/2022 related to the mobilisation of the European Globalisation Adjustment Fund (EGF/2021/007 FR/Selecta)¹, in accordance with Article 31(1) of the Financial Regulation².
2. The purpose of this transfer is to move an amount of EUR 4.07 million in commitment appropriations from Article 30 04 02 (*Reserve for the European Globalisation Adjustment Fund for Displaced Workers (EGF)*) to Article 16 02 02 (*European Globalisation Adjustment Fund for Displaced Workers (EGF)*), as recorded in 6017/22.
