The SCA approved the Presidency four-column document set out in document 5399/14 + COR 1 as a basis to start negotiations with the European Parliament.

The SCA also took note of the Presidency intention to negotiate with the European Parliament on 10 February 2014 with a view to possibly reaching a political agreement at that meeting.

The SCA further took note of the Presidency information that an extraordinary meeting of the SCA could be needed on 17 February 2014 if a political agreement were concluded on 10 February 2014.

- State of play

The SCA took note of the information provided by the Presidency on the timetable for the proceedings on the proposal for information provision and promotion measures for agricultural products on the internal market and in third countries. It also took note of the contributions made by delegations and the Commission representative. The Presidency promised to keep the SCA informed of further developments.

The Commission presented its report to the Committee. Several delegations took the floor and expressed their broad support to the development of the optional quality term "product of island farming". In their views, this optional instrument would be beneficial both for local

farmers and for consumers and would not compete with other existing instruments (such as PDOs/PGIs). Some concerns were expressed by a few delegations regarding the use of the Eurostat criteria. The Presidency concluded that this matter would be further discussed at a future session of the SCA.

The SCA agreed to give more time to all delegations to further examine this issue and invites the Council to extend the period for raising objections on this Delegated Regulation by two months in accordance to Article 56 of Regulation (EU) No 1152/2012.
