	 Preparation for the trilogue 		

I. <u>INTRODUCTION</u>

- 1. The <u>Commission</u> submitted the above-mentioned proposal to the <u>European Parliament</u> and to the Council on 1 June 2023 as a part of the Maritime Safety Package¹.
- 2. The proposal concerns a modification of Directive 2009/21/EC of the European Parliament and of the Council of 23 April 2009 on compliance with flag State requirements².
- 3. Directive 2009/21/EC regulates the enforcement of rules applicable to flag State at the Union level. The responsibility for monitoring the compliance of ships with particular IMO conventions lies with the State where the ship is registered and whose nationality the ship holds: the flag State. The Directive aims to ensure that Member States effectively and consistently discharge their obligations as flag States.

- 4. The revision of the Directive has the following specific objectives:
 - to update and align the Directive with the international rules, in particular as regards
 the IMO Instruments Implementation Code III Code;
 - to ensure adequate inspections of flagged ships and monitoring oversight of recognised organisations (ROs) working on behalf of the flag State;
 - to ensure a higher uptake of digital solutions and
 - to ensure a harmonised approach in the understanding, reporting and measuring of the performance of flag States fleets and duties.
- 5. The proposal was accompanied by an impact assessment and an evaluation report¹. The impact assessment was presented and thoroughly examined at one working party meeting, and it did not raise any major concerns for delegations.

II. STATE OF PLAY

- 1. The European Parliament designated the <u>Committee on Transport and Tourism</u> (TRAN) as the responsible committee on this proposal and Ms Vera Tax (S&D, Netherlands) as rapporteur. It adopted its position and a mandate for negotiations in plenary on 13 December 2023.
- 2. On 20 September 2023, the <u>European Economic and Social Committee</u> adopted its opinion on the proposal². On 23 June 2023, the <u>European Committee of the Regions</u> decided not to give an opinion.
- 3. The Council agreed on a general approach on 4 December 2023.
- 4. The co-legislators agreed in writing, in the beginning of January 2024, to enter into negotiations and granted a broad mandate to the technical level. The co-legislators confirmed the objective of the Commission proposal.

- 5. Between 9 January 2024 and 14 February there were <u>4 technical meetings</u> organised to prepare the trilogue planned on 27 February. The Presidency presented in the <u>Shipping</u>

 <u>Working Party</u> on 15, 22 and 29 January as well as 5 and 12 February compromise proposals and drafting suggestions that were prepared in the technical meetings with the Parliament.
- 6. During the technical meetings the Presidency explained the work done in the Council and got support from the Parliament for most of the changes it presented in the general approach.

 After the last technical meeting, five main political issues remain to be resolved:
 - Social provisions (*lines 11a, 25a, 49, 58, 69, 69a, 78a, 93, 139b*);
 - Genuine link (*line 21*)
 - Risk Based Approach (*lines 13d, 17, 17b, 18, 57-57f*);
 - Digitalisation (*lines 77-93a*)
 - Sharing of flag State inspection reports (line 84)

III. THE PROPOSED MANDATE

- 7. The trilogue is scheduled on 27 February in the European Parliament in Strasbourg. It is the Presidency's intention to finalise the negotiations with a political agreement.
- 8. For the European Parliament, **the social element** is politically very important, and there are no less than 9 amendments on this topic. However, as many Member States noted, the Union already has a legal framework in force in this area¹. For this reason, introducing such provisions in this directive could generate legal uncertainty, and the Presidency has pointed this out repeatedly during the interinstitutional technical meetings. Moreover, the 2006 Maritime Labour Convention is not within the scope of the III Code, and so there is no reason to include it in this directive.

This is, however, very important politically for the Parliament. At the same time, the general objective of improving the shipboard living and working conditions of seafarers is something that the Council can support. For this reason, the Presidency is suggesting several compromise proposals, which would not create any additional obligations or burdens for the Member States, in lines 11a, 25a, 36d, 49 and 58. In exchange, the Presidency will insist that the Parliament shows flexibility in respect to other elements which are important for the Council, such as digitalisation and the risk-based approach.

- 9. One of the most controversial amendments of the Parliament concerns the issue of 'genuine link' (line 21), included in recital (11), but without any correspondence in the articles. The concept is mentioned in Article 91(1) of UNCLOS¹, which states that there must be a genuine link between a vessel and its flag State. The Parliament proposed that the Commission would develop guidelines to set out what constitutes a genuine link and its consequences. This is, however, a highly controversial issue, as there is currently no generally agreed legal understanding, at international level, of the meaning and limits of the concept. A restrictive interpretation at Union level could have an impact on several Member States with open registers. For this reason and having in mind the positions expressed by Member States during the discussions in the Shipping Working Party, the Presidency is suggesting to reject the EP amendment in its entirety.
- 10. The Presidency explained in detail the Council **risk-based approach** (*lines 57-57f*) and its advantages. While acknowledging the added value of prioritising ships with a higher risk for the flag State inspections, the EP remains concerned of the fact that, according to the data in the impact assessment, some Member States seem to be conducting a number of flag State inspections which is too low. Moreover, it noted that in the Council text the risk-based approach remains optional, which means that MS are free not to use such an approach in their inspection activities. For Member States who decide not to use this approach, there are no quantitative nor qualitative requirements in the general approach. For Member States who use the risk-based approach, there is also a risk that certain ships would not be inspected for extended periods of time. This is a major point for the EP, who seems convinced that flag States inspections are central to ensure a similar high quality of shipping in all Member States.

UNCLOS – The United Nations Convention on the Law of the Sea

The Presidency is now proposing a number of additional elements that would strengthen the risk-based approach and alleviate the concerns of the Parliament. During the interinstitutional technical meetings, the EP indicated it could agree with this revised risk based approach, with the exception of the 7 years time limit between inspections in lines 57e and 57f, where they propose 5 years. In view of a compromise, the Presidency would like to test the Member States' flexibility for a 6 years time limit (which, according to a simplistic estimation, could be equivalent to a 16,6 % yearly inspection quota).

11. One of the main objectives of the European Parliament is to stimulate the **digitalisation** of the sector at European level. They consider that electronic information sharing will facilitate the work of flag State (and port State) inspectors and improve overall efficiency, while at the same time reducing administrative burdens, both for authorities and for the shipping companies. In *line 79*, The Parliament strongly supports the Commission, considering that the *electronic availability of statutory certificates* is a minimal requirement; they do not share the Council concerns and consider that these certificates do not include any confidential information. The availability of statutory certificates in a digital form could facilitate inspections.

The Presidency is proposing, in *lines* 77-93a a compromise solution that takes into consideration the concerns of Member States (no additional administrative burden, no duplication of work and no additional cost), and also achieves the result sought by the Parliament and the Commission: that all the information listed in Article 6 (including the statutory certificates – *line* 79) is available online, in an up-to-date form, to all port State and flag State inspectors in the Union.

This compromise solution is based on a *digital interoperable portal*, which would be essentially a 'bridge' allowing port and flag State inspector to directly consult the information that is stored in national databases. This brings no new obligation for Member States, other than the one already in the general approach: to make the information available in an electronic format.

- 12. On a similar point linked to the digitalisation, the Parliament sees a strong added value in the **electronic sharing of flag State inspection reports** (*line 84*). This is based on three main arguments:
 - better use of scarce resources / less need to inspect ships for example: if a specific ship, which is certified by a certain Recognised Organisation (RO), is subject to a flag State inspection in another Member State and no issues are identified, this can be a good indication that similar ships, certified by the same RO, do not pose a substantial risk this information (the outcome of the inspection report) can therefore be used in its own risk-based approach by another flag State;
 - better monitoring of ROs and less chance of detentions by port State control if several inspection reports indicate structural weaknesses in the activity of a certain RO, on certain ship-types, this information (the outcomes of inspection reports) could be used by another flag State to inspect with priority such ships, certified by the respective RO, and determine corrective actions which in turn would avoid possible deficiencies and detentions of those ships by port State control authorities in other Member States.
 - coherent and harmonised implementation of the legislation by flag State inspectors This sharing of inspection reports already happens for Ro-PAX ships. Without
 digitalizing and sharing inspection reports here, there would be two different regimes
 for flag State inspectors to follow, based on the type of ship.

The Presidency would like to know if Member States can show flexibility towards the idea of sharing at least some elements of the flag State inspection reports.

- 13. As regards other more technical issues, it should be noted that some adjusted compromises (with green highlight in the Annex) are proposed for:
 - the scope (*line 36g*) the Parliament has strong reservations to changing the scope of the proposal and they asked to limit changes to what is absolutely necessary; moreover, they were critical on the fact that the concept of international voyages, while essential for this directive, is not clearly defined. As a compromise, the Presidency is proposing to delete the part relative to certification (which is already included in the definition of ship) and to include one additional definition for the concept of 'international voyage'. This proposed

In addition, a new recital explaining the modification of the scope was included in *line 12a*; from a legal perspective, this does not change the substance of the general approach;

- remote inspections (line 46) the Parliament indicated that it can accept the deletion of 'on-board' if the last sentence of the proposed definition is also deleted;
- HSSC (*line 56 and 16*) even if at political level the text could be acceptable for the EP, the EP legal service has serious misgivings on the clarity of the reference to 'flag State prerogatives', considering this notion is not detailed in international law; in consultation with the CLS, the Presidency is proposing a redrafted text, in *lines 14 and 56*;
- reports on their flag State performance (*line 105c*) after clarifying the correct terminology ('medium' instead of 'standard'), the EP insisted to revert in substance to the text of the existing directive; if this would be agreed by the Council, the EP would accept the GA in lines 107 and 109;
- Delegation (lines 62, 64) the EP has legal concerns on the wording "whether its own or delegated"; in consultation with the CLS, the Presidency is proposing a redrafted text to the effect that Member States shall ensure that 'appropriate resources are available to their administrations';
- Member States oversight (*line 69*) the Presidency proposed to delete the last part of the sentence, which is redundant, since the concept of 'Conventions' is defined under Article 3(f) (*line 41*) and already includes the reference to the III Code.
- Derogation for landlocked States (lines 30b and 136b) at the request of the Parliament, and in consultation with CLS, the Presidency is proposing changes to these two lines, to limit the derogation only to the mandatory provisions of Article 6 on electronic information and exchange.

IV. CONCLUSIONS

14. The <u>Permanent Representatives Committee</u> is invited to endorse the Presidency's strategy for a conclusive negotiation and the related compromise proposals as outlined in this note and its Annex, and to give the corresponding mandate for the trilogue on 27 February 2024.
