"Cyprus would like to express its regret for the fact that the text of the Accession Partnership with FYROM does not include an explicit reference to the need for FYROM to ensure full respect to international law and in particular to the sovereignty and territorial integrity of the Republic of Cyprus, as stated in United Nations Security Council Resolutions 541 (1983) and 550 (1984) on Cyprus.

The need for full respect to international law and in particular to the sovereignty and territorial integrity of all Member States of the EU constitutes one of the main obligations of candidate countries and a fundamental commitment FYROM has undertaken under the Stabilisation and Association Agreement it has signed with the EU.

In view of the above, Cyprus is obliged to abstain from the vote on the adoption of the Accession Partnership with FYROM.

With regard to immunity, delegations welcomed the Commission's announcement that, subject to the approval by the College, it would be prepared to amend Regulation No 549/69 by introducing an exception on the immunity of Europol officials participating in joint investigations teams.

Moreover, the Commission will provide a written reply by 24 February to the questions regarding budget neutrality. Various delegations recalled their pending scrutiny reservation on this issue.

Regarding "bold- non bold posts, rotation and instructions" issue, the Committee agreed to amending Article 6(4) as set out in document 6240/08. The German proposal on "bold posts rotation" will be submitted for further discussions to the Europol Working Party. The three issues will be re-discussed at the Committee at its meeting on 27 February 2008.

b) Other items in connection with the Council meeting

No issue was raised under this item.

60. **EU-US High Level Contact Group on Data Protection** State of play

At the request of the Presidency, the Commission presented the activities of the EU-US High Level Contact Group on data protection. One delegation intervened to stress the importance of this ongoing exercise. The Chair indicated that the Committee would revert to this issue at its meeting on 27 February in order to discuss the future ways forward.
