Request to transfer provisions from the draft NRPP regulation to the draft
CAP regulation, the draft CFP regulation and the draft CMO regulation
*- Information from France, on behalf of France, Portugal and Spain,
supported by Austria, Belgium, Bulgaria, Croatia, Czechia, Hungary,
Ireland, Italy, Lithuania, Malta, Poland, Romania, Slovakia and Slovenia*

Following the non-paper of January 23 and as expressed during the COREPER II on 28 January 2026, **France, Portugal, Spain, Austria, Belgium, Bulgaria, Croatia, Czechia, Hungary, Ireland, Italy, Lithuania, Malta, Poland, Romania, Slovakia and Slovenia** consider that a number of provisions relating to the Common Agricultural Policy (CAP) and the Common Fisheries Policy (CFP) that are currently contained in the draft NRPP Regulation should be transferred, as appropriate, to the draft sectoral regulations specific to Fisheries (proposal for a CFP Regulation) and to the CAP (proposal for a CAP Regulation and proposal for a European Regulation revising the Common Organisation of Agricultural Markets (CMO) No 1308/2013).

This request is complementary to the list drawn up by the Commission and the Presidency and concerns the transfer of the specific definitions set out in Article 4 and paragraphs 1 to 5 of Article 35 to the CAP Regulation, paragraphs 6 to 9 to the CMO Regulation and paragraph 11 to the Fisheries Regulation, as well as all or part of the following articles: 59, 62 (including 62.1), 70 (including 70.1 to 70.3).

This transfer of regulatory provisions first and foremost pursues the objective of clarifying the texts in order to improve the readability of the provisions applicable to the beneficiaries of the CAP (in particular farmers) and the CFP. This transfer is therefore part of a simplification process, the elimination of duplicates and references that complicate the reading of the regulations, and aims to ensure a coherent treatment of all the provisions specific to these two policies.

This request has no budgetary impact and does not affect the functioning of the financial instrument supported by the NRPP Regulation.

Therefore, **France, Portugal, Spain, Austria, Belgium, Bulgaria, Croatia, Czechia, Hungary, Ireland, Italy, Lithuania, Malta, Poland, Romania, Slovakia and Slovenia** ask the Presidency to consider the transfer proposals attached in annex. This is a collectively supported “basic minimum set” of articles to be transferred, still allowing individual Member State to have the freedom to ask for the transfer of other provisions, including on outermost regions.
