Differences to be notified to the International Civil Aviation Organization, in respect of Amendment 37 to Annex 6 – Operation of Aircraft, Part II – International General Aviation – Aeroplanes to the Chicago Convention

1. DIFFERENCES TO BE NOTIFIED

During its 219th session, held from 2 to 20 March 2020, the ICAO Council adopted several Amendments to numerous Annexes to the Chicago Convention in the areas of safety, environment and air navigation, among them, Amendment 37 to Annex 6, Part II.

In that context, having regard to relevant Union legislation, the difference pertaining to Amendment 37, Part II of Annex 6 on Operations of Aircraft in the area of harmonisation of terms for authorisations, acceptance and approvals (AAA) shall be notified to ICAO as follows.

2. DETAILS OF THE DIFFERENCES THAT SHALL BE NOTIFIED

2.1. AMENDMENT 37 TO PART II OF ANNEX 6 ON OPERATIONS OF AIRCRAFT

2.1.1. DESCRIPTION

Amendment 37 to Annex 6 Part II that is subject to this Decision relates to the area of harmonisation of terms for authorisations, acceptance and approvals (AAA).
