THE COUNCIL OF THE EUROPEAN UNION.

Having regard to the Treaty on European Union, and in particular Article 29 thereof,

Having regard to the proposal from the High Representative of the Union for Foreign Affairs and Security Policy,

#### Whereas:

- (1) On 28 April 2023, the Council adopted Decision (CFSP) 2023/891 concerning restrictive measures in view of actions destabilising the Republic of Moldova (1) (hereafter Moldova).
- (2) The Union remains unwavering in its support to Moldova, its resilience, security, stability, economy and energy supply in the face of destabilising activities by external actors.
- (3) **DELETED**
- (4) Decision (CFSP) 2023/891 should therefore be amended accordingly.

HAS ADOPTED THIS DECISION:

Article 1

The Annex to Decision (CFSP) 2023/891 is amended as set out in the Annex to this Decision.

Article 2
