Statement by Belgium, France and Luxembourg

"Les délégations belges, françaises et luxembourgeoises :

- insistent sur la nécessité d'élaborer une réglementation européenne effective, cohérente, simple, claire et de haute qualité, qui se concentre sur les domaines où sa valeur ajoutée est la plus importante et qui s'attache à réduire le coût de la Non-Europe résultant de la fragmentation des règles nationales ;
- soulignent à cet égard l'importance de privilégier les instruments réglementaires les plus efficaces, tels que l'harmonisation et la reconnaissance mutuelle, pour éviter la réglementation excessive et les lourdeurs administratives ;
- prennent note de l'intention de la Commission d'introduire une méthode « One in, one out » au niveau européen mais estiment, en tout état de cause, que ce nouvel instrument doit être envisagé avec toute la prudence nécessaire et par étapes, qu'il doit respecter l'intégrité de l'acquis communautaire, qu'il ne peut reposer sur une logique mécanique de réduction quantitative et qu'il doit faire l'objet d'une évaluation continue ;

Statement by the Commission and the Presidency

"The Presidency notes the support for the Non-Paper, and will thus transmit to the UNECE Secretariat, together with the Commission, the support of the EU and its Member States to the Non-Paper. The Presidency notes that this Non-paper does not fully reflect the Bratislava Ministerial Decision that was approved by the Council in 2019.

Noting the EU's and its Member States' positions, both the Commission and the Presidency are submitting this statement to the UNECE Secretariat to underline that, the EU and its Member States believe that it is of utmost importance that negotiations must be swift, must start in 2021, and last for only one year, and call on all negotiating parties to focus the work on the not-agreed parts of the draft negotiating text and not to reopen the paragraphs already agreed, unless necessary in order to reflect the recent policy developments such as the Paris Agreement, the 2030 Agenda and its Sustainable Development Goals, and the United Nations Strategic Plan for Forests.

The EU and its Member States understand the Non-paper as an agreement by all participants to grant the EU the same negotiating rights as all other negotiating partners. The EU and its Member States call on all partners to strive for a Legally Binding Agreement that delivers on expectations in society towards sustainable forest management and would engage and inspire all relevant stakeholders to undertake concrete actions and show high standards and practices on transparency and credibility."
