On behalf of the President of the European Committee of the Regions (CoR), Vasco Alves Cordeiro, I would like to thank you for the referral request from the Council of the European Union to the CoR, dated 11 January 2023, regarding the following dossier:

Proposal for a Regulation of the European Parliament and of the Council amending Regulations (EU) 2017/745 and (EU) 2017/746 as regards the transitional provisions for certain medical devices and in vitro diagnostic medical devices. COM(2023) 10 final - 2023/0005 (COD).

The CoR's Commission for Natural Resources (NAT) decided at its meeting on 31 January 2023 not to issue an opinion on this proposal and not to include the dossier in the ongoing work of the CoR. As you might recall, the CoR also did not issue an opinion on the previous proposal for transitional provisions, (COM(2021) 627 final). These changes to the regulations (EU) 2017/745 and (EU) 2017/746 have no local or regional relevance.
