Having regard to Regulation (EU) No 492/2011 of the European Parliament and of the Council of 5 April 2011 on freedom of movement for workers within the Union<sup>2</sup>, and in particular Articles 23 and 24 thereof

#### Whereas:

- By its Decision of 20 September 2022<sup>3</sup>, the Council appointed members and alternate (1) members of the Advisory Committee on Freedom of Movement for Workers for the period ending on 24 September 2024.
- (2) A seat as member in the governments' representatives category has fallen vacant as a result of the resignation of Mr Thomas LEWIS.
- (3) The government of Ireland has submitted a nomination for the vacant seat,
