# amending Decision 1999/70/EC concerning the external auditors of the national central banks, as regards the external auditors of the Banque centrale du Luxembourg

## THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Protocol No 4 on the Statute of the European System of Central Banks and of the European Central Bank, annexed to the Treaty on European Union and the Treaty on the Functioning of the European Union, and in particular Article 27.1 thereof,

Having regard to the Recommendation of the European Central Bank of 29 January 2024 to the Council of the European Union on the external auditors of Banque centrale du Luxembourg (ECB/2024/3)<sup>1</sup>,

### Whereas:

- (1) The accounts of the European Central Bank (ECB) and of the national central banks of the Member States whose currency is the euro are to be audited by independent external auditors recommended by the Governing Council of the ECB and approved by the Council of the European Union.
- The mandate of the current external auditors of the Banque centrale du Luxembourg, Ernst & Young S.A., will end following the audit for the financial year 2023. It is therefore necessary to appoint external auditors for the financial year 2024 onwards.
- (3) The Banque centrale du Luxembourg has selected KPMG Audit S.à r.l. as its external auditors for the financial years 2024 to 2028.
- (4) The Governing Council of the ECB has recommended that KPMG Audit S.à r.l. be appointed as the external auditors of the Banque centrale du Luxembourg for the financial years 2024 to 2028.
- (5) Following the recommendation of the Governing Council of the ECB, Council Decision 1999/70/EC<sup>2</sup> should be amended accordingly,

## Article 1

In Article 1 of Decision 1999/70/EC, paragraph 7 is replaced by the following:

'7. KPMG Audit S.à r.l. are hereby approved as the external auditors of the Banque centrale du Luxembourg for the financial years 2024 to 2028.'.

Article 2

This Decision shall take effect on the date of its notification.

Article 3

This Decision is addressed to the European Central Bank.
