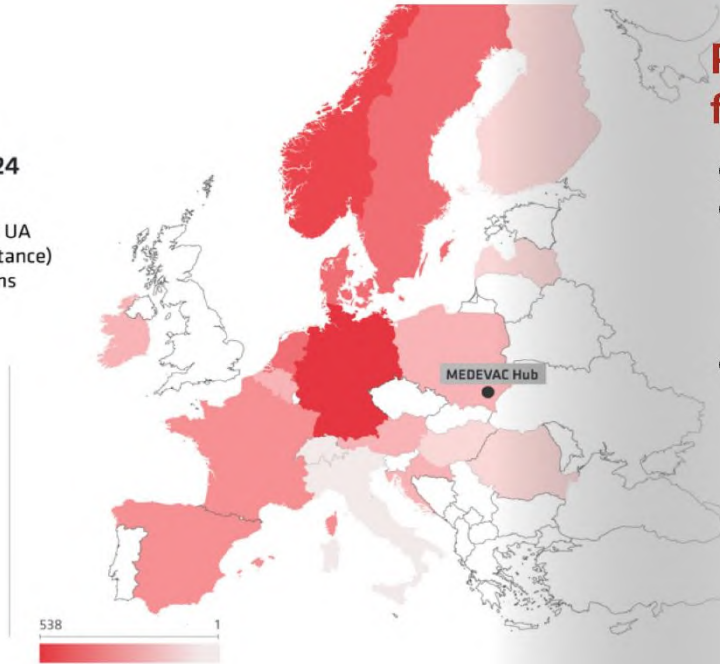
Number of people evacuated and assisted by MEDEVAC HUB Jasionka staff in 2022-2024

Humanitarian-development nexus: UA local authorities

- Improvement of living conditions and support to local authorities in the rural areas
- Rehabilitation of rural clinics (FAPs: “Feldsher-midwife point”) thanks to Polish Aid funding





Challenges in collaborating with UA local authorities

- 2018-22 PCPM's support to local authorities in Lebanon and Iraq hosting Syrian refugees (DG NEAR)
