The SCA took note of the Presidency's debrief of the 4th trilogue on the HZR, which took place on 2 March, and of the comments of delegations and of the Commission on the possible compromise solutions on Articles 84 to 87 on "conditionality".

The SCA also took note of document 6704/21 comprising EP and Commission proposals on Articles 96 and 57 of the HZR and of the comments of delegations and the Commission, on the basis of which some of the questions for the Ministerial debate at the forthcoming Council would be based.

¹ Following the SCA meeting, the Presidency concluded that the text included in document 6646/1/21 REV1 was acceptable to delegations and would be submitted to the Council for adoption as an "A" item.

The Presidency informed the SCA that, in agreement with the Netherlands delegation following their request at the last SCA meeting to have a follow-up discussion on the JRC study at the March "Agriculture and Fisheries" Council meeting², the item will be tabled at the April Council meeting.
