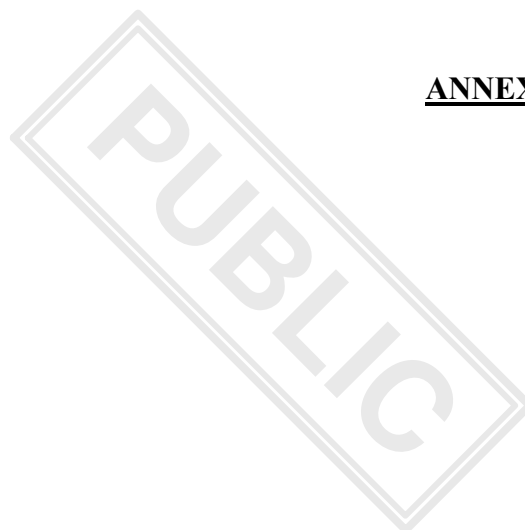

THE REGIONAL STEERING COMMITTEE OF THE TRANSPORT COMMUNITY,

Having regard to Treaty establishing the Transport Community, and in particular point (a) of Article 20(3) thereof,

Whereas:

- (1) In accordance with point (a) of Article 20(3) of the Treaty establishing the Transport Community ('TCT'), in respect of new legally binding European Union acts, the Regional Steering Committee of the Transport Community is to adopt, *inter alia*, decisions revising Annex I to the TCT to integrate those acts in the TCT.
- (2) A significant number of new legal acts of the European Union have been adopted in areas covered by the TCT since its signature on 9 October 2017, whereas other legal acts have been repealed. Annex I should therefore be revised to reflect these changes.
- (3) For the sake of legal clarity and simplification, it is appropriate to replace Annex I to the TCT by the text in the Annex to this Decision,

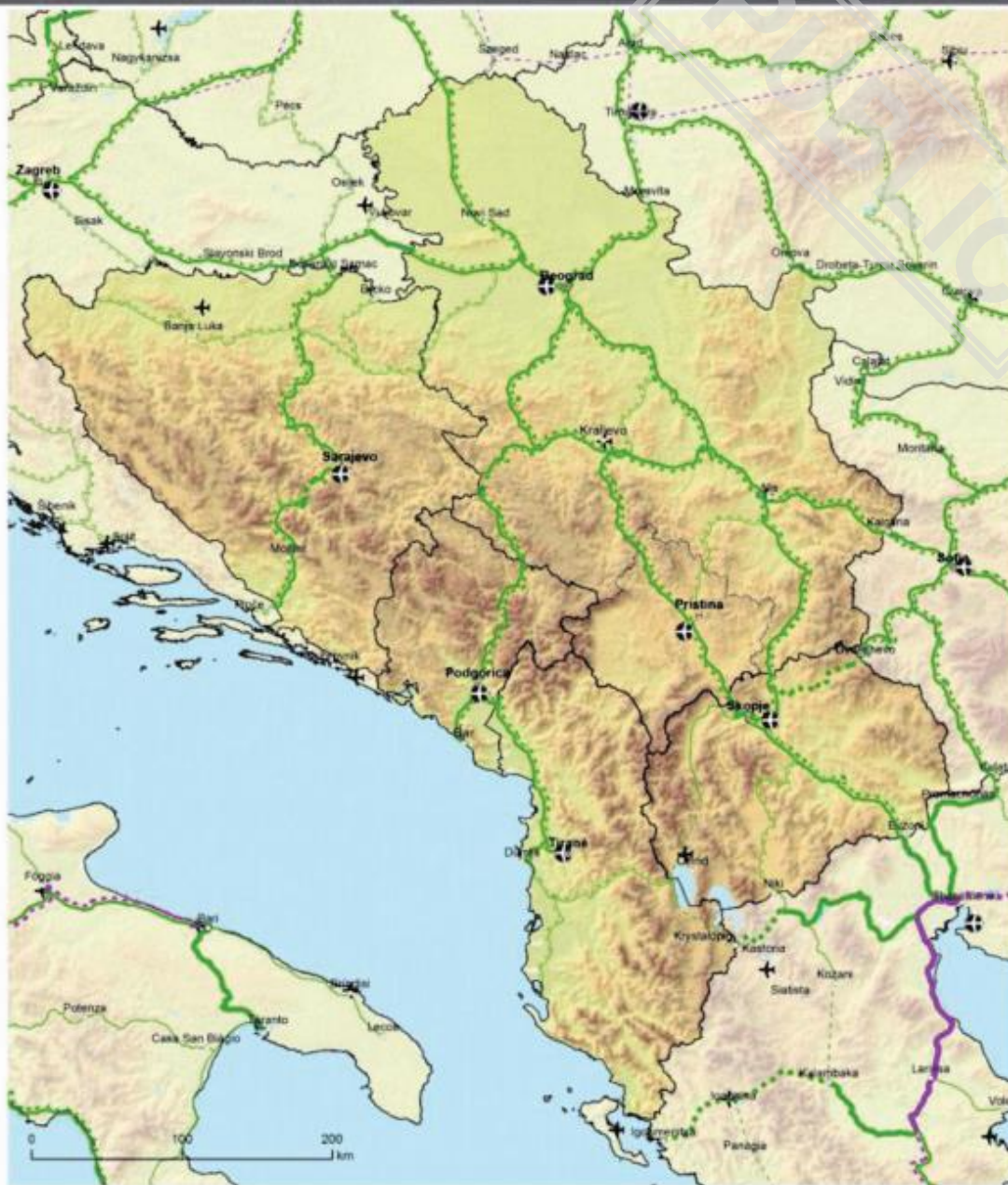
