13. Preparation of the Council meeting (Justice and Home Affairs), on 28 February 2008

a) Outstanding issues of the draft Council decision establishing the European Police
 Office (EUROPOL)
 6782/08 EUROPOL 22

<u>The Committee</u> reached agreement on two of the three outstanding issues of the draft Council Decision establishing the European Police Office, as set out in 7008/08 EUROPOL 23. These issues are:

- a) the lifting of immunity for Europol officials when participating in operational activities, especially Joint Investigation Teams (JITs);
- b) the principle of staff rotation and the possibility for Europol staff participating in JIT to receive instructions from the team leader

With regard to the third outstanding issue, budget neutrality, some Member States asked the Commission to provide a comprehensive picture of budget neutrality of Europol based on current Europol staff levels and actual estimated costs rather than on average monthly salaries. The Committee concluded to submit this issue for further discussions to the Justice and Home Affairs Council.
