**Statement by the delegations of Belgium, Germany, Spain, France, Italy, Luxembourg, Austria and Poland**

"Where the European Union adopts internal legislative acts and on this basis, it exercises external exclusive competence, the Member States bound by those legislative acts take part in the acts that the Union adopts as part of this external competence.

In the context of this decision, all the Member States of the European Union bound by Council Regulation (EC) No 44/2001 of 22 December 2000 on jurisdiction and the recognition and enforcement of judgments in civil and commercial matters consequently take part in the adoption of the Decision authorising the Member States which are Contracting Parties to the Vienna Convention on Civil Liability for Nuclear Damage of 21 May 1963 ("Vienna Convention") to ratify the Protocol amending that Convention in the interest of the European Union, or to accede to it."

**Statement by the Commission**

"The Commission considers that Protocol 21 on the position of the United Kingdom and Ireland in respect of the Area of Freedom, Security and Justice, annexed to the Treaty on European Union and to the Treaty on the Functioning of the European Union does not apply in the present case and United Kingdom and Ireland are bound by the present decision as a consequence of the fact that they are bound by Council Regulation (EC) No 44/2001 of 22 December 2000 on jurisdiction and the recognition and enforcement of judgments in civil and commercial matters."

**Statement by Austria**

"The present draft Regulation, which determines end-of waste criteria for copper scrap, is not acceptable.

Although the draft Regulation contains several improvements compared to the End-of-Waste-Regulation for metal scrap, basic requirements which should ensure enforcement of the Regulation are not contained in this draft.

Furthermore it is not clarified, whether end-of waste for enamelled cable-waste, where the removal of the coating is not feasible, is possible."

"The Conclusions on the renewal of the Swiss financial contribution constitute a political decision under Article 16 of the Treaty on European Union. Article 16 confers policy-making powers to the Council. As a consequence, the Conclusions are to be understood as the political decision of the Council, not of the Member States.

The Commission takes note of the political decision taken by the Council and will, on this basis, accept the invitation to engage in discussions with Switzerland on behalf of the EU. The Commission recalls in this regard its position in cases C-28/12 and C-114/12, pending before the Court of Justice."

Pursuant with Article 55(3) of Regulation (EC) No 1987/2006 and Article 71(3) of Decision 2007/533/JHA, the Commission stated that:
