- By its Decision of 24 February 2022<sup>2</sup>, the Council appointed members and alternate members of the Advisory Committee on Safety and Health at Work for the period from 1 March 2022 to 28 February 2025.
- (2) A seat as alternate member in the trade-unions' representatives category has fallen vacant as a result of the resignation of Mr Erkki AUVINEN.
