**TABLE A.I**

Figures of Table A.I are broken down per Member State, and where possible per EU Common Military List category where (a) = number of licences issued; (b) = value of licences issued in euros; (c) = value of arms exports in euros (if available).<sup>1</sup>

Total EU licence refusals to each destination, region and worldwide are provided, broken down by EU Common Military List category; (d) = number of licence refusals (small discrepancies may appear between breakdowns and totals due to refusals concerning more than one ML item or refusals for items other than those appearing in the ML<sup>2</sup>; (e) = criteria numbers on which refusals are based (the approximate number of times each criterion is invoked is indicated in brackets).

NB:

Statistics are compiled differently by each Member State: no uniform standard is used.

Consequently, owing to current procedures regarding arms export reporting or data protection legislation, not all countries have been able to submit the same information<sup>3</sup>:

<sup>2</sup>Concerning refusals (row (d)), totals do not always correspond to the sum of the refusals shown per military list item; this is because in some instances one refusal concerns more than one military list item, and in some instances refusals which have been issued in accordance with the Common Position for items which do not appear on the military list (for example dual use items for military end-use) are included in the total.

- (i) Concerning Austria: With regard to items covered by the EU Common Military List, the Austrian law distinguishes between 'war material' (as stipulated in the Austrian War Material Act and Regulation) and 'equipment on the Common Military List not listed as war material' covered by the Austrian Foreign Trade Act. As to category c) value of actual exports by Military List Category, figures may be inaccurate in particular as such data regarding equipment of the Common Military List not listed as war material is available to the competent authorities only after expiration or full utilization of the individual export license.
- (ii) Concerning the Czech Republic: In rows a) and b) are not included General transfer licences and Global transfer licences pursuant to Directive 2009/43/EC, which could cover goods of more than only one ML Category and allow exports to more than only one Member State. In addition to that, some other licenses issued cover goods of more than only one ML Category and their value is the total value of all covered goods. Due to this fact, in rows b) are not included these types of licences. The sums in rows c) are based on information provided by exporters and also contain actual exports made in 2014 based on licences issued in a previous year.
- (iii) Concerning Germany: some licenses issued cover goods of more than one ML Category (e.g. one license for the export of rifles and their ammunition). In reporting in table A.I., each time a license concerns a MLcategory, it is counted as one single license, so the sums in rows a) and column "Total per destination " do not always reflect the actual numbers of licenses granted, but a slightly higher figure (i.e. the number of times a ML category has been affected by a license for that destination).
- (iv) Concerning France: Export data provided by France for 2014 indicate a large increase, which actually corresponds to the complete scope of licences granted and not to actual exports (row c). This is due to:

- The EU User's Guide stipulates that just the value of actual exports to each destination needs only to be provided where it is available. With regard to actual exports authorised by EU Member States (row c)), it is important to note that Belgium, Denmark, Germany, Poland, Greece, Ireland and the United Kingdom could not provide these data while France and Italy have reported total values only. No aggregation is therefore reported at the EU level.
- With regard to the use of global and general licences notably applied to intraEU transfers pursuant to Directive 2009/43/EC, it is important to note that the actual value of arms transfers and exports under global and general licences is generally reported by EU Member States. This is however dependant on the Member States' ability to report on actual values (row c)) as described above and to possible additional national specificities as explained in footnote n°3.
- data are reported in Euros and accordingly converted from national currencies for Member States not having the Euro as national currency. Please bear in mind the possible exchange rate

- France substantially overhauled its export control system in June 2014 in notably shifting from a two-step control system (prior agreement and actual export authorisation) to a single licence-based system. This shift has entailed the addition of the values of both the prior agreements granted and the export authorisations, which has therefore inflated the overall value of licences reported. Furthermore, the implementation of this change in the licensing system has driven a large number of exporters to request that their prior agreements already granted be converted into single licences. Comparison between 2014 data and earlier data is therefore irrelevant due to this change in the reporting.

- French authorities now require exporters to apply for licences in the earliest phase of market prospection and to inform in this regard on achievement potential. As early as the negotiation phase, operations such as disseminating documentation, demonstrations, participation in call for tenders require a licence. Such comprehensive control and transparency approach entails a large value of licences granted and reported which does not reflect the value of actual orders finally made.

- (v) Concerning the Netherlands: As values of global licences cannot always be attributed to individual military list categories or individual countries, quoted total values indicated are higher than the sum of the values per ML category or per destination. The figures on actual exports reported by the Netherlands are based on information provided by the exporters in 2014, and may reflect exports based on a licence issued in a previous year. Although much care has been given to the collection of the data on actual exports, the actual exports figures for 2014 may be higher than the values quoted in this report.
- (vi): concerning Hungary: data provided includes figures of general, global and individual export licences. Transfers of military equipment to the Hungarian Forces deployed in various missions (table AII) are not considered regular foreign trade transactions, because there is no actual payment taking place.
- (vii): Concerning Sweden: The Swedish currency (SEK) is converted to (EUR) using the average exchange rate for 2014 (9,14). Rows a, b and c covers transfers/exports according to Regulation (EU) 258/2012 when also covered by Swedish Act (1992:1300) on War Material. Since some licenses cover goods of more than one ML category, each time a license concerns an ML category, it is counted as one single license. As value of Global licenses not always are visible ("Unlimited value") figures will occur only in row a and not b. I this case as more than one country of destination normally are covered for the same ML, it is counted as one single license for each country of destination.
