PT and ES made a statement on the following item :

"Portugal and Spain welcome the agreement on the Regulation of the European Parliament and of the Council on improving securities settlement in the European Union and on central securities depositories (CSDs) and amending Directive 98/26/EC, in particular the ambitious sanctions regime foreseen therein. Portugal and Spain also commend the efforts of the Hellenic Presidency in trying to achieve a balanced solution to address concerns in this regard.

Portugal and Spain note that the sanctions regime is highly sensitive. Member States operate under very different legal and institutional frameworks and these national frameworks need to remain coherent as harmonisation of the sanctions regime is pursued at European level. The difficulties of these discussions are well known and most Member States specificities have been addressed, in particular when they are grounded on constitutional concerns.

Portugal and Spain will strive to implement the permanent ban on the exercise of management functions in investment firms in conformity with national law."

FI made also a statement on the above-mentioned item :

"Regarding the proposal for a Regulation of the European Parliament and of the Council on improving securities settlement in the European Union and on central securities depositories (CSDs) and amending Directive 98/26/EC, Finland's position is abstention, due to the risks it contains for reduced ownership transparency in Finland and we want therefore to record the following declaration:

Openness and transparency is a crucial objective for financial markets. Finland wants to retain its current 100% transparency regarding domestic ownerships in Finnish listed companies and cannot therefore support the Regulation which may endanger this transparency. Finland emphasizes the need to improve the level of available shareholder information across EU and urges including this in the preparation of EU securities law legislation (SLL) and amendment of the shareholders' rights directive (SHRD)."

The Council Legal Service made the following intervention for the same item (CSDs Regulation) :

"The proposed wording of Article 38(5), second sub-paragraph provides for a derogation from the general regime, which is both unlimited in time and without an objective justification. The proposed derogation is especially problematic in the case of a Regulation. While there are instances where the Union legislator has allowed certain flexibility by deferring to relevant national law, all these exceptions were equally applicable to all parties concerned. In contrast, by introducing a specific cut-off date as proposed, the persons and entities concerned by the exception in the second sub-paragraph of paragraph 5 would be a closed group, composed of clearly identifiable Member States, legal and natural persons. In addition, as a result of this provision, the CSD Regulation would mandate the application of stricter rules towards one part of the EU legal and natural persons, and might thus be interpreted as discriminatory.

On this basis, the Council Legal Service is of the opinion that the proposed second sub-paragraph in Article 38(5) of the CSD Regulation is not compatible with the Treaties and, as such, cannot be relied upon and might be declared unenforceable in subsequent legal proceedings. More specifically, this would mean that a person covered by this exception could still require to benefit from the choice offered by paragraph 5, first sub-paragraph, and the Member State concerned would not be able to oppose to this person its national legislation."

DE made a statement on the following item :

"Today's Council Decision states that: "With respect to those matters falling under the exclusive competence of the Union, Member States are hereby authorised to ratify the Arms Trade Treaty in the interests of the Union." The Federal Republic of Germany endorses the ratification of the Treaty by the Member States, also in the interests of the Union, and supports the appeal to the Member States to do so.

Nevertheless, the Federal Republic of Germany has doubts as to whether the Decision can be based on Article 218 (6) TFEU and Article 207 (3) TFEU, which refers to Article 218 TFEU. According to the text of Article 218 (1) TFEU, the procedure for concluding agreements in Article 218 TFEU only applies to "agreements between the <u>Union</u> and third countries or international organisations". Analogous application of Article 218 TFEU to the agreements of the Member States is precluded given the principle of conferral enshrined in Article 5 (2) TEU.

The Federal Republic of Germany's cooperation in adopting this Decision is thus without prejudice to its legal position on the interpretation of Article 218 TFEU."

Following the presentation of the text agreed ad referendum with the EP rapporteurs, <u>the</u> <u>Presidency</u> noted that there was sufficient support for the compromise text on the Intracorporate transferee Directive as set out in the annex to document 6795/14 + COR 1. In order to deal with some specific concerns expressed by some delegations, the <u>Council Legal Service</u> made the following statement:

"Recital 23 of this Directive specifies that "bilateral agreements or national legislation on social security rights of intra-corporate transferees which are adopted after its entry into force of this Directive should not provide for less favourable treatment than the treatment granted to nationals of the Member States where the work is carried out".

It further specifies in a second sentence that "*as a result of such agreements or national legislation, it may be, for example, in the interest of the intra-corporate transferees to remain affiliated to the social security system of their country of origin if interruption of this affiliation would adversely affect their rights or would result in bearing the costs of double coverage.*"

The <u>Council Legal Service</u> is of the view that the second sentence is a clarification of the first sentence and that the application of the legislation of the country of origin may constitute a more favourable provision as referred to in this Directive.

Four delegations (AT, ES, HU and PL) indicated they were not in a position to support the above compromise text.

The <u>HU delegation</u> made the following statement:

"Hungary expresses its serious disappointment regarding the adopted text in Article 14(2) and Recital (23) since it precludes the practical applicability of bilateral social security agreements and limits Member States in their competence when concluding such agreements. Based on the Treaties social security policy belongs to the competence of Member States. We believe that the purpose of all secondary legislation should respect this. The aim of equal treatment harmonisation is to be interpreted in light of the competence rules of the Treaties. This Directive cannot restrict, nor impair the sovereignty of Member States in this area. In addition in our view the reference to more favourable provisions in bilateral social security agreements is ambiguous, and thus does not ensure legal certainty. Finally Hungary regrets that the compromise text adopted could create a situation with significant negative impact on the investment readiness in certain economic relations. This may harm economic recovery, could hinder the stimulation of growth and the enhancement of competitiveness, which is a common priority for the EU."

<u>Other delegations</u> also expressed their intention to make statements on this issue to be inscribed in the minutes of the Council meeting, which will formally adopt the above Directive.

As a conclusion, the <u>Presidency</u> indicated it will send a letter to the Chairs of the LIBE and the EMPL Committees informing them that the Council is in a position to approve this text if the European Parliament adopts it, subject to its revision by the lawyer-linguists.
