"Hungary declares that the Commission's Communication on a Union of Equality: Gender Equality Strategy 2020-2025 mentioned on page 4 of the Communication from the Commission to the European Parliament, the Council, the European Economic and Social Committee and the Committee of the Regions on achieving the European Education Area by 2025 (30 September 2020), which is referred to on page 6, page 20, and on page 29 of the Council Resolution, should be interpreted with due regard to national competences and the specific circumstances in each Member State. "In all their diversity" on page 16 of the Commission's Communication on achieving the European Education Area by 2025, can only be interpreted as set out in Article 22 CFREU.

In addition, Hungary declares that the Commission's Communications on a Union of Equality: LGBTIQ Equality Strategy 2020-2025 and on a Union of Equality: Gender Equality Strategy 2020-2025 mentioned on page 6 and 8 in the Communication from the Commission to the European Parliament, the Council, the European Economic and Social Committee and the Committee of the Regions Action plan on Integration and Inclusion 2021-2027 (referred to in para 43 of Annex I of the Council Resolution) should also be interpreted with due regard to national competences and the specific circumstances in each Member State."

Statement by Cyprus, Czech Republic, Hungary, Ireland, Luxembourg, Malta and Sweden

"Notwithstanding the constructive discussions at Working Party facilitated by the Presidency, and the general support expressed by all for tax transparency, Cyprus, Czech Republic, Hungary, Ireland, Luxembourg, Malta and Sweden have ongoing concerns regarding this Proposed Directive, and fully share the analysis of the Council legal service of 11 November 2016, reference 2016/0107 (COD), FISC 194, stating that the proposal for a Directive amending Directive 2013/34/EU as regards disclosure of income tax information must be based on Article 115 TFEU since both the aim and the content of the proposal relate to “fiscal provisions”, rejecting thereby the appropriateness of the legal basis of the initial proposal, i.e. Article 50(1) TFEU, and are of the view that accordingly, the proposal must be discussed at ECOFIN Council, taking due account of the relevant procedural rules.

Cyprus, Czech Republic, Hungary, Ireland, Luxembourg, Malta and Sweden thus consider that the COMPET Council is not the appropriate Council configuration for having a political debate on the Council's *general approach* on this proposal.³

Statement by Germany

"Die Bundesrepublik Deutschland stimmt dem ITER-Beschlussentwurf zu und gibt die folgende Erklärung zu Protokoll:

Deutschland unterstützt auf Grundlage des ITER Abkommens von 2006, wie vom Rat der Europäischen Union in seinen Schlussfolgerungen zum reformierten ITER-Projekt vom 12. April 2018 (doc. 7881/18) bekräftigt, die erfolgreiche Fertigstellung des ITER-Projekts.

Für Deutschland ist ITER (wie die Fusionsforschung insgesamt) ein Projekt der langfristig ausgerichteten, anwendungsorientierten Grundlagenforschung. Die Erforschung der Fusionsenergiegewinnung hat das Ziel, eine nicht auf fossile Brennstoffe angewiesene, verlässliche, nachhaltige und wirtschaftliche Energiequelle zu erschließen. Gelingt der Schritt in die Anwendung, wird diese voraussichtlich erst nach 2050 verfügbar sein.

Für Deutschland ist es neben der Energiewende zugleich Ausdruck einer globalen Verantwortung von Deutschland und der Europäischen Union, das Verständnis von Fusionsprozessen weiter voranzutreiben und dieses wissenschaftlich herausragende Know-how der Welt zur Verfügung zu stellen. Die weltweite steigende Energienachfrage und die Zielsetzung der internationalen Klimapolitik erfordern es aus Sicht von Deutschland, eine breite Palette von Optionen für die künftige Energieversorgung zu erforschen, die potentiell eine nachhaltige kohlenstofffreie Energieversorgung ermöglichen könnte. Fusionsenergie könnte eine dieser Optionen sein, die durch ITER zielgerichtet verfolgt wird.

Gleichwohl ist es für Deutschland zweckmäßig, dem ITER unter dem Mehrjährigen Finanzrahmen (MFR) 2021-2027 keine Klimarelevanz beizumessen, weil erst mit dem First Plasma voraussichtlich Ende 2025 der Betrieb des ITER beginnt. Entsprechend sollte die Europäische Kommission nach der nun konsentierten Änderung des Erwägungsgrunds 10 die EU-Ausgaben für ITER nicht als Beitrag zum Ziel anrechnen, mindestens 30 % der Gesamtausgaben aus dem Unionshaushalt und dem Instrument „Next Generation EU“ für Klimazwecke zu verwenden. Nach erfolgreichem First Plasma ist die Frage der Klimarelevanz des ITER neu zu bewerten, wenn es um den nächsten MFR 2028 ff. geht."

"The Federal Republic of Germany approves the ITER proposal and makes the following statement to be entered in the minutes:

On the basis of the 2006 ITER Agreement, as reaffirmed by the Council of the European Union in its Conclusions on the reformed ITER project of 12 April 2018 (doc. 7881/18), Germany supports the successful completion of the ITER project.

Germany views ITER (and fusion research in general) as a project for long-term, application-oriented basic research. The purpose of research on fusion power generation is to develop an energy source that is fossil-free, reliable, sustainable and economically viable. Should research successfully translate into application, this energy source will only be available from 2050.

Germany's motivation – in addition to greening the energy system – is to both express its own global responsibility and that of the European Union to further advance our understanding of fusion processes and to make this outstanding scientific know-how available to the world. In the light of the increasing global demand for energy and international climate policy targets, Germany considers it imperative to explore a broad range of options that can potentially enable a sustainable carbon-free energy supply in the future. Fusion energy might be one of these options that ITER pursues in a targeted manner.

Germany nevertheless considers it appropriate not to assign any climate relevance to ITER within the Multi-Annual Financial Framework (MFF) 2021-2027. This is because ITER is likely only to begin operations upon achieving First Plasma at the end of 2025. Accordingly, the European Commission – as per the now agreed amendment to Recital 10 – should not include EU expenditure on ITER as a contribution to the target of devoting at least 30% of the total EU budget expenditure and Next Generation EU to climate-related action. After successful achievement of First Plasma, the issue of ITER's climate relevance has to be reassessed as the MFF for the period starting in 2028 approaches."

Statement by Luxembourg

"Le Luxembourg reste, de manière générale, très critique en ce qui concerne le financement des activités de recherche nucléaire par l'Union européenne. Le Luxembourg souhaiterait qu'une orientation des fonds européens, davantage axée sur les énergies renouvelables, soit exploitée à l'avenir. La Proposition de 'Décision du Conseil modifiant la décision 2007/198/Euratom instituant une entreprise commune pour ITER et le développement de l'énergie de fusion et lui conférant des avantages', ne préconisant pas une telle orientation, la position du Luxembourg reste inchangée. Malgré les réticences quant au contenu de cette décision, le Luxembourg est cependant en mesure de lever sa réserve générale et s'abstient par conséquent du vote."

"Luxembourg remains, in general, very critical towards the funding of nuclear research activities by the European Union. Luxembourg would like a reorientation of European funds, more focused on renewable energies, to be exploited in the future. Since the 'Council Decision amending Decision 2007/198/Euratom establishing the European Joint Undertaking for ITER and the Development of Fusion Energy and conferring advantages upon it' does not advocate such a reorientation, Luxembourg's position remains unchanged. Despite the reluctance as to the content of this Decision, Luxembourg is however able to lift its general reservation and abstains therefore from the vote."

Joint statement by Greece and Cyprus

"In a spirit of compromise, Greece and Cyprus accept the proposed solution of once again extending the deadline, until October 2021, for Turkey to fulfill criterion 1.1 in the EU list of non-cooperative jurisdictions for tax purposes. However, the said MS reiterate that passed October 2021, no further extension will be offered and failure to comply with any agreed deadlines as stated in the Council Conclusions, will result in moving Turkey to Annex I under criterion 1.1.

The repeated derogations which have been granted so far to one specific third state whilst making no exceptions for others, are undermining the reliability and objectivity of the EU list of non-cooperative jurisdictions for tax purposes. In this context, the said MS call for a reflection to be carried out in the Group on the value of such a list and the purpose it serves, including on options on how to remedy the situation."

In the Commission's view, the predominant purpose of the Decision falls under the common commercial policy, whereas it relates merely incidentally to the procurement of transport services. Therefore, the Decision should indicate solely Article 207(4) TFEU as its single substantive legal basis.

Statement by Hungary

HU statement on Council Conclusions on EU Priorities in UN Human Rights Fora 2021 (paragraph {7})

"The adoption of the Programme of Action of the International Conference on Population and Development (ICPD) and the Beijing Platform for Action of the Fourth World Conference on Women marked a remarkable consensus. They placed the enjoyment of human rights at the heart of development and important gains in the fields of health, equality between men and women and education have been achieved since their adoption. These fields are at the core of the 2030 Agenda for Sustainable Development incorporating as founding principles the universal respect for human rights and human dignity, the rule of law, justice, equality and non-discrimination.

Hungary remains dedicated to its human rights commitments, including the protection and promotion of women's rights and equality between men and women. Hungary is deeply committed to the implementation of the ICPD Programme of Action and Beijing Platform for Action as well as the 2030 Agenda, serving also as basic references in the fields of sexual and reproductive health and reproductive rights. Hungary notes, that the term of "sexual and reproductive health and rights (SRHR)" and related issues, like "sexual rights", "comprehensive sexuality education", "modern methods of contraception", "emergency contraception", are lacking consensual definition at international level, including within the European Union. These issues are interpreted and promoted by Hungary in the context of the 2030 Agenda, the ICPD Programme of Action and the Beijing Declaration and Platform for Action and in line with its national legislation."
