Statement by the Commission

"The Commission takes note of the Council endorsement on the Guidelines on the Establishment of Union and Common Positions within the World Customs Organisation (document 6489/20). These Guidelines lay down practical arrangements relevant for the establishment of EU positions on acts which do not have legal effects in the meaning of Article 218(9) TFEU and of 'common positions'.

The Commission recalls that customs matters fall within the EU exclusive competence and therefore that the vast majority of the work under WCO falls under Union exclusive competence where EU positions would need to be established. The Commission confirms its interpretation of references to 'common positions' as referring normally to positions in the limited areas of Member States' exclusive competence.

The Commission will continue to act in application of the Treaties and reserves the right to use all legal means at its disposal to ensure the respect of the provisions of the Treaties."
