#### 4. Proposal for a Regulation of the European Parliament and of the Council laying down specific measures for agriculture in the outermost regions of the Union

The SCA approved the mandate for the informal trilogue and took note of the comments by delegations and the Commission, in particular as regards the request for further clarifications on the amendments with budgetary implications.

The SCA approved the mandate for the informal trilogue and took note of the comments by delegations and the Commission, in particular as regards the request for further clarifications on the amendments with budgetary implications.

The Presidency also noted the need for consistency between the provisions in this Regulation and the Regulation on the Outermost regions.

Preparation for the second informal trilogue 6544/12 AGRI 91 AGRIORG 33 CODEC 385

The SCA took note of the good level of support of delegations for the compromise text prepared by the Presidency set out in document 6544/12, of the reserves entered by some delegations and of the scrutiny reserves entered by several others.

The SCA further took note of the Presidency's invitation to delegations to finalise their examination with a view to lifting their reservations at the earliest opportunity; and of the Presidency's intention to come back to this file at a next meeting as appropriate.

## 7. Proposal for a Regulation of the European Parliament and of the Council amending Council Regulation (EC) No 834/2007 on organic production and labelling of organic products

Preparation for the informal trilogue 6484/12 AGRI 101 AGRILEG 16 CODEC 453

The SCA endorsed the Presidency compromise text containing few modifications, as indicated in document 6484/12, namely the deletion of the term "national" in recital 3 and a redrafting of articles 22, 24 and 25. The Presidency informed delegations that the next Trilogue could take place later in March.
