The Special Committee on Agriculture had an exchange of views on the Commission proposal for a Regulation of the European Parliament and of the Council amending Council Regulation (EC) No 485/2008 on scrutiny by Member States of transactions forming part of the system of financing by the European Agricultural Guarantee Fund.

The Special Committee on Agriculture also took note of the comments made by a number of delegations that there should be a recital on the consultation of national experts and that the scope of the Regulation is an essential element and, therefore, it cannot be subject to delegation of powers. Furthermore, they considered that a delegation of powers should not be for an indeterminate period of time. Instead, these delegations proposed 5 years.

Furthermore, the CY and UK delegations entered Parliamentary scrutiny reservations while the DK delegation entered a general scrutiny reservation.
