"The Commission undertakes to keep under continual review all developments in relation to the scientific and other relevant aspects of use and detection of substances in beef and veal production, and to report to the Council on any necessary modifications to the Directives adopted."

"Several Member States have made numerous requests for amendments to the Annex to the Directive, and the Council feels that, because of the highly technical nature of the questions raised, those requests should be examined by the Commission in the Standing Committee for Feedingstuffs so that, in accordance with the procedure laid down, the necessary adjustments may be made and apply at the same time as the basic Directive."

STATEMENT 30/96

"The Commission undertakes to submit a proposal as swiftly as possible to amend this Directive by introducing transitional arrangements concerning its application in Finland, Sweden and Austria."
