STATEMENT 7/01

STATEMENT BY THE GERMAN DELEGATION CONCERNING AMENDMENT 13

"The Federal German Government assumes that the guidance to be given by the Commission on the basis of the compromise now reached on Article 3(3)(b) (European Parliament amendments 13, 38 and 46) will indeed relieve the burden on the small enterprises and organisations referred to in the Regulation. In particular, Germany assumes that the exceptions will not be confined solely or principally to micro-enterprises and that the conditions for exceptions to annual validation will be such that small organisations and enterprises with a low environmental impact are as a rule covered by the exceptions."

DECLARATION 8/01

STATEMENT BY THE AUSTRIAN DELEGATION

"Austria states that it will act on guidance adopted in accordance with the procedure laid down in Article 14 only where it relates to an obligation and is confined solely to fulfilment of that obligation. In particular, Austria will act on such guidance only if it does not conflict with or restrict the Articles of the Regulation or Annex V thereto.

Moreover, Austria will act on such guidance only if the advice and prescriptions which it contains are consistent with all the provisions of the Regulation, in particular the Articles and Annex V."

DECLARATION 9/01

COMMISSION STATEMENT

Re Article 32

"The Commission notes the agreement of the co-legislators relating to recital 13 and Article 32, on the basis of Amendments 1 and 28, in particular concerning the date by which a proposal should be presented for the implementation of the Cartagena Protocol and the content of any such proposal.

In the respect of its right of initiative, the Commission states that it cannot accept to be bound by the provisions of this article neither as to timing nor as to the content of a future proposal.

The Commission does however confirm its commitment, after a comprehensive examination of all the potential implications, to presenting a proposal with a view to full implementation of the Cartagena Protocol."

STATEMENT 10/01

STATEMENT BY THE COMMISSION

Re Amendment 35

"With a view to facilitating the obligation of Member States to take the necessary measures to ensure traceability and labelling at all the stages of the placing on the market of GMOs authorised in accordance with Part C of a revised Directive 90/220/EEC, the Commission reaffirms its intention to present in the course of 2001 appropriate proposals for this purpose.

In addition, the Commission at the same time having regard to the results of the meeting with the experts of the Member States on 29 November 2000, affirms its intention to present proposals aiming to provide appropriate traceability for products derived from GMOs, as well as to supplement the labelling regime in accordance with the White Paper on Food Safety."

STATEMENT 11/01

STATEMENT BY THE ITALIAN DELEGATION

"In noting the agreement reached in the framework of the conciliation procedure for the revision of Directive 90/220, the Italian delegation would stress that the substantial grounds which led Italy to abstain from the political agreement reached by a qualified majority of the Environment Council of 24 June 1999 still remain. The main reason was failure to submit complete draft provisions to guarantee labelling and the traceability of GMOs and products derived therefrom."

STATEMENT 12/01

STATEMENT BY THE DANISH, GREEK, FRENCH, ITALIAN, AUSTRIAN AND LUXEMBOURG DELEGATIONS

"Having regard to the principle of prevention and precaution, the delegations of the following Member States: Denmark, Greece, France, Italy, Austria and Luxembourg

- reaffirm the need to introduce a more rigorous, transparent and comprehensive framework
 concerning risk assessment and risk management (taking account of the specific
 characteristics of European eco-systems), monitoring, traceability and labelling of GMOs and
 to generally restore the confidence of the public and of operators;
- note that the amended provisions of Directive 90/220/EEC significantly but only partially
 improve the existing arrangements and emphasise the essential improvements made
 concerning transparency, public access to information, regional biological monitoring of the
 countryside, gradual elimination of antibiotic resistance markers, legal certainty and
 ratification of the Carthagena Protocol;
- ask the Commission to follow up its commitment concerning the early submission of comprehensive legislative proposals on GMO traceability and labelling, environmental liability and ratification of the Carthagena Protocol.

Accordingly, the above delegations

- reaffirm their intention, when exercising the powers conferred upon them, of ensuring that the
 new authorisations for cultivating and marketing GMOs are suspended pending the adoption
 of effective provisions concerning a complete traceability of GMOs that guarantees reliable
 labelling of all GMO products;
- call on the Commission to make rapid progress towards the establishment of a system of environmental liability to supplement the regulatory framework necessary for development in the field of biotechnologies, as in other environmental fields."

STATEMENT 13/01

STATEMENT BY THE UNITED KINGDOM DELEGATION

"The United Kingdom notes the agreement reached in relation to recital 16, and records its understanding that the first sentence of the recital refers only to environmental liability in relation to activities within the scope of this Directive. The United Kingdom recalls to this effect the statement made by the United Kingdom and other delegations in the minutes of the Council Meeting of 24-25 June 1999."

STATEMENT 14/01

STATEMENT BY AUSTRIA, GERMANY, BELGIUM, LUXEMBOURG, FRANCE IRELAND AND SPAIN

"In view of the fact that in connection with the implementation of the new Directive consistent measures for ensuring traceability, labelling and monitoring of GMOs and GMO-Products are of the highest importance, Austria, Germany, Belgium, Luxembourg, France, Ireland and Spain call on the Commission,

- (1) to continue effectively and to conclude in due time the work already initiated concerning the necessary instruments for effective traceability systems, for the assignment of a unique identifier to GMOs and for clear, consistent and coherent labelling of GMOs and products derived from GMOs (including feeding stuffs)
- (2) to come forward as soon as possible with a proposal for guidance notes to supplement Annex VII of the Directive concerning plans for monitoring the effects of GMOs."

STATEMENT 15/01

STATEMENT BY DENMARK, AUSTRIA, FRANCE, BELGIUM, GERMANY AND SPAIN

"As stated during the conciliation procedure, Parts A and D of the Directive of the European Parliament and of the Council on the deliberate release into the environment of genetically modified organisms and repealing Council Directive 90/220/EEC also apply to GMOs covered by sectoral legislation. Part B also applies to GMOs covered by such legislation, unless they are exempt by virtue of Article 5. These delegations agree with the opinion expressed and note that the opinion is undisputed in the Council and by the Commission."

STATEMENT 16/01

STATEMENT BY IRELAND

"The effectiveness of the public participation provisions in the new Directive is a critically important issue. As well as contributing to greater transparency, these provisions are significant in building public confidence in the whole regulatory process. The regulation of genetically modified organisms is unavoidably complex. Therefore, in order to facilitate effective public participation in the processing of individual notifications, appropriate EU guidelines to inform and reassure the general public on relevant regulatory and procedural matters should be developed by the Commission and made available as soon as possible."

STATEMENT 17/01

STATEMENT BY THE COMMISSION

"The Commission underlines that studies will be made, and reports – and if need be legislative proposals – presented, subject to the availability of the necessary resources."

STATEMENT 18/01

STATEMENT BY THE COMMISSION

"The question of recognition of diplomas, certificates and other evidence of former qualifications obtained outside the European Union arises only in the case of a fairly small number of Community nationals. The Treaty does not in fact lay down any legal basis for the purpose of facilitating the recognition of diplomas, certificates and other evidence of former qualifications obtained by nationals of third countries.

The question of recognition of qualifications obtained in third countries has already been discussed within the committees of representatives of the national authorities responsible for implementing the mutual recognition of diplomas.

The Court of Justice of the European Communities has just determined new principles which must be applied by the Member States in this context (see judgment of 14.9.2000 in case C-238/98 Hocsman).

The Commission will identify the situations which have not yet been resolved and will propose, if necessary, appropriate solutions in its future proposals."

STATEMENT 19/01

JOINT STATEMENT BY THE PARLIAMENT/COUNCIL/COMMISSION

"The European Parliament, the Council and the Commission share the opinion that it is important to have consolidated versions, easily accessible to everyone, of the legal texts applicable in the field of mutual recognition of professional qualifications.

For this purpose, much codification work has been done through the adoption of Council Directive 93/16/EEC (free movement of doctors) and Directive 1999/42/CE of the European Parliament and of the Council (third general system). Furthermore, the Commission has made available to users the User's Guide to the general system for the recognition of professional qualifications.

The Commission intends to pursue this effort in two stages: initially it plans to integrate the sectoral Directives into a consolidated framework. The Commission will then examine the possibility of consolidating the Directives relating to the general system, in order to continue simplifying the legislation and further facilitate the free provision of services with regard to the conclusions of the Lisbon Summit.

The Commission will also examine developments in the specific training of general practitioners in Member States and the extent of the problems which would arise from differences in duration and training. If a need is felt, the Commission will present subsequent proposals for coordination in this respect.

The Commission will present the results of its work at the latest in 2003.

The European Parliament and the Council note the intentions of the Commission, which will keep them informed on progress made."

STATEMENT 20/01

Re Article 9

"The Netherlands delegation states that the Ethics Committees are independent bodies under the Netherlands' administrative law. In accordance with Article 9 of the Directive, the sponsor may not start a clinical trial if an Ethics Committee has issued an unfavourable opinion. The competent body is not authorised to invalidate this decision.

In the light of the Netherlands' administrative appeals system, Article 9 involves the possibility of an appeal against the decision of the Ethics Committee (see 8230/00 (Annex II))."

STATEMENT 21/01

Re Article 9(5)

"The German delegation is assuming that in Article 9(5), in the phrase "or the manufacturing of which requires such components", the relative pronoun "which" refers to "active ingredient or active ingredients"."

STATEMENT 22/01

Legal basis, Article 5(i) and Article 9(6)

"The Netherlands delegation states that it will vote against the Directive in connection with the incorrect legal basis adopted for it. The provisions of the Directive relating to the substantive, legal and ethical criteria governing whether or not clinical trials should be permitted cannot be based on Treaty Article 95. These criteria in no way refer to the abolition of trade barriers with a view to completion of the internal market.

The Netherlands delegation will also vote against the Directive since Article 5(i) makes it impossible for clinical trials to be conducted with adult patients incompetent to act for themselves, inasmuch as there must be no attendant risk if the condition that the expected benefit to the person involved is great enough to make the risks acceptable cannot be met. While the Netherlands considers that trials which are of no benefit to the person concerned must be viewed with the greatest possible reserve, there are conceivable circumstances in which comparative investigation, such as clinical trials with medicinal products for treating Alzheimer's disease, is essential. In the Netherlands' view, the Council of Europe Convention on Human Rights and Biomedicine makes the necessary subtle distinction regarding this point, unlike the Directive.

The Netherlands delegation will also vote against the Directive since its Article 9(6) may hamper any clinically and ethically justified future developments in the field of germ-line gene therapy.

At the same time, <u>the Netherlands delegation</u> is objecting to the lack of procedural diligence with which the Council handled this Directive, after adoption of the common position."
